

**AN ORDINANCE CONCERNING MEETINGS**

WHEREAS, I.C. 36-2-2-6 requires that regular meetings of the Board of Commissioners of Vanderburgh County shall be established by resolution at the first meeting in January of each year:

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Vanderburgh County, as follows:

**SECTION 1. AMENDMENT OF SECTION 2.04.020**

Section 2.04.020 of the Code of Ordinances of Vanderburgh County is hereby amended by deleting said Section as it is presently constituted and substituting the following in lieu thereof:

**Section 2.04.020 Meetings.**

A. In accordance with I.C. 32-2-2-6, the County Executive shall hold a regular meeting at least once a month and at other times as needed to conduct all necessary business and dates of regular meetings shall be established by resolution at the first meeting in January of each year.

B. The regular meetings of the Board of Commissioners of Vanderburgh County shall be held on the first, second, third and fourth Tuesday of each month at 3:30 p.m. in Room 301 in the Civic Center Complex in Evansville, Indiana. However, there shall be no meeting of the Board of Commissioners of Vanderburgh County on March 28, 2006, May 2, 2006 and November 7, 2006. Further, if a legal holiday falls on a Tuesday, then the meeting of the Board of Commissioners of Vanderburgh County for that Tuesday will be held on the following Tuesday of the next week, unless otherwise stated by the Board of Commissioners of Vanderburgh County in an open meeting.

C. Rezoning petitions will be heard by the Board of Commissioners of Vanderburgh County on the third Tuesday of each month beginning at 3:30 p.m. in Room 301 of the Civic Center Complex in Evansville, Indiana. However, if a legal holiday falls on the third Tuesday of the month, then rezoning petitions will be heard by the Board of Commissioners of Vanderburgh County on the fourth Tuesday of the month at 3:30 p.m., unless otherwise stated by the Board of Commissioners of Vanderburgh County in an open meeting.



**SECTION 2. EFFECTIVE DATE**


This Ordinance shall be in full force and effect from and after its passage by the Board of Commissioners of Vanderburgh County.






