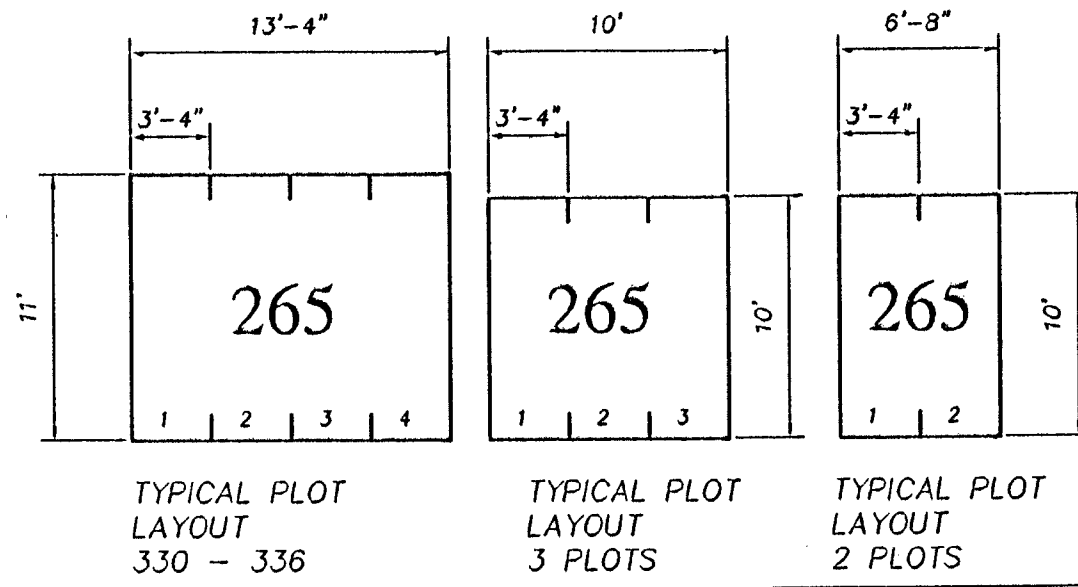

Land Description

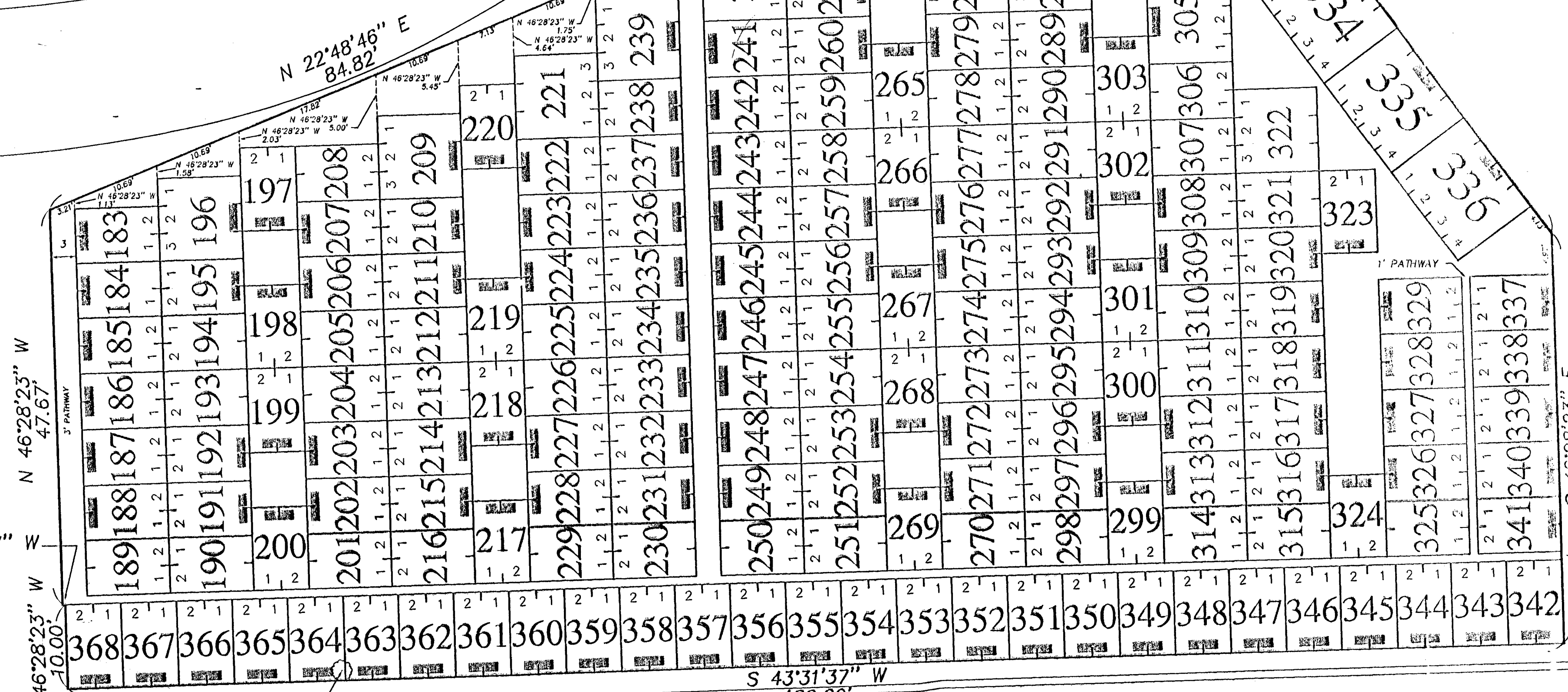

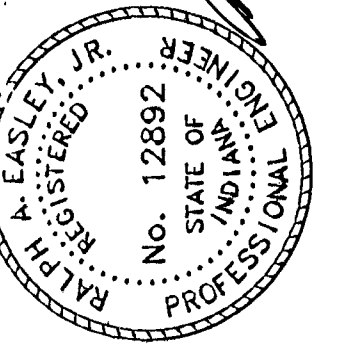
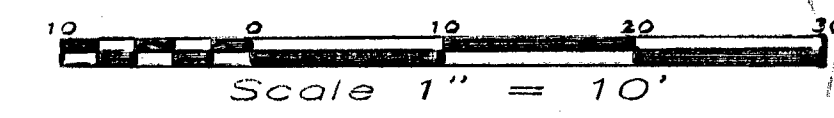
