








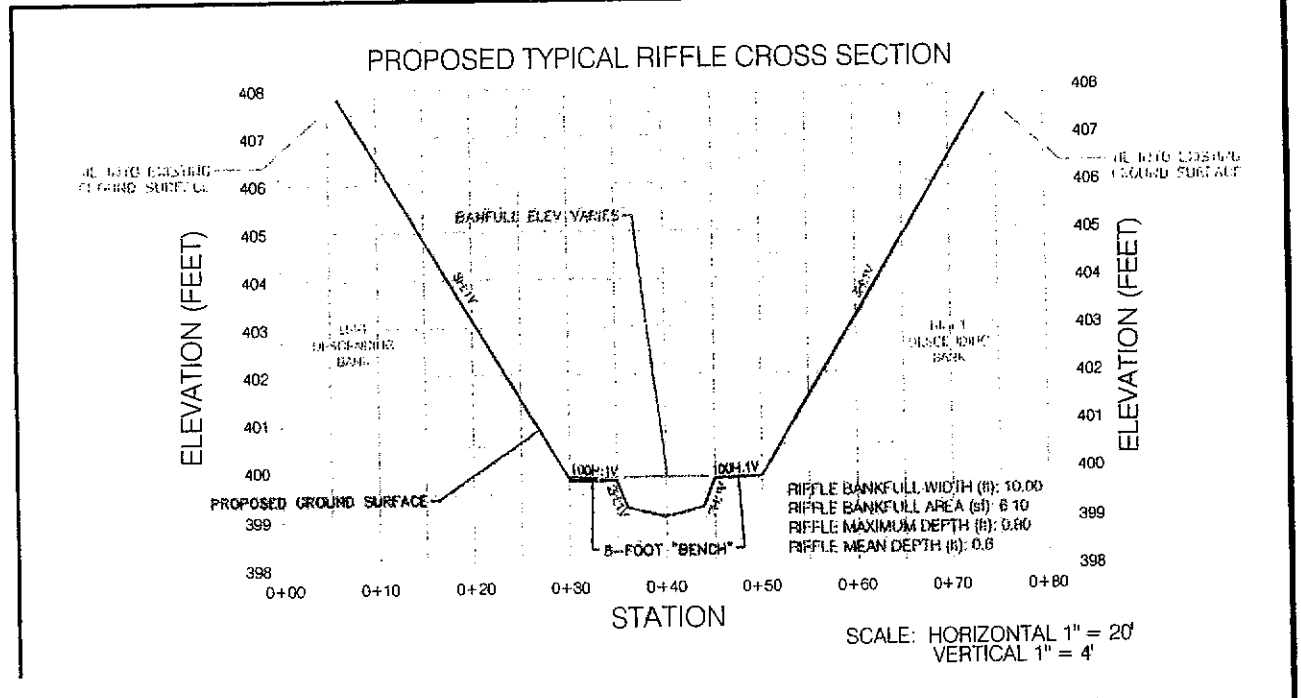
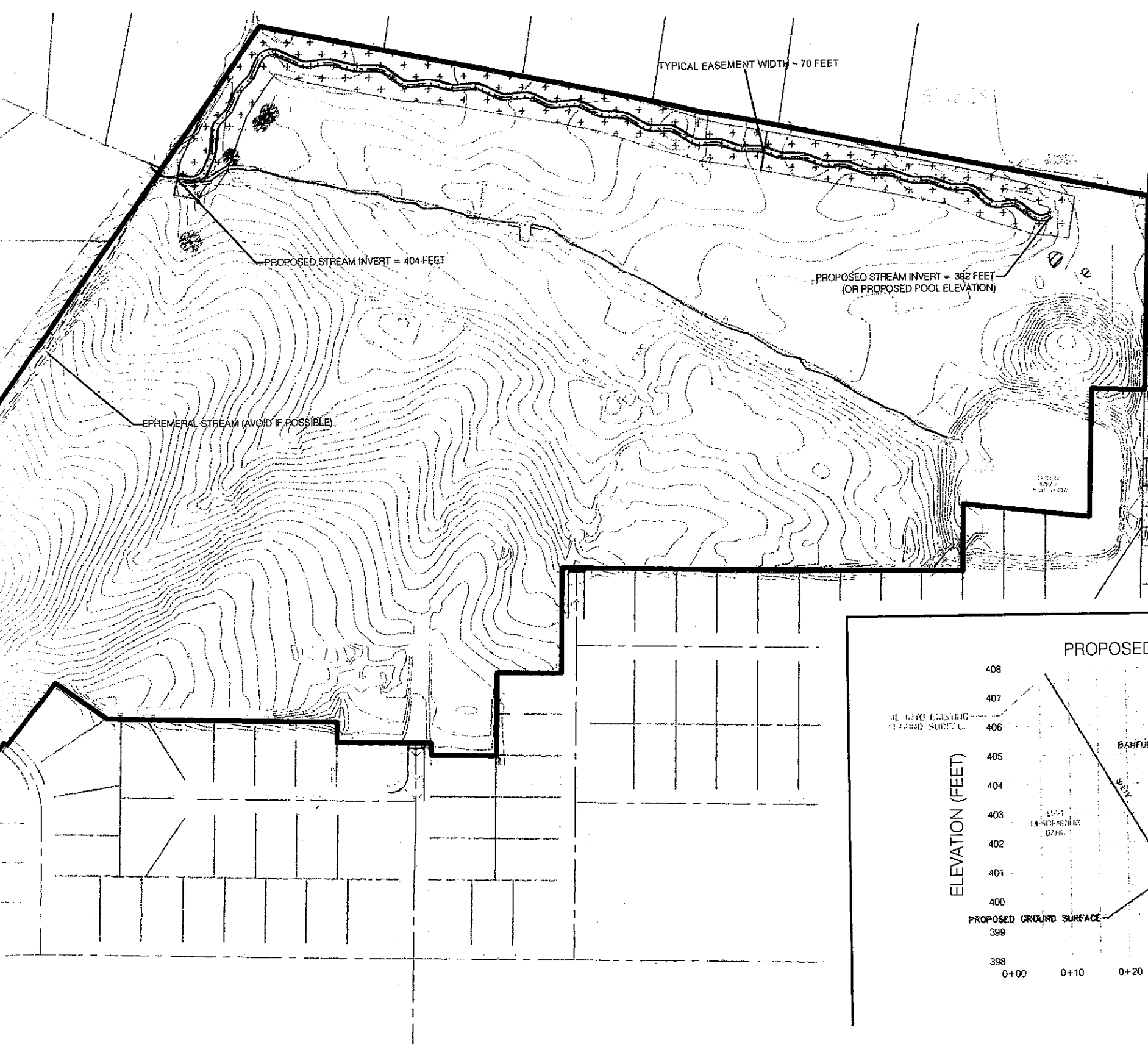

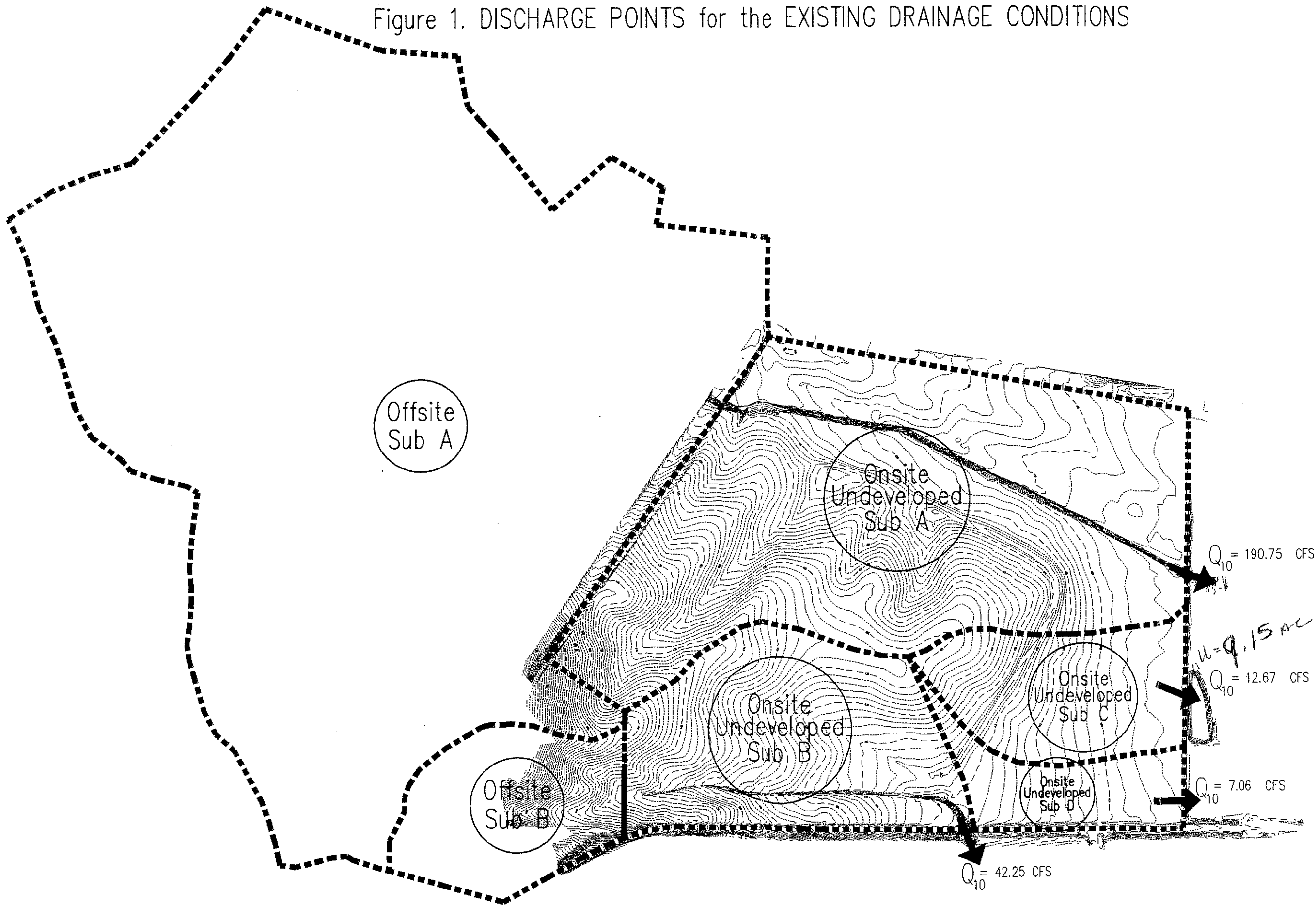

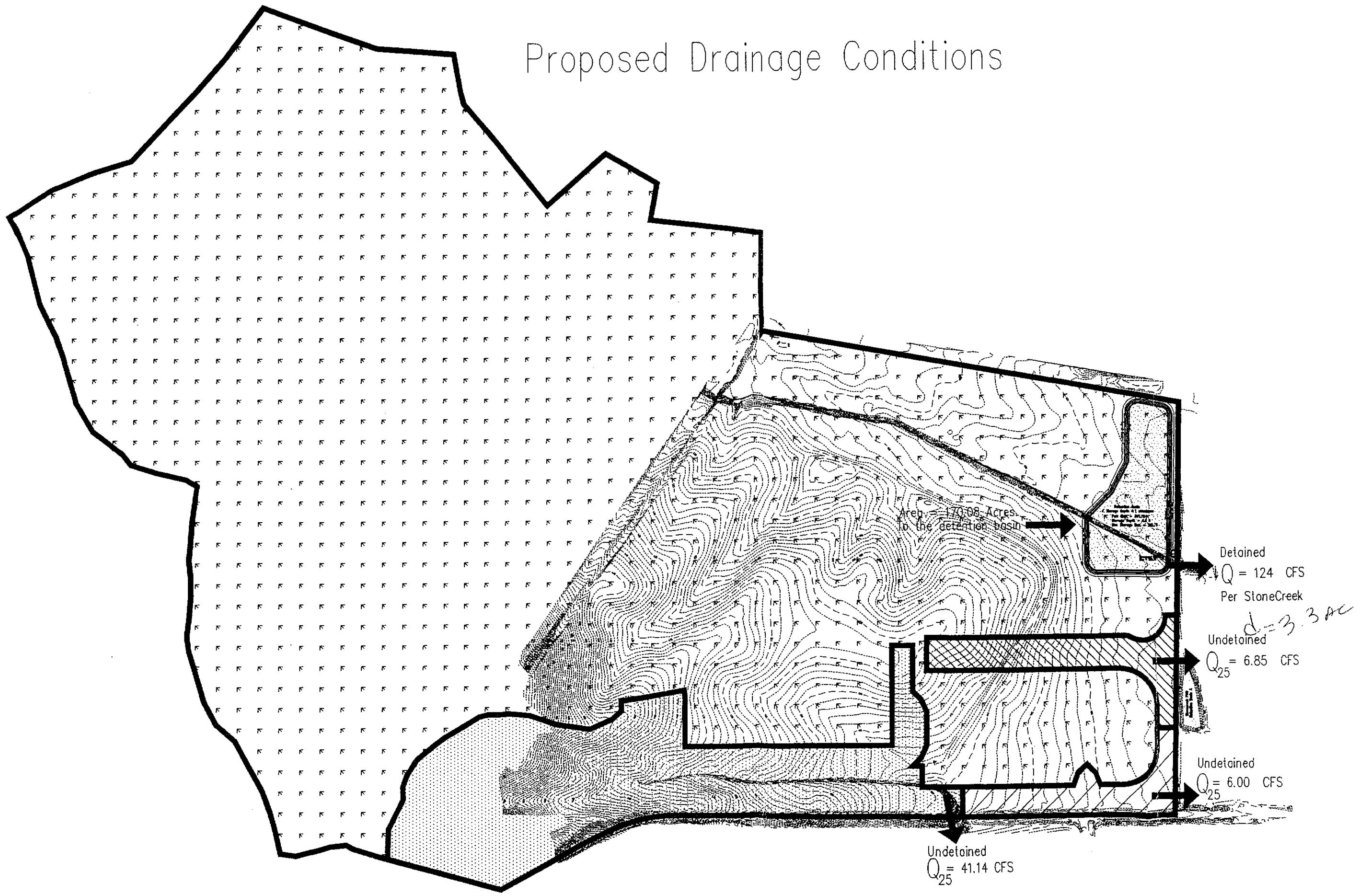

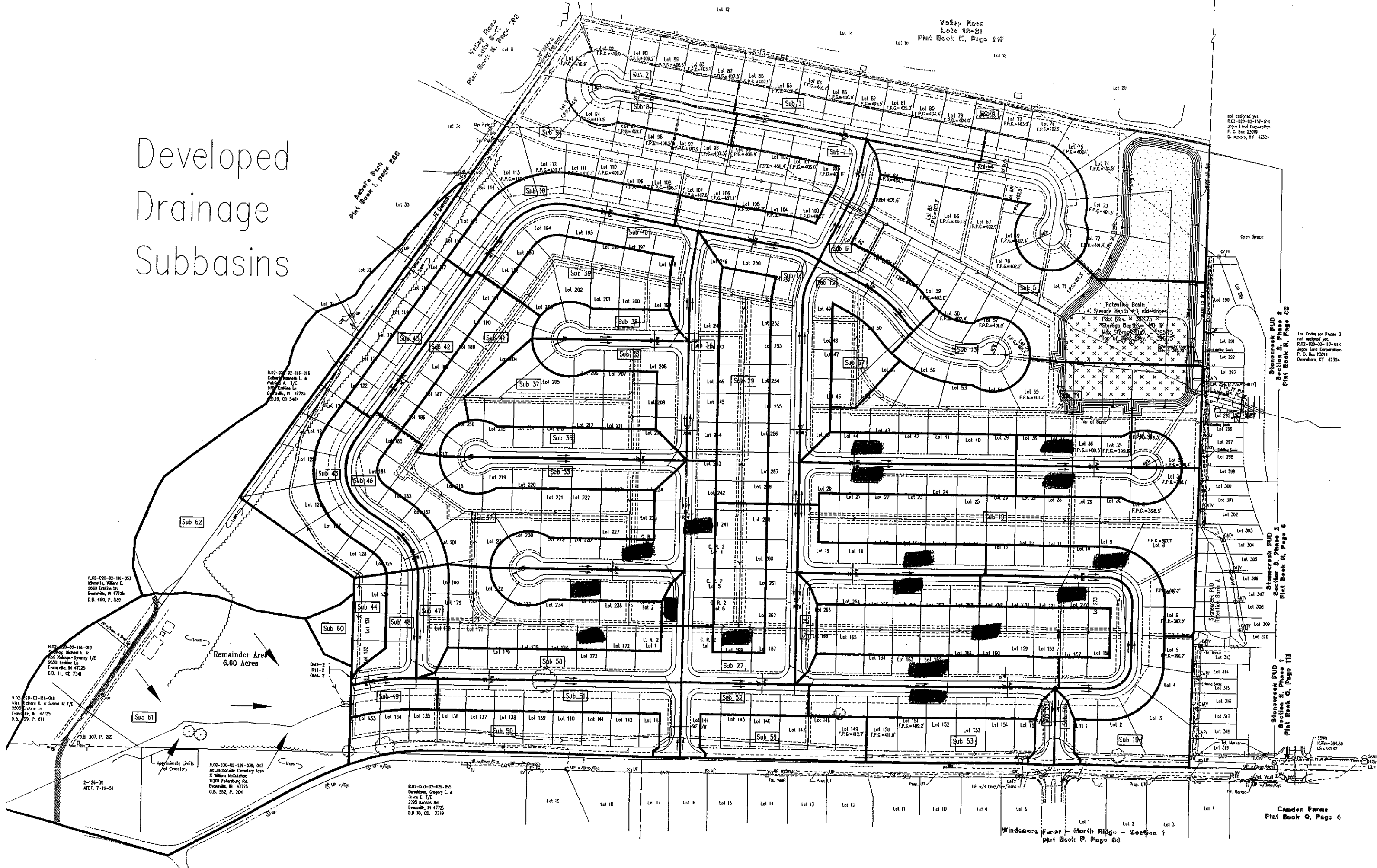
Offsite and Undeveloped Drainage Subbasins
