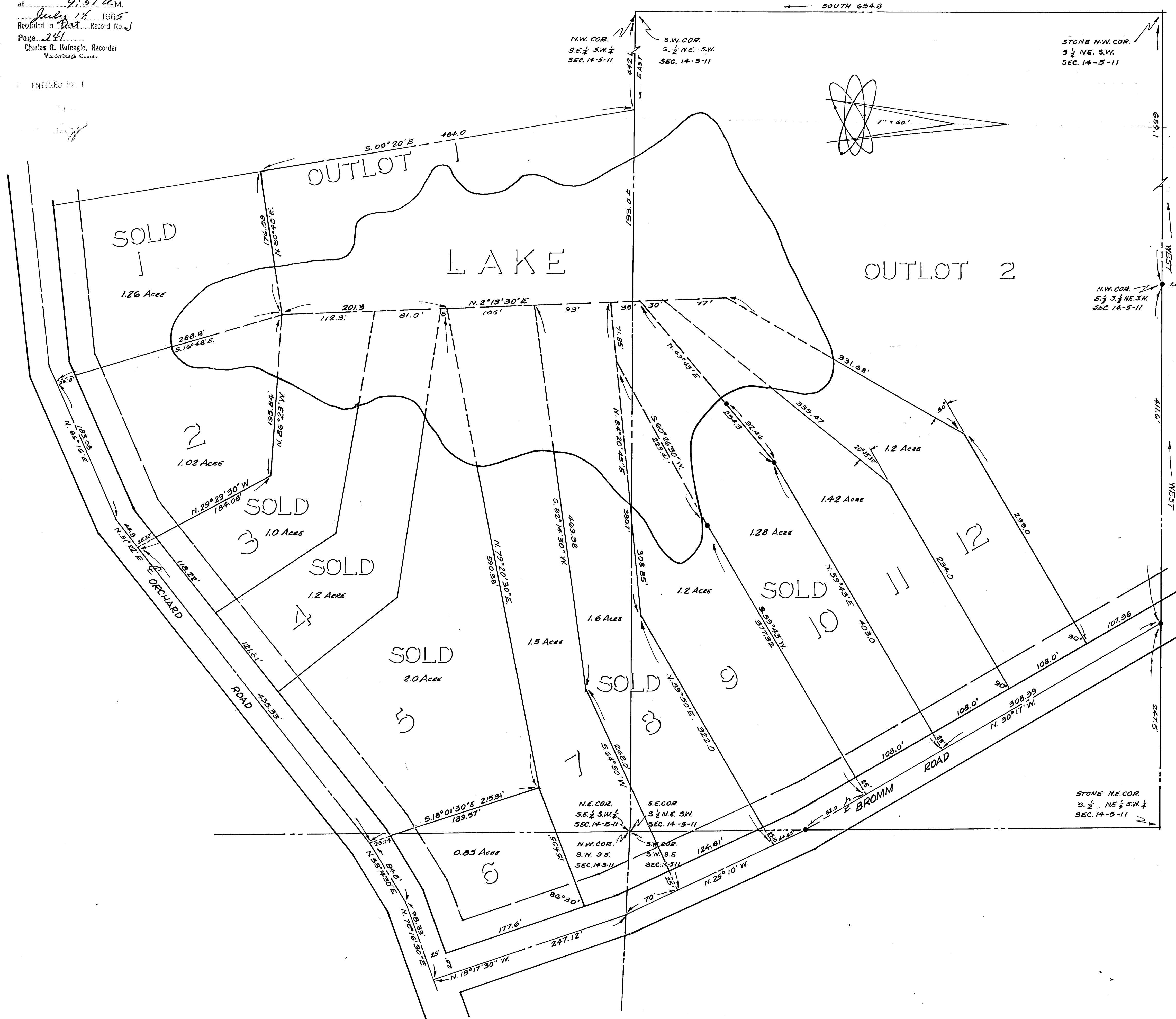

COUNTY SHEET

We, the undersigned, owners of the real estate shown and described here on do hereby as shown plot and subdivision said real estate and designate same as CLETUS BITTNER SUBDIVISION. All streets within the plot are dedicated to the public. Building setback lines are established as shown on the plot between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plot and marked "Easement" are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easements hereon referred. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities in said strips of ground.

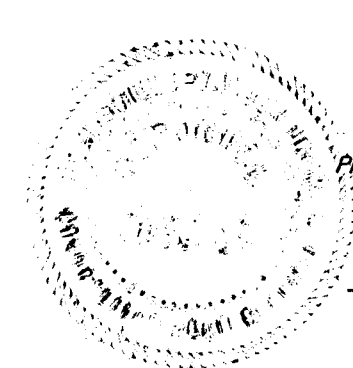
