

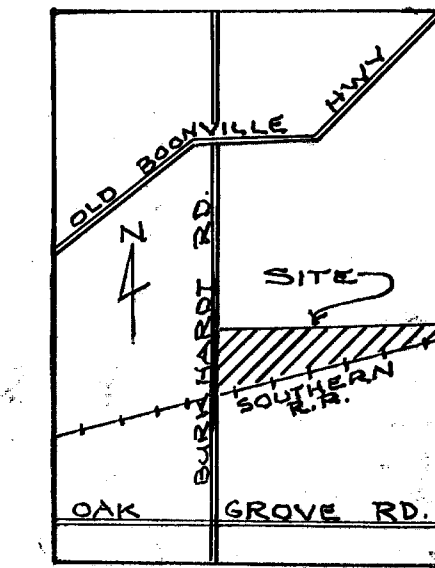
# BURKHARDT INDUSTRIAL PARK

## DESCRIPTION.

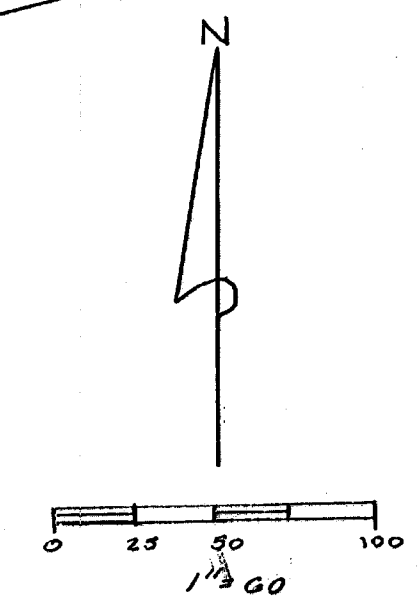
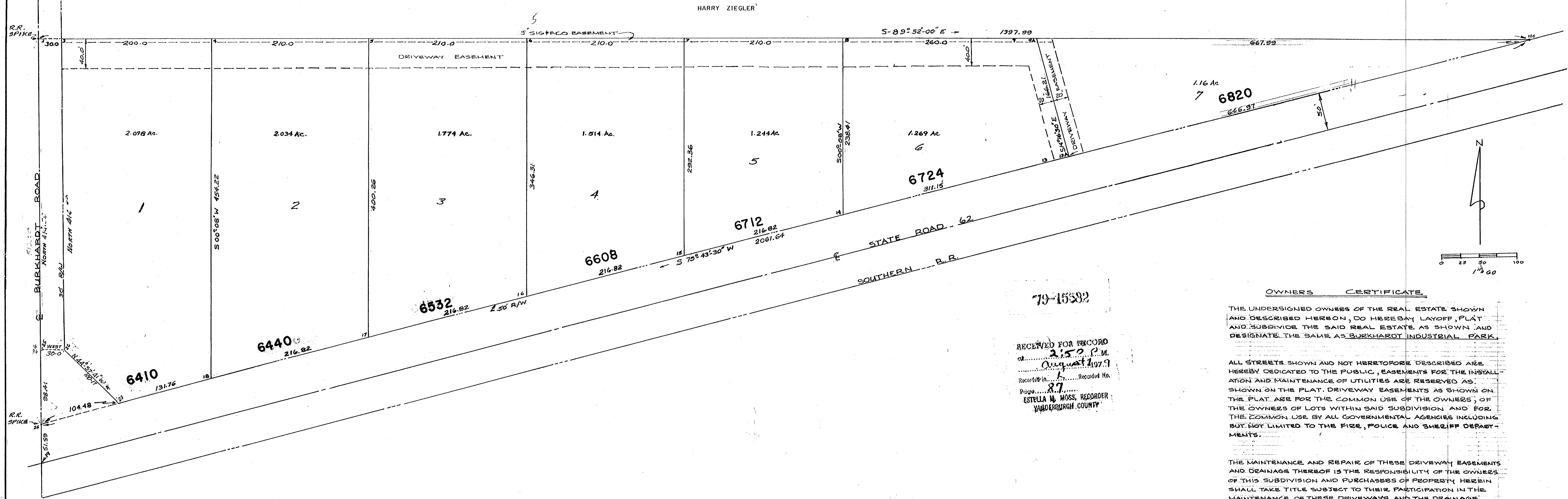
A SUBDIVISION OF PART OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 6 SOUTH, RANGE 9 WEST IN VANDERBURGH COUNTY, INDIANA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
 BEGINNING AT A POINT ON THE WEST LINE OF SAID QUARTER SECTION WHICH LAYS 714.0 FEET SOUTH OF THE NORTHWEST QUARTER OF SECTION; FROM SAID PLACE OF BEGINNING THENCE SOUTH 89°52'00" EAST FOR 1937.99 FEET TO A POINT ON THE NORTH RIGHT OF WAY LINE OF S.R. NO. 62 (50.0 FEET MEASURED AT RIGHT ANGLES FROM THE CENTERLINE OF SAID HIGHWAY); THENCE SOUTH 75°43'30" WEST ALONG THE SAID RIGHT OF WAY FOR 1936.76 FEET; THENCE NORTH 44°57'41" WEST ALONG THE RIGHT OF WAY OF S.R. NO. 62 FOR 100.17 FEET; THENCE WEST FOR 30.0 FEET TO A POINT ON THE WEST LINE OF SAID QUARTER SECTION IN BURKHARDT ROAD; THENCE NORTH ALONG SAID WEST LINE FOR 414.33 FEET TO THE PLACE OF BEGINNING.
