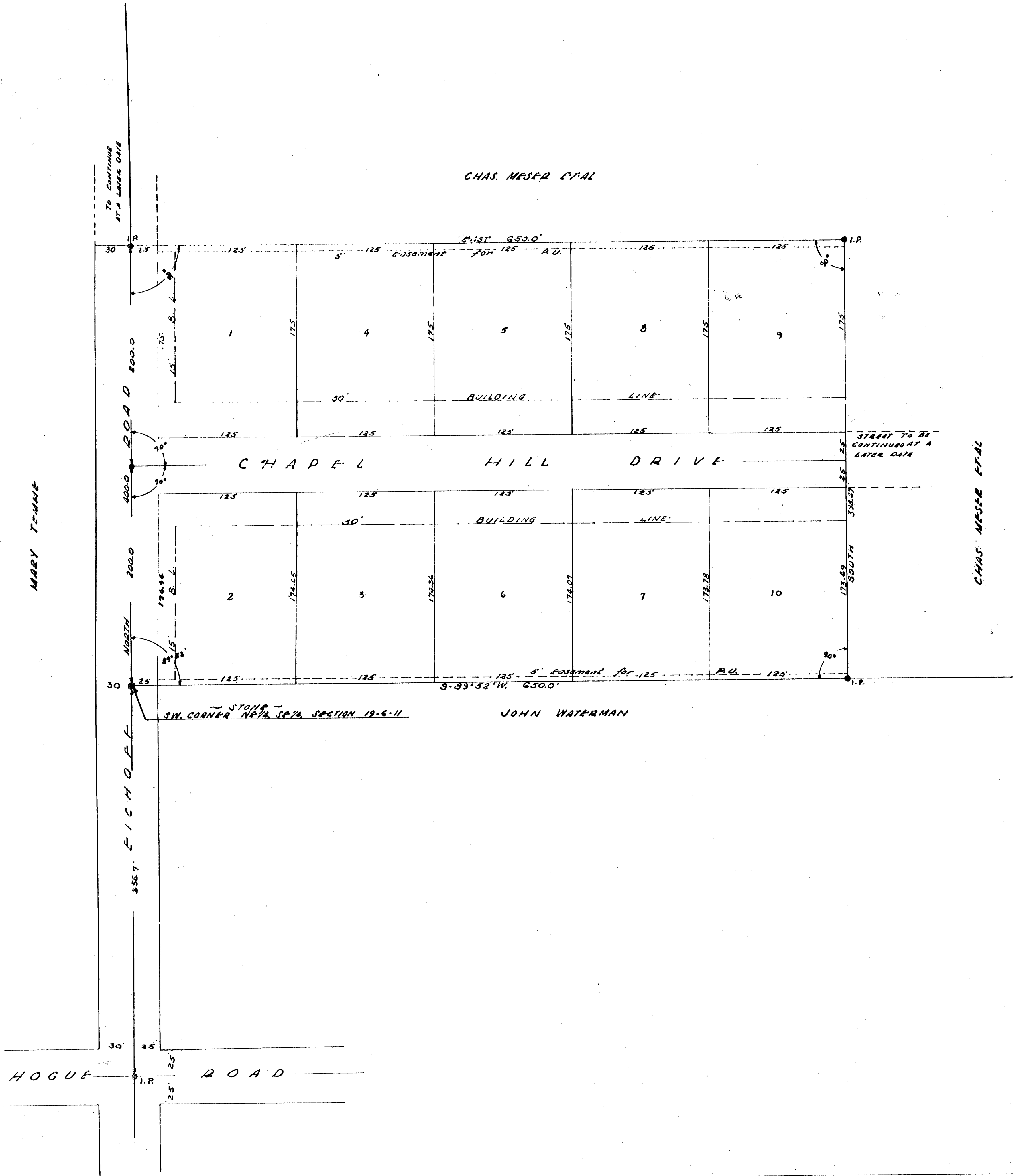

Beginning at a stone, said stone being the S.W. corner of the above said 1/4, thence with the West line of said 1/4, North 400.0 feet to an iron pin in said line, thence East 450.0 feet to an iron pin, thence paralleling the said West line South 390.49 feet to an iron pin on the South line of said 1/4, thence with said South line S 89° 52' W 650.0 feet to the place of beginning, containing 5.97 acres more or less, excepting all legal highways and rights of ways.
