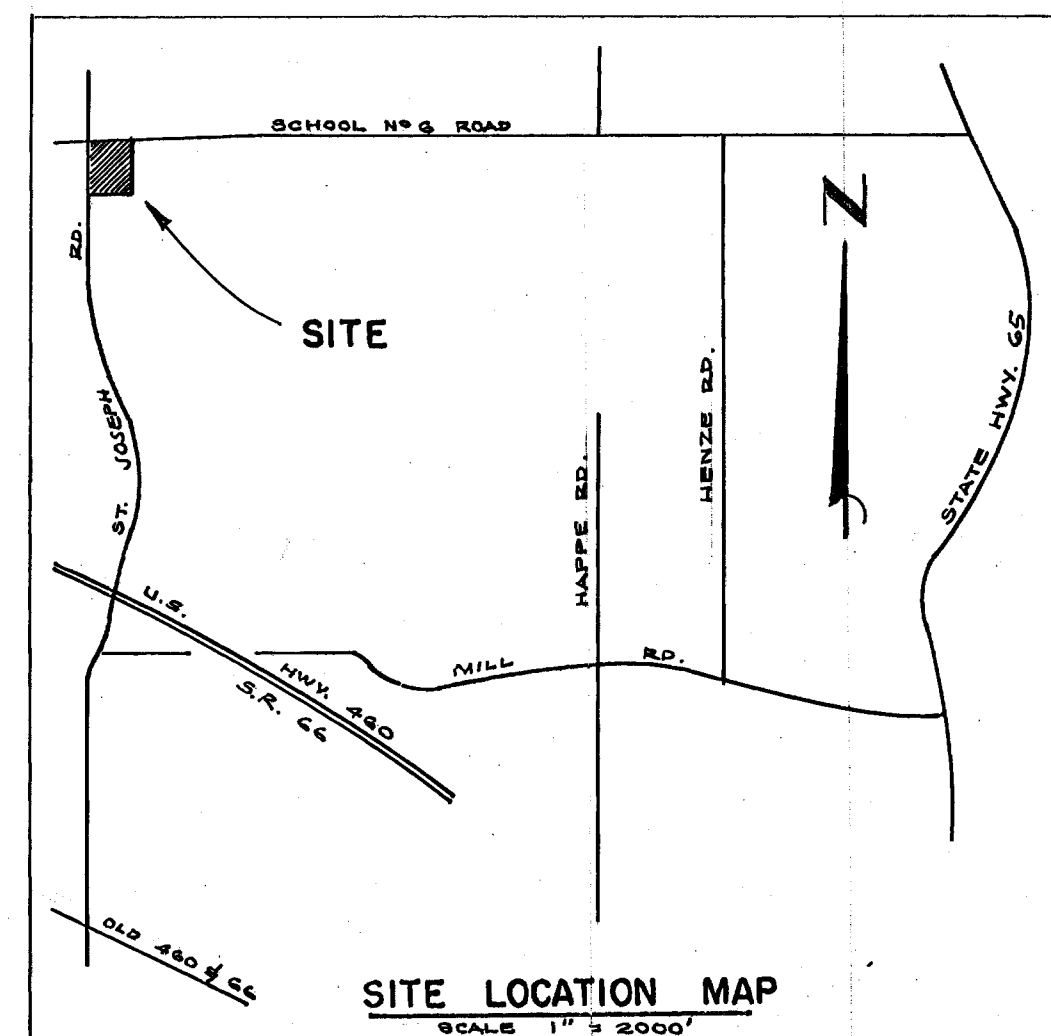
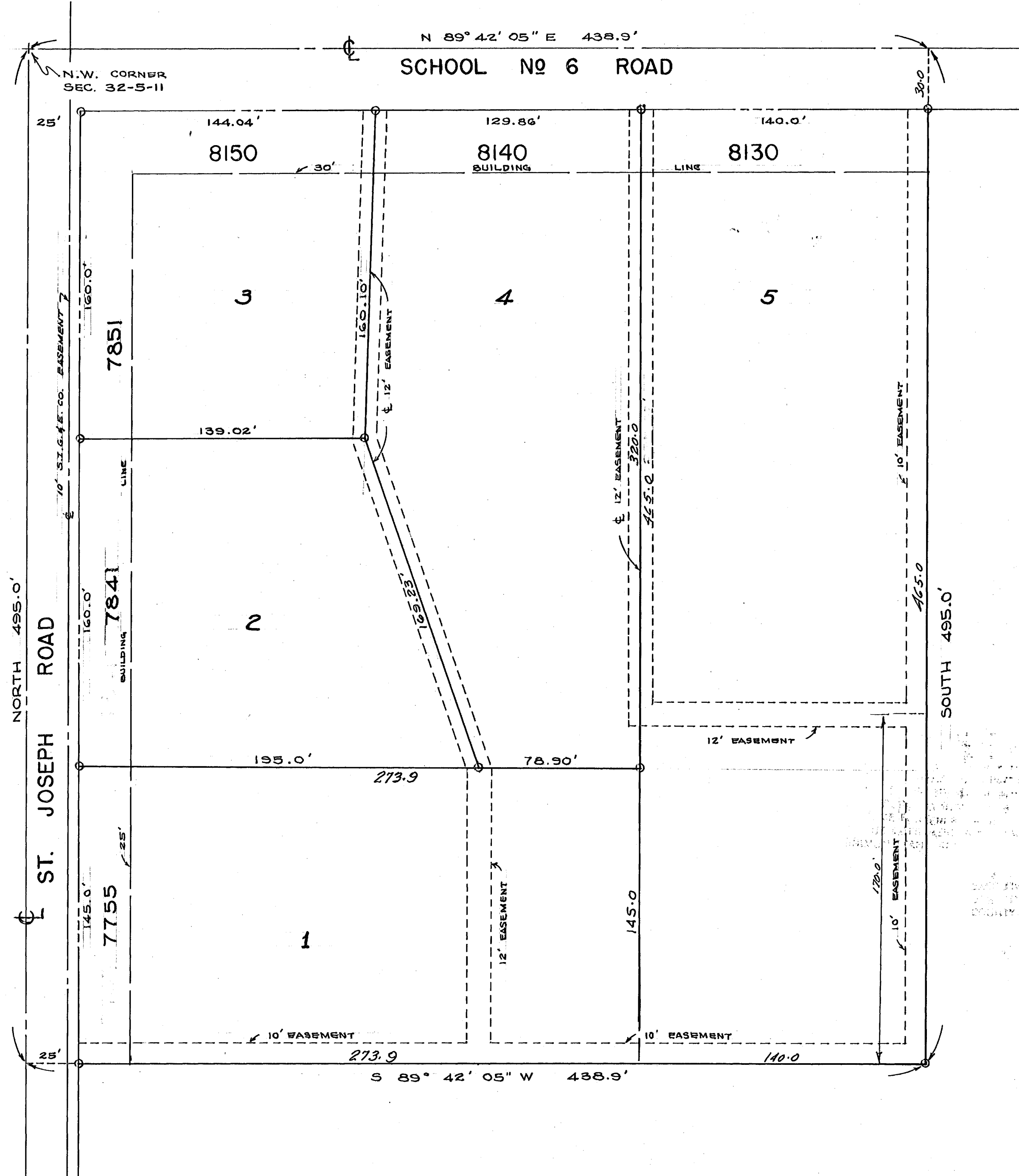
LEGAL DESCRIPTION

A SUBDIVISION OF PART OF THE NORTHWEST QUARTER OF SECTION THIRTY TWO (32), TOWNSHIP FIVE (5) SOUTH, RANGE ELEVEN (11) WEST, IN VANDERBURGH COUNTY, INDIANA, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF THE SAID QUARTER SECTION; THENCE NORTH 89 DEGREES, 42 MINUTES AND 05 SECONDS EAST ALONG THE NORTH LINE OF THE SAID QUARTER SECTION FOR 438.9 FEET; THENCE SOUTH AND PARALLEL TO THE WEST LINE OF THE SAID QUARTER SECTION FOR 495.0 FEET, THENCE SOUTH 89 DEGREES, 42 MINUTES AND 05 SECONDS WEST, PARALLEL TO THE NORTH LINE OF THE SAID QUARTER SECTION, FOR 438.9 FEET TO THE WEST LINE OF THE SAID QUARTER SECTION; THENCE NORTH ALONG THE SAID WEST LINE FOR 495.0 FEET, TO THE PLACE OF BEGINNING.
