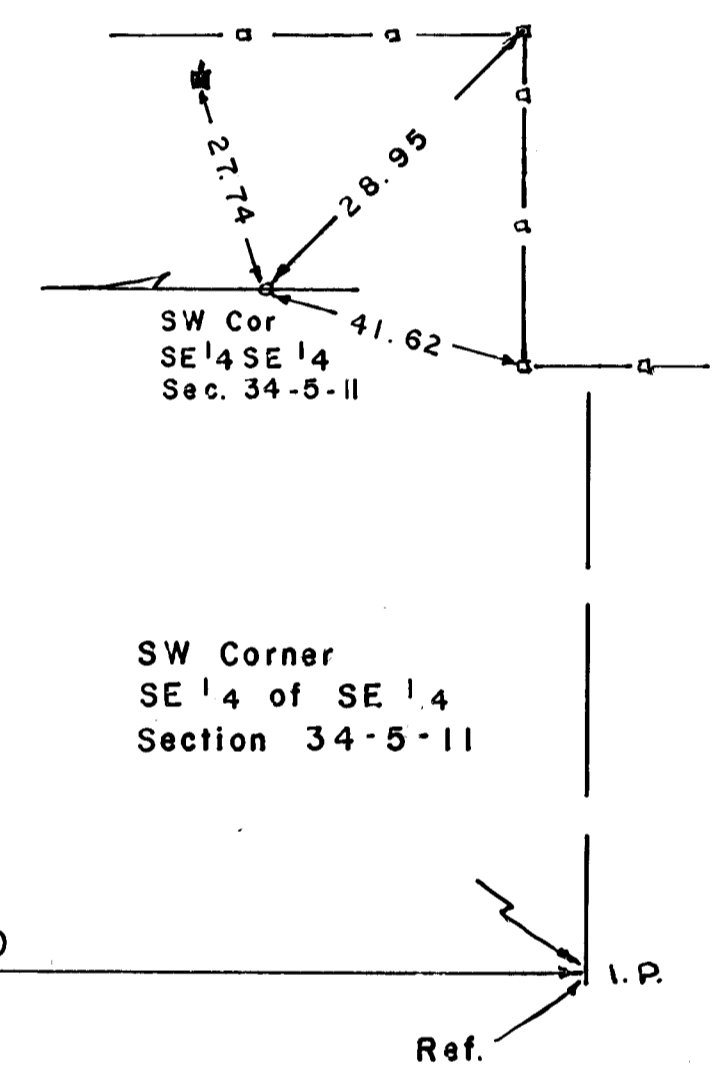
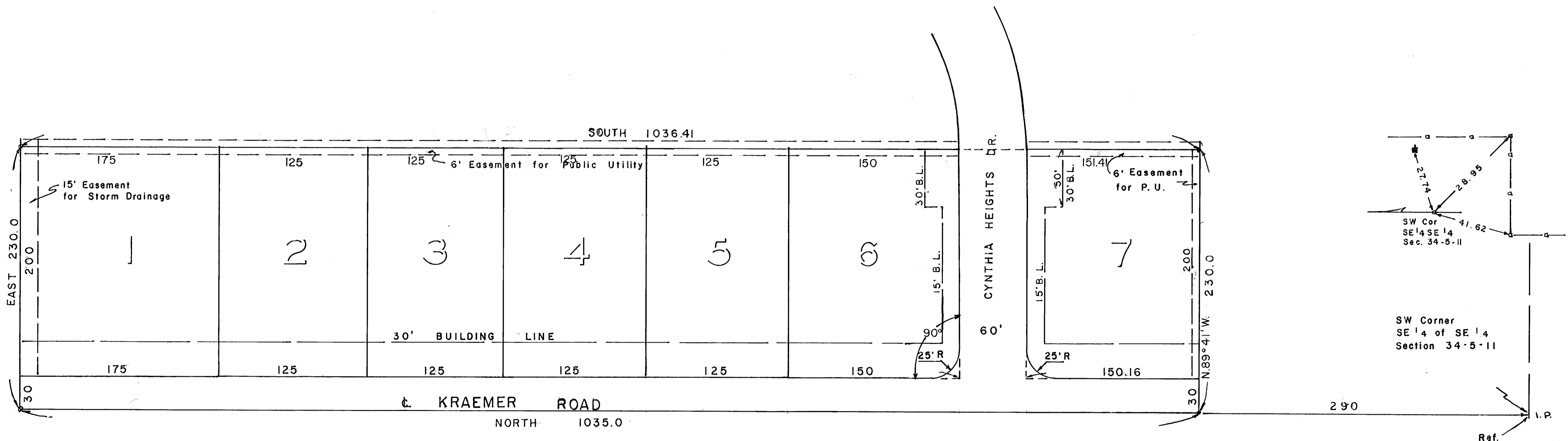
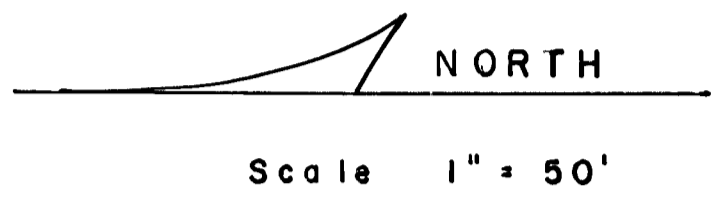

A subdivision of part of the Southeast Quarter of the Southeast Quarter of Section 34, Township 5 South, Range 11 West, Vanderburgh County, Indiana, described as follows:
Beginning on the West line of said quarter-quarter section a distance of 290 feet North of the southwest corner thereof; thence North along said West line a distance of 1035.0 feet to the center of a ditch; thence East along said center line a distance of 230 feet; thence South 1036.41 feet more or less to a point 290 feet North of the South line; thence N 89° 41' W a distance of 230 feet to the place of beginning.

Building setback lines are established as shown on the plat between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plat and marked "P.U." Easement are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easements hereon reserved. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities in said strips of ground.

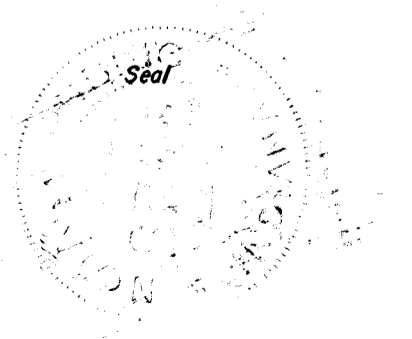
