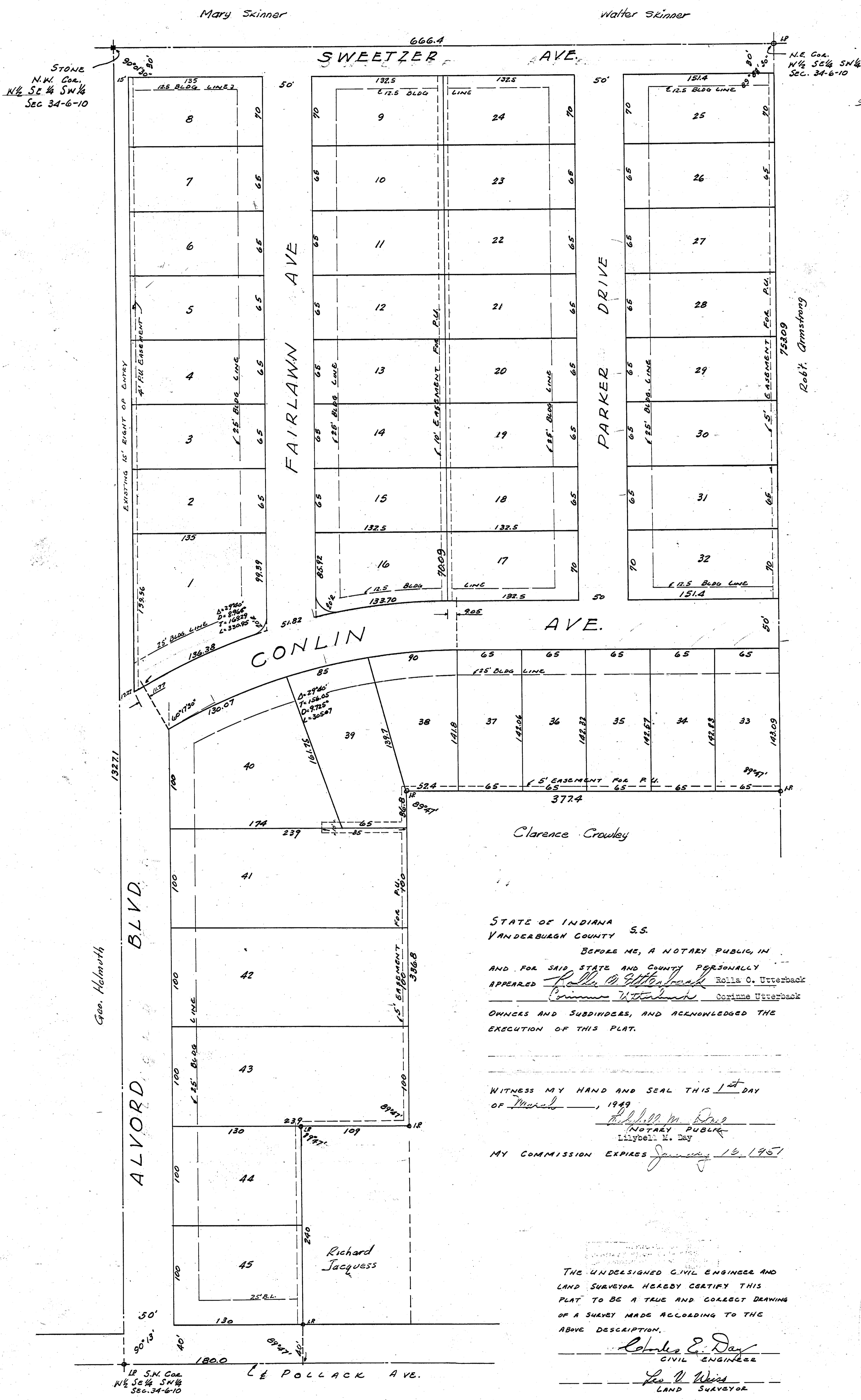


# EASTERN TERRACE

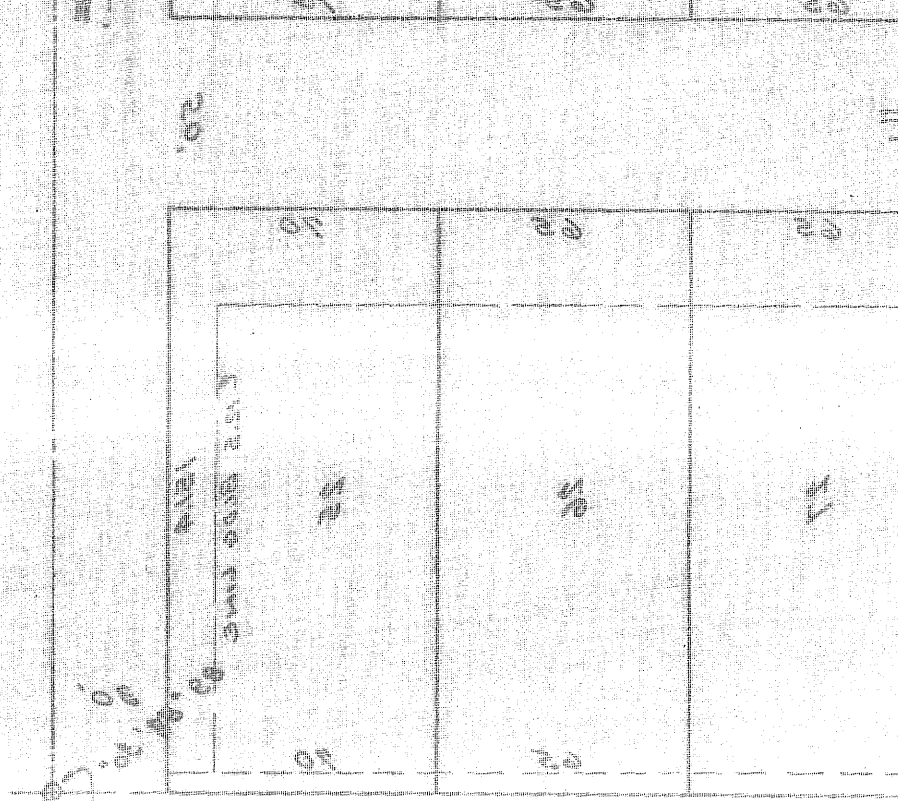
