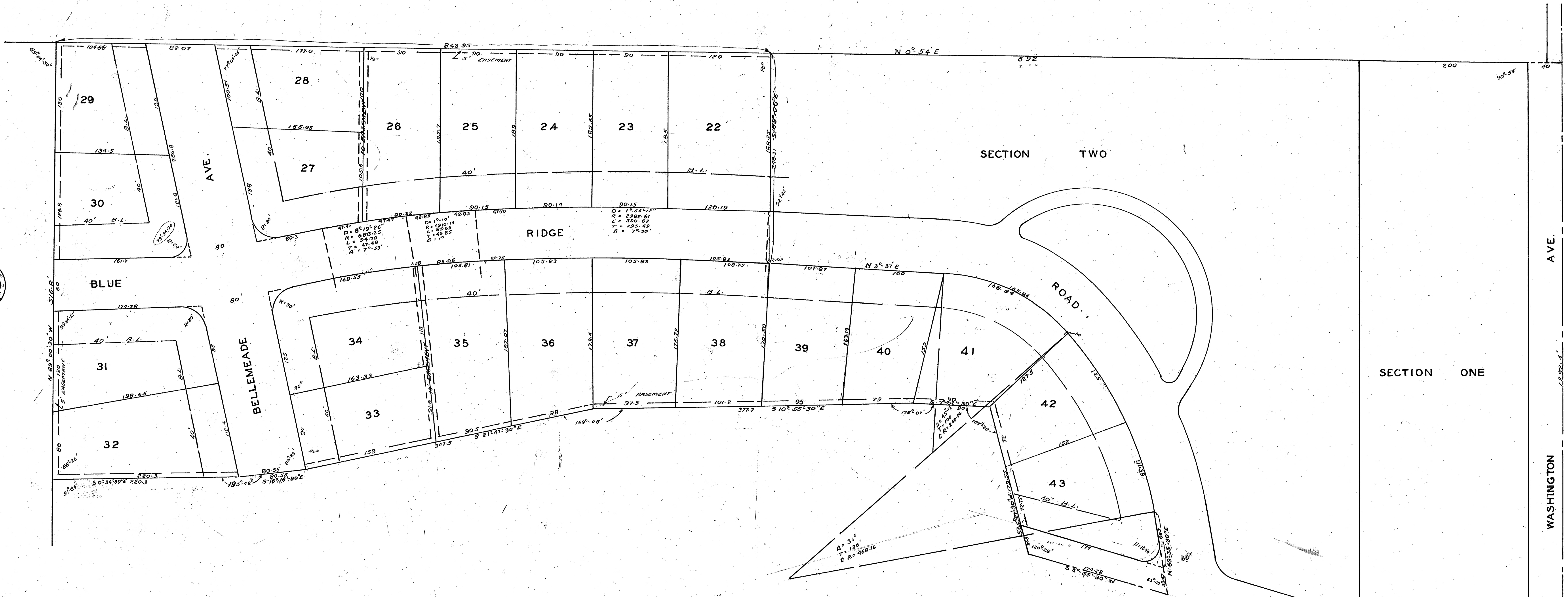


SECTION THREE

ALL THAT PART OF THE SOUTHWEST QUARTER OF SECTION 26, TOWNSHIP 6 SOUTH, RANGE 10 WEST, DESCRIBED AS BEGINNING AT THE NORTHEAST CORNER OF HEBRON MEADOW; SECTION TWO, SAID PLACE OF BEGINNING IS DESCRIBED AS COMMENCING AT THE SOUTHWEST CORNER OF SAID QUARTER SECTION AND RUNNING THENCE EAST ALONG THE SOUTH LINE THEREOF 1232.4 FT., THENCE N 0° 54' E - 933.0 FT. TO SAID NORTHEAST CORNER; FROM SAID PLACE OF BEGINNING CONTINUE N 0° 54' E - 843.95 FT.; THENCE N 89° 00' 30" W - 516.8 FT.; THENCE S 0° 34' 30" E - 220.3 FT. 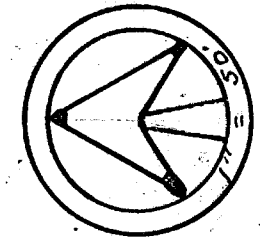
