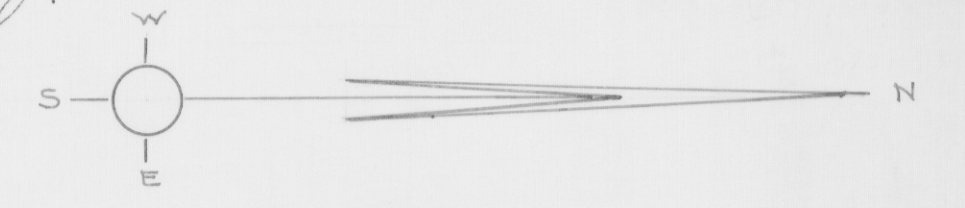

OF PART OF THE NORTHWEST QUARTER OF SECTION 35, TOWNSHIP 5 SOUTH, RANGE 10 WEST IN VANDERBURGH COUNTY, INDIANA; MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE NORTH LINE OF SAID QUARTER SECTION, SAID POINT LYING 372.17 FEET SOUTH OF THE NORTHWEST CORNER OF SAID QUARTER SECTION; FROM SAID PLACE OF BEGINNING THENCE EAST AND PARALLEL TO THE SOUTH LINE OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION FOR A DISTANCE OF 200 FEET; THENCE SOUTH AND PARALLEL TO THE WEST LINE OF SAID QUARTER SECTION FOR A DISTANCE OF 750 FEET; THENCE WEST AND PARALLEL TO THE SOUTH LINE OF SAID QUARTER SECTION FOR A DISTANCE OF 200 FEET TO A POINT ON THE SAID WEST LINE; THENCE SOUTH ALONG THE SAID WEST LINE FOR A DISTANCE OF 100 FEET; THENCE EAST AND PARALLEL TO THE SAID SOUTH LINE FOR A DISTANCE OF 200 FEET; THENCE SOUTH AND PARALLEL TO THE SAID WEST LINE FOR A DISTANCE OF 100 FEET; THENCE WEST AND PARALLEL TO THE SAID SOUTH LINE FOR A DISTANCE OF 200 FEET TO A POINT ON THE SAID WEST LINE; THENCE SOUTH ALONG THE SAID WEST LINE FOR A DISTANCE OF 230 FEET; THENCE EAST AND PARALLEL TO THE SAID SOUTH LINE FOR 200 FEET; THENCE SOUTH AND PARALLEL TO THE SAID WEST LINE FOR 100 FEET; THENCE WEST AND PARALLEL TO THE SAID SOUTH LINE FOR 200 FEET TO A POINT ON THE SAID WEST LINE; THENCE NORTH ALONG THE SAID WEST LINE FOR 1280 FEET TO THE PLACE OF BEGINNING



We, the undersigned owners of the real estate shown and described herein do hereby plat the same and designate it as WILLIAM HESEMAN SUBDIVISION. All streets within the plat are hereby dedicated to the public. Building set-back lines are established as shown on the plat and between these lines and the street. Right-of-way there shall not be erected or maintained any building or structure. Strips of land shown on the plat and marked "EASEMENT FOR P.U." are reserved for the installation, maintenance and repair of water, sewers, gas, telephone and electrical, poles, lines and wires, subject at all times to the proper authorities and to the easements hereon reserved. No structure shall be erected or maintained on these strips of land and owners shall take title subject to the rights of the public utilities in these strips of land
