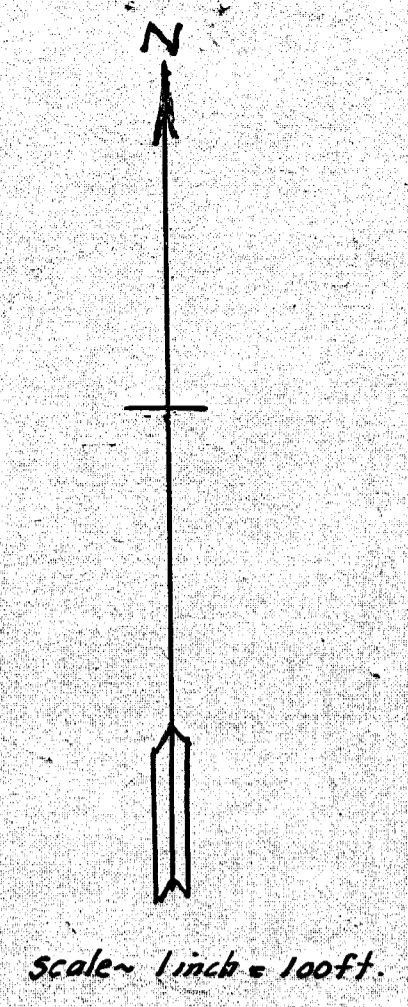

**PLAT OF
 LAKE TALAHY.**

A SUBDIVISION OF PART OF THE EAST 1/2 OF SEC. 28-5-10 AND PART OF THE WEST 1/2 OF SECTION 27-5-10, DESCRIBED AS FOLLOWS:-

Beginning at the point of intersection of the center line of the Whetstone Road and the south line of the E 1/2 of the SW 1/4 of section 27-5-10 and running thence northwesterly along the center of said road to the point where the center of said road intersects the north line of the south 1/2 of the S.W. 1/4 of the N.W. 1/4 of said section 27-5-10; thence west along the north line of said 1/2 of section to the North West corner thereof; thence south along the line dividing Sec. 27-5-10 and 28-5-10 a distance of 175 feet; thence west a distance of 239.5 feet to the center of the Petersburg Road; thence in a southerly direction along the center of the Petersburg Road to its intersection with the north line of the land now owned by the McCutchans as recorded in Deed Record 165 on page 30; thence S-70°8'-E a distance of 180.3 feet to a stone; thence S-63°24'-E 201.2 feet to a stone; thence south 358.2 feet to a stone on the south line of the N.W. 1/4 of the S.W. 1/4 of Sec. 27-5-10; thence west to the center of the Petersburg Road; thence in a southwesterly direction along the center of the Petersburg Road to a point 340 feet south of the north line of the S.E. 1/4 of the S.E. 1/4 of Sec. 28-5-10; thence east to the east line of the S.W. 1/4 of the S.W. 1/4 of Sec. 27-5-10; thence north 340 feet to the S.W. corner of the N.E. 1/4 of said section 27-5-10; thence east along the south line of the N.E. 1/4 of the S.W. 1/4 of said section 27-5-10 to the place of beginning.

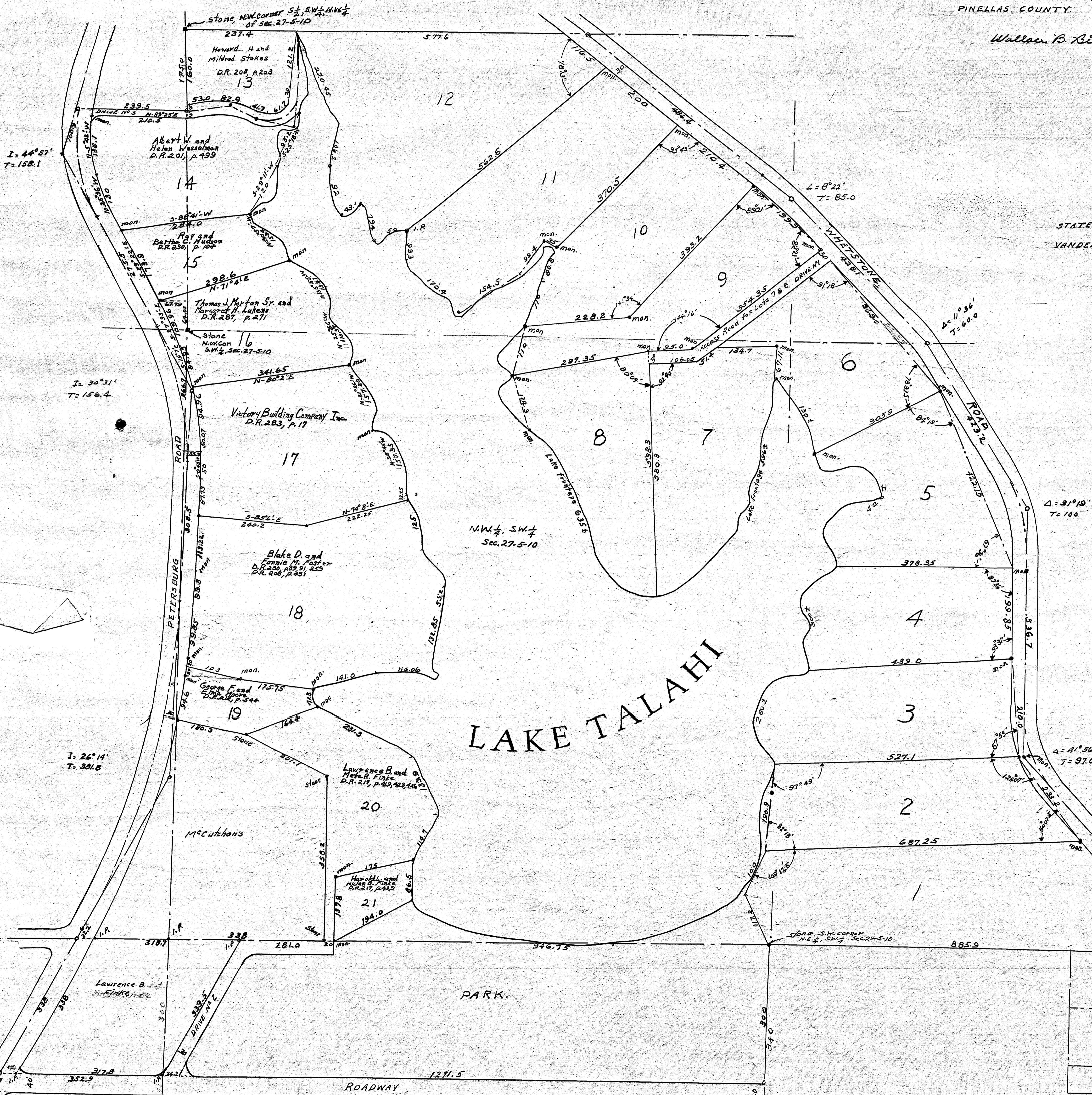

A SUB-DIVISION OF PART OF THE WEST HALF OF SECTION 27-5-10.

DESCRIPTION: Beginning at a point on the north line of the south 1/2 of the S.W. 1/4 of the N.W. 1/4 of said section 27-5-10 at a distance of 237.4 feet east of the northwest corner of said 1/4, 1/4 section and running thence east along said north line to the center of the Wheelstone Road; thence southeastwardly along the center of said road to the intersection of the center of said road with the south line of the N.E. 1/4 of the S.W. 1/4 of said section 27-5-10; thence west along the south line of said N.E. 1/4, S.W. 1/4 a distance of 926.8 ft. to the southwest corner of said N.E. 1/4, S.W. 1/4; thence south along the east line of the S.W. 1/4 of the S.W. 1/4 of said section 27-5-10 a distance of 340 feet; thence westwardly and parallel with the north line of said S.W. 1/4, S.W. 1/4 of sec. 27-5-10 to a point on the west line of said S.W. 1/4, S.W. 1/4 of sec. 27-5-10; thence north 40 feet; thence N. 41° 33' E a distance of 339.5 ft. to a point on the north line of said S.W. 1/4, S.W. 1/4 of section 27-5-10; thence eastwardly along the north line of said S.W. 1/4, S.W. 1/4 of section 27-5-10 a distance of 201 ft.; thence N. 61° 26' E a distance of 194 feet to a point on the shore line of LAKE TALAHI; thence in a northerly direction along the meanders of said shore line to a point which is S. 8° 45' E and 137.7 feet distant from the point of beginning; thence N. 8° 45' W a distance of 137.7 feet to the place of beginning.

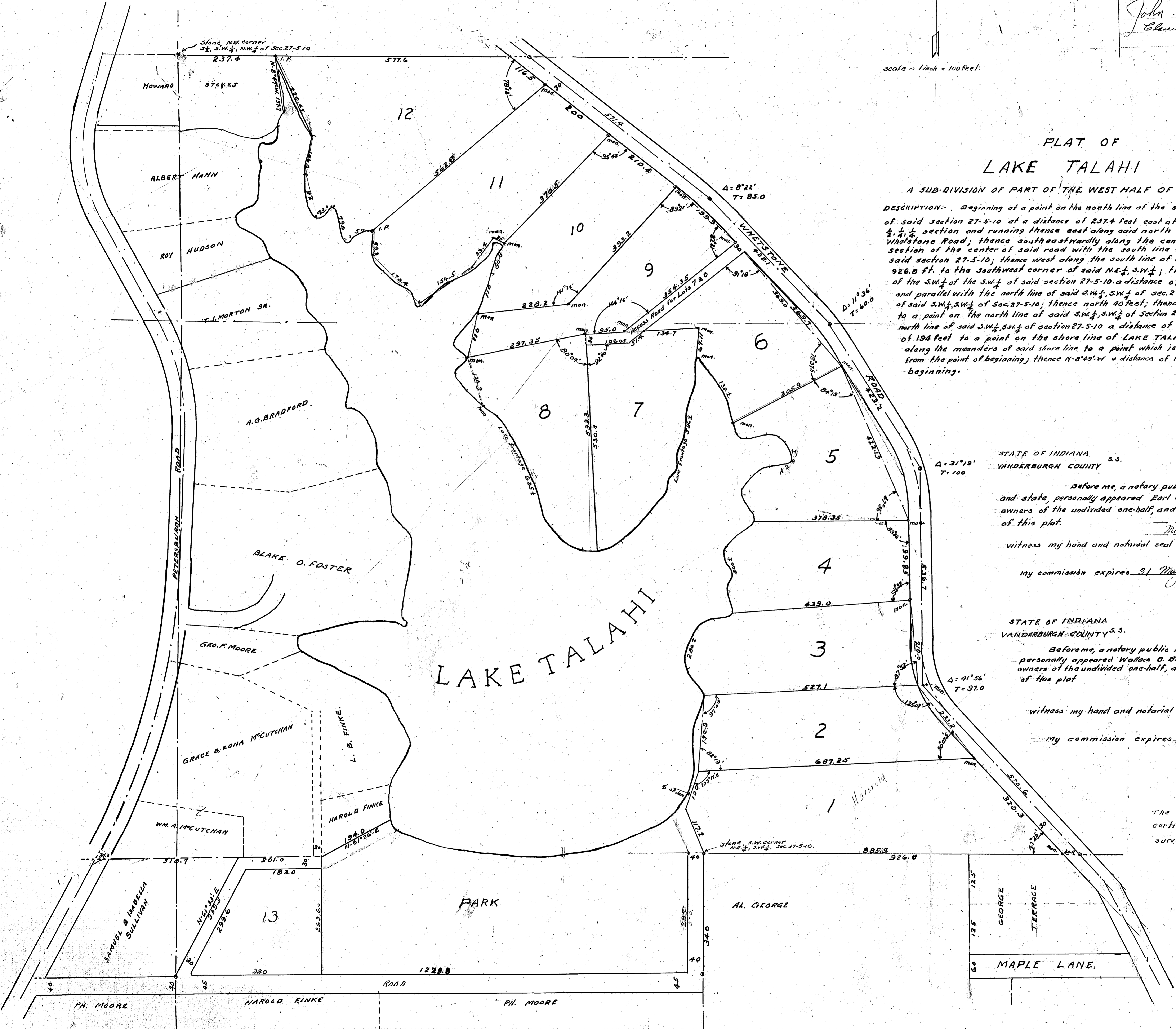
