LEGAL DESCRIPTION

A subdivision of part of the north half of the north half of the northwest quarter of the northeast quarter of Section 32, Township 6 South, Range 11 West, lying in Vanderburgh County, Indiana, more particularly described as follows:

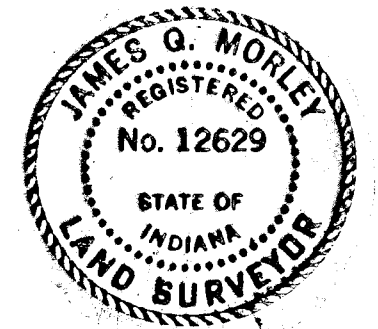
Beginning at the northwest corner of the northeast quarter of Section 32, said point being marked by an iron pin found in place and said pin being the true point of beginning; thence south 88 degrees, 52 minutes, 21 seconds east along the section line a distance of 630.00 feet to an iron pin; thence south 00 degrees, 05 minutes, 46 seconds east a distance of 326.95 feet to an iron pin; thence north 89 degrees, 02 minutes, 49 seconds west a distance of 629.96 feet to a railroad spike set in Schutte Road; thence north 00 degrees, 05 minutes, 46 seconds west along the quarter section line a distance of 328.85 feet to the true point of beginning, containing 4.73 acres.

The subdivision is also subject to an undefined easement for a pole and wire power line acquired by the Southern Indiana Gas and Electric Company in 1936. The existing location of this line is shown on the plat.

OWNER'S CERTIFICATE

No structures are to be erected or maintained upon said strip of land, and owners in this subdivision shall take their titles subject to the rights of public utilities.

The undersigned owners also reserve the right to dedicate the easement for ingress and egress across lots 11 and 12 as street right-of-way.
