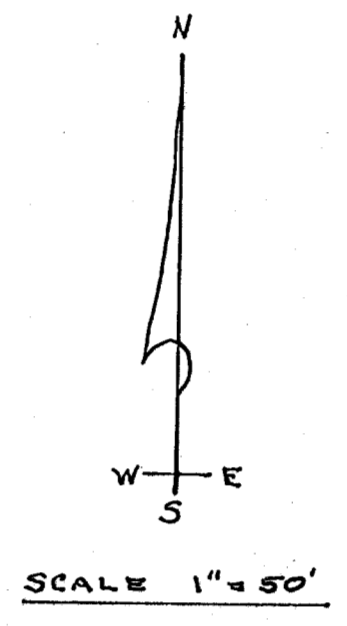
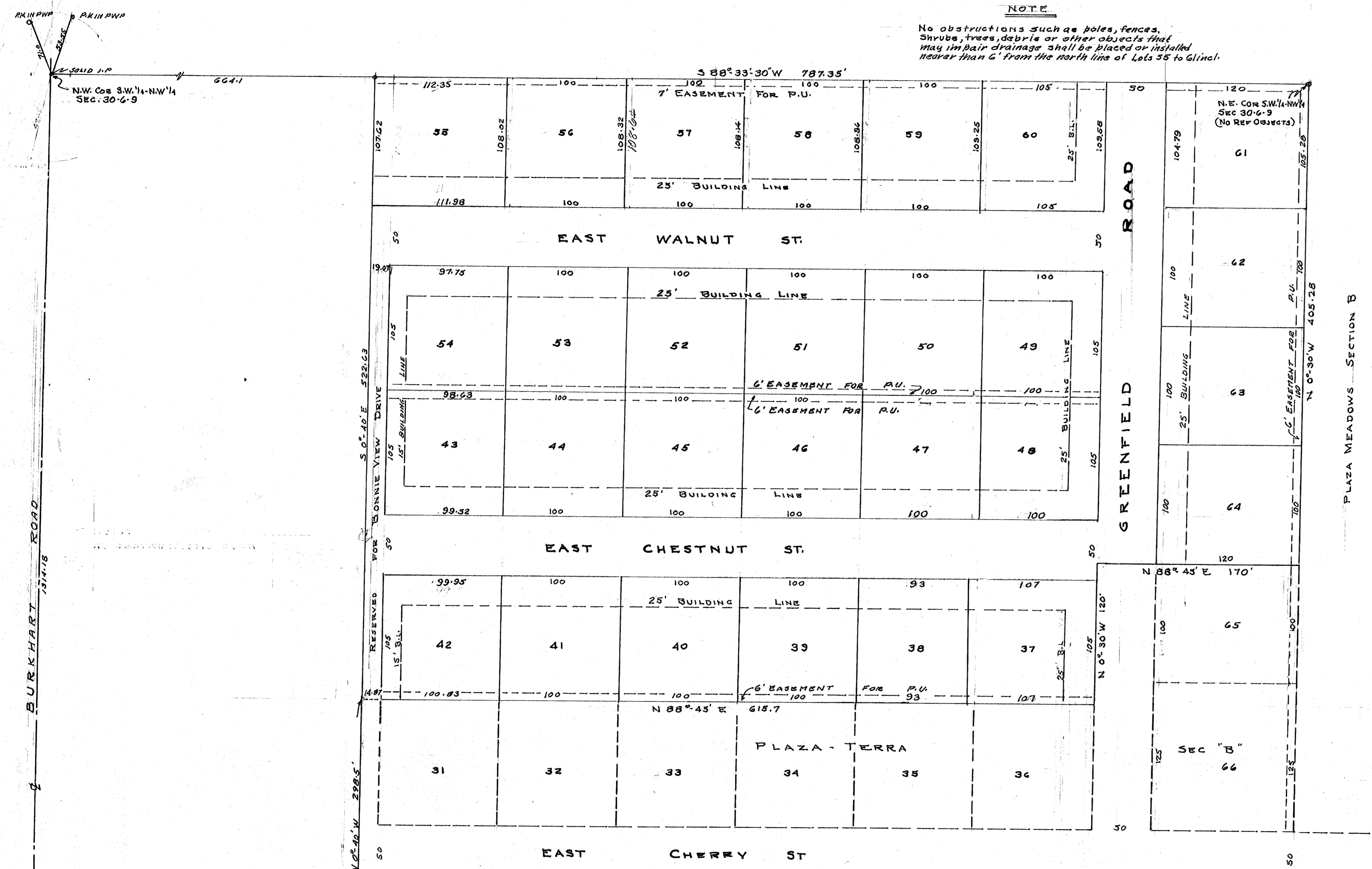
NOTE
