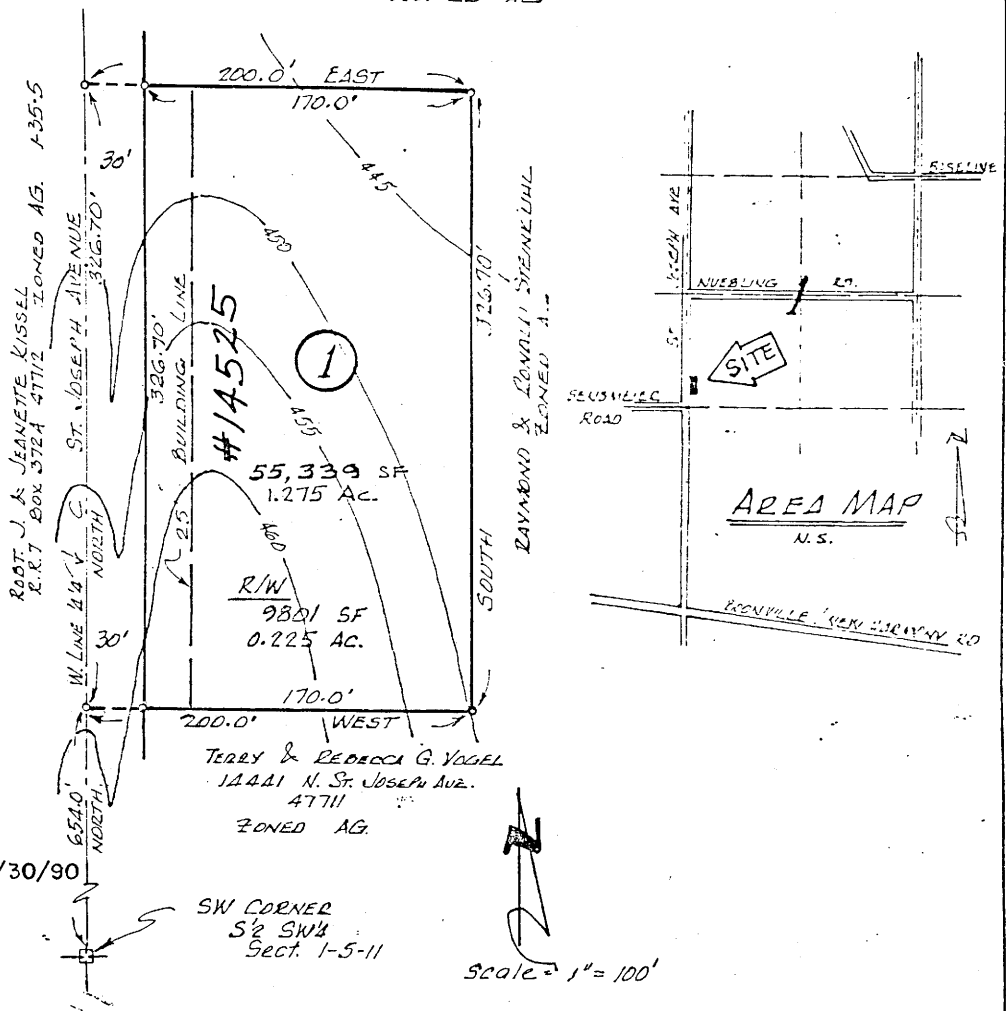

That part of the South one-half of the Southwest quarter of Section 1, Township 5 South, Range 11 West in Vanderburgh County, Indiana, described as follows:

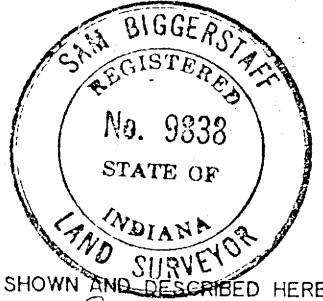

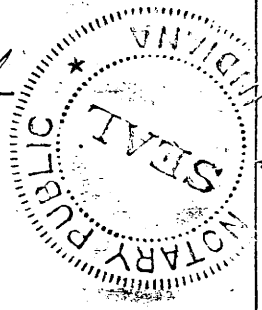
