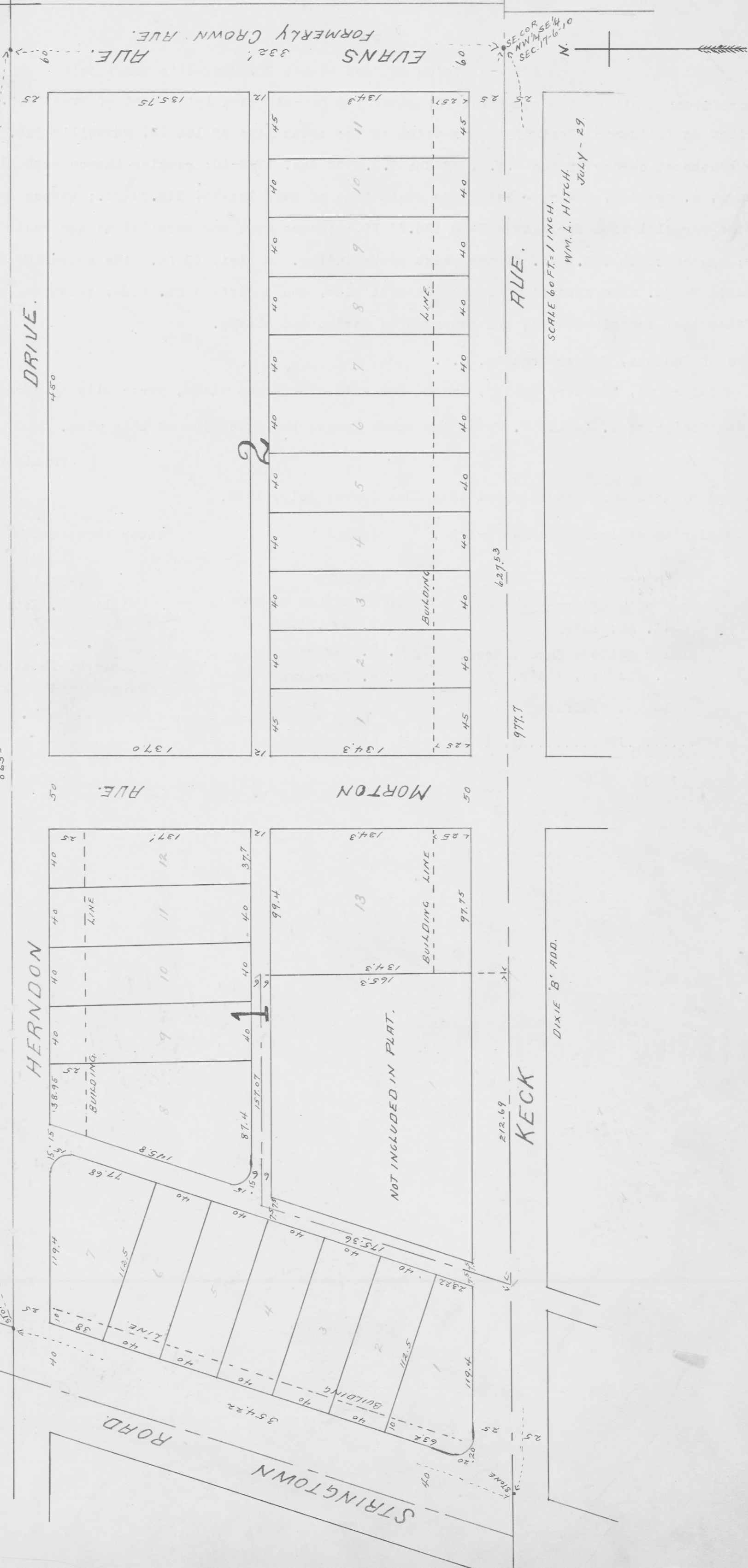


A SUBDIVISION OF PART OF LOT 23 MAXWELL'S SUBDIVISION.

A Sub-division of Part of Lot 23, Maxwell's Subdivision

Description:- All that part of lot 23, Maxwell's Sub-division lying west of Evans Ave. except a tract described as follows:- Beginning at a point on the south line of lot 23, Maxwell's Sub. 627.53 ft. west of the southeast corner of the N.W. 1/4, of the S.E. 1/4 of Sec. 17-6-10; running thence west along the south line of said 1/4, 1/4. section, the same being the south line of said lot 23, 212.69 ft.; thence in a northeasterly direction parallel with Stringtown Road 175.36 ft.; thence east and parallel to the south line of lot 23, 157.07 ft.; thence south 165.3 ft. to the point of beginning. A strip 25 ft. wide extending across the south end; a strip 7 1/2 ft. wide extending across the west side, and a strip 6 ft. wide, extending across the north side of this last described tract are reserved as street and alleys.
