

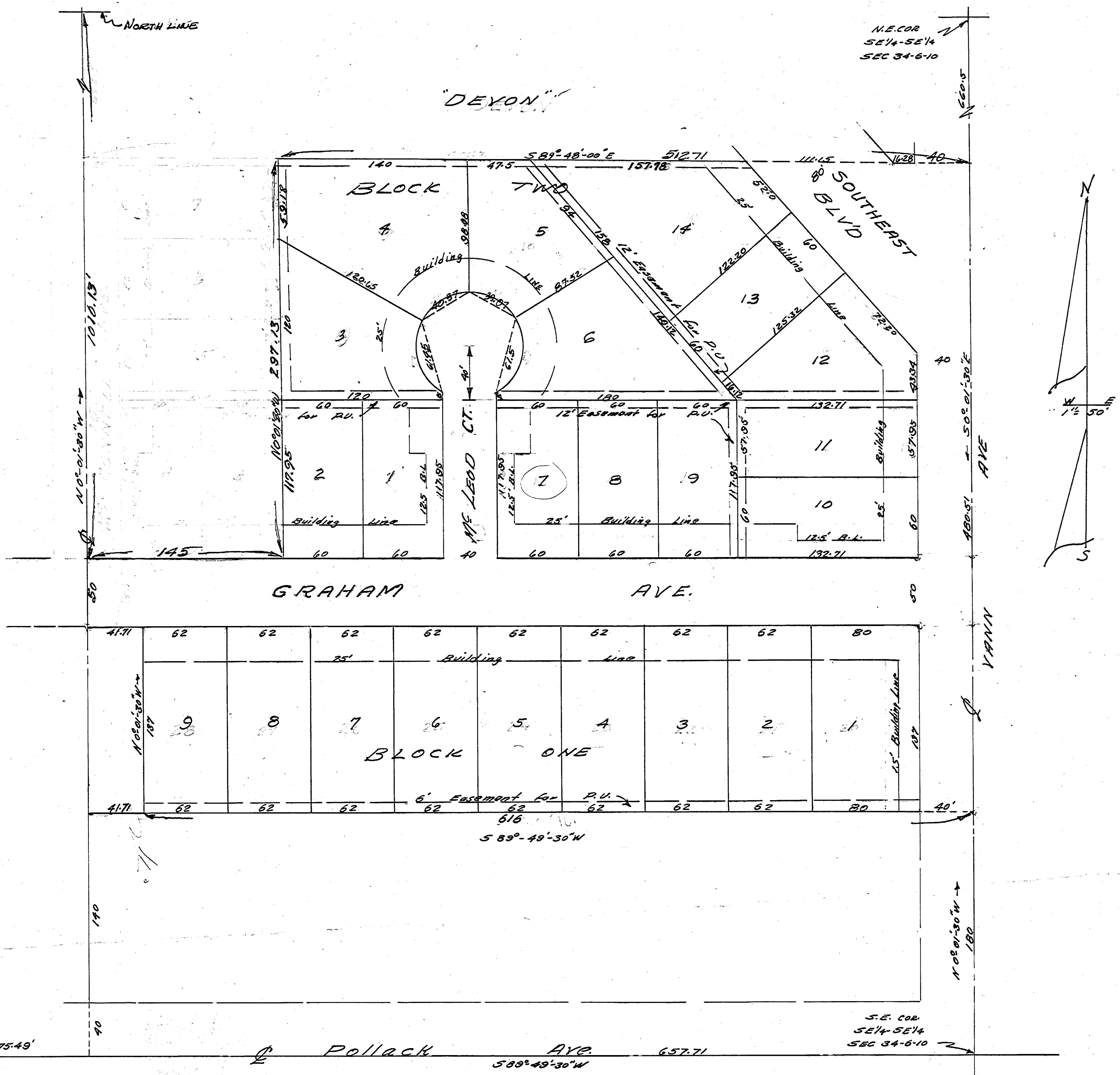

A subdivision of part of the Southeast Quarter of the Southeast Quarter of Section 34, Township 6 South, Range 10 West, in Vanderburgh County, Indiana, and described as follows: Beginning at a point on the East line of said quarter quarter section $N00^{\circ}01'30''W$ a distance of 180 feet from the Southeast corner thereof; thence $S89^{\circ}49'30''W$ and parallel to the South line of said quarter quarter section for a distance of 616 feet; thence $N00^{\circ}01'30''W$ for a distance of 137 feet; thence $S89^{\circ}49'30''W$ for a distance of 41.71 feet; thence $N00^{\circ}01'30''W$ and parallel to the said East line for 500 feet to a point which lies $S00^{\circ}01'30''E$ a distance of 1010.13 feet from the North line of said quarter quarter section; thence $S89^{\circ}49'30''E$ for a distance of 145.0 feet; thence $N00^{\circ}01'30''W$ a distance of 297.13 feet; thence $S89^{\circ}49'30''E$ a distance of 512.71 feet to a point on the East line of said quarter quarter section which lies $S0^{\circ}01'30''E$ a distance of 660.5 feet from the North East Corner thereof; thence $S0^{\circ}01'30''E$ along said East line a distance of 480.51 feet to the place of Beginning.
