

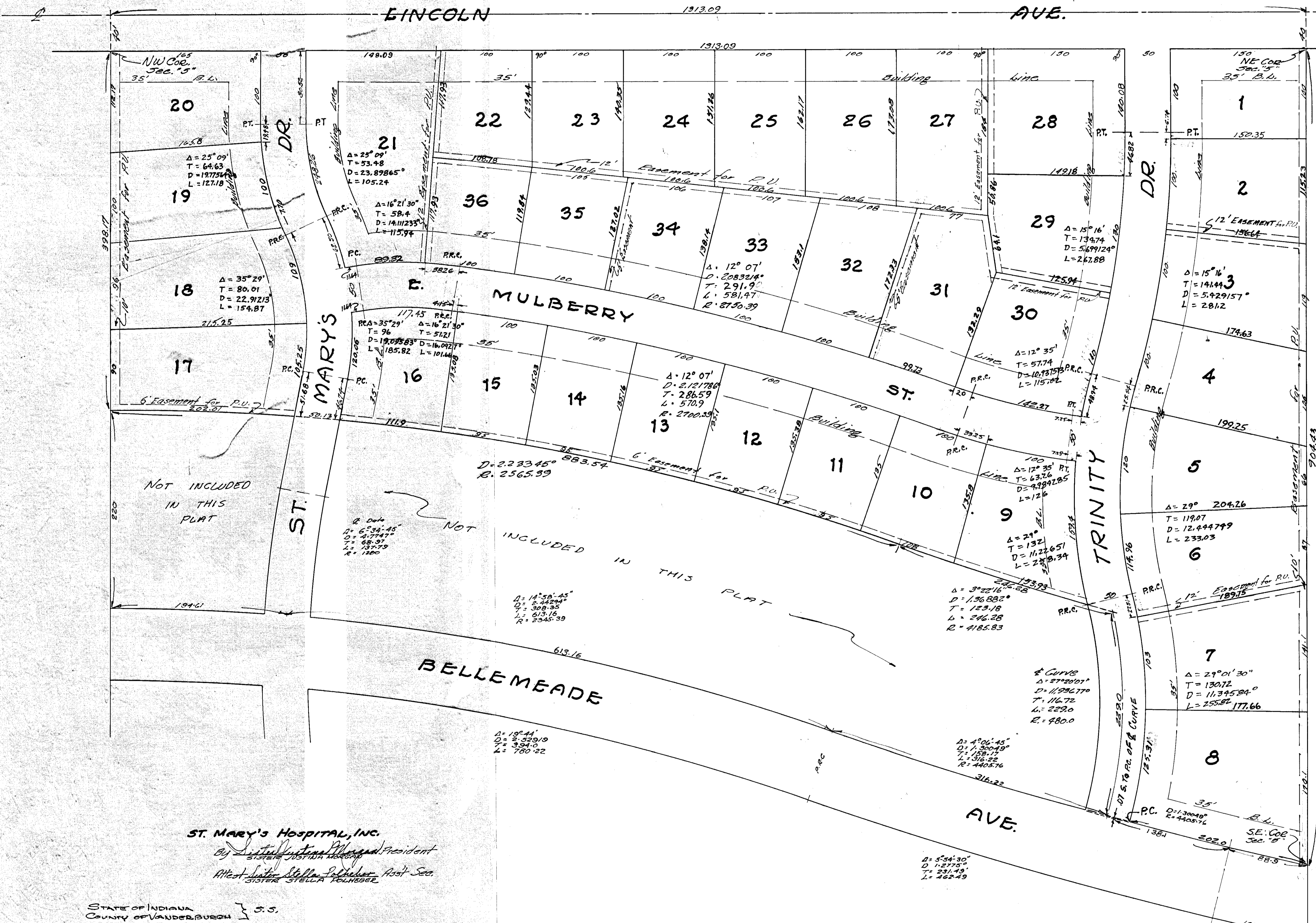
# ST MARY'S PARK

A REPLAT OF THE FOLLOWING DESCRIBED PART OF SECTION 5 OF ST MARY'S SUBDIVISION, AN ADDITION TO THE CITY OF EVANSVILLE AS PER PLAT THEREOF, RECORDED IN PLAT BOOK "I" PAGE 260, IN THE OFFICE OF THE RECORDERS OF VAN DER BURG COUNTY, IND., TO WIT:

Beginning at the northwest corner of section 5 of St Mary's Subdivision, thence south along the west line of said section 5 a distance of 398.17 feet to a point 200 feet North of the North line of Bellemeade Ave. as platted in said St Mary's Subdivision, thence Southeast along a 223345° Curve to the right and parallel to the North line of said Bellemeade Ave. a distance of 683.54 feet to the end of said curve, thence continue Southeast along a 136882° Curve to the left and parallel to the north line of said Bellemeade Ave. a distance of 246.28 feet to the end of said curve, thence Southeast along a 1193677° Curve to the right a distance of 229.0 feet to a point on the north line of said Bellemeade Ave., thence Southeast along said north line of Bellemeade Ave. and on a 130049° curve to the left a distance of 138.10 feet to the end of said curve, thence Southeast along the tangent to said curve and along the north line of said Bellemeade Ave. a distance of 88.90 feet to the Southeast corner of said Section 5, thence North along the East line thereof a distance of 904.43 feet to the Northeast corner of said Section 5, thence West along the north line thereof for a distance of 1313.09 feet to the place of beginning.
