# PLAT OF TAYLOR PLACE

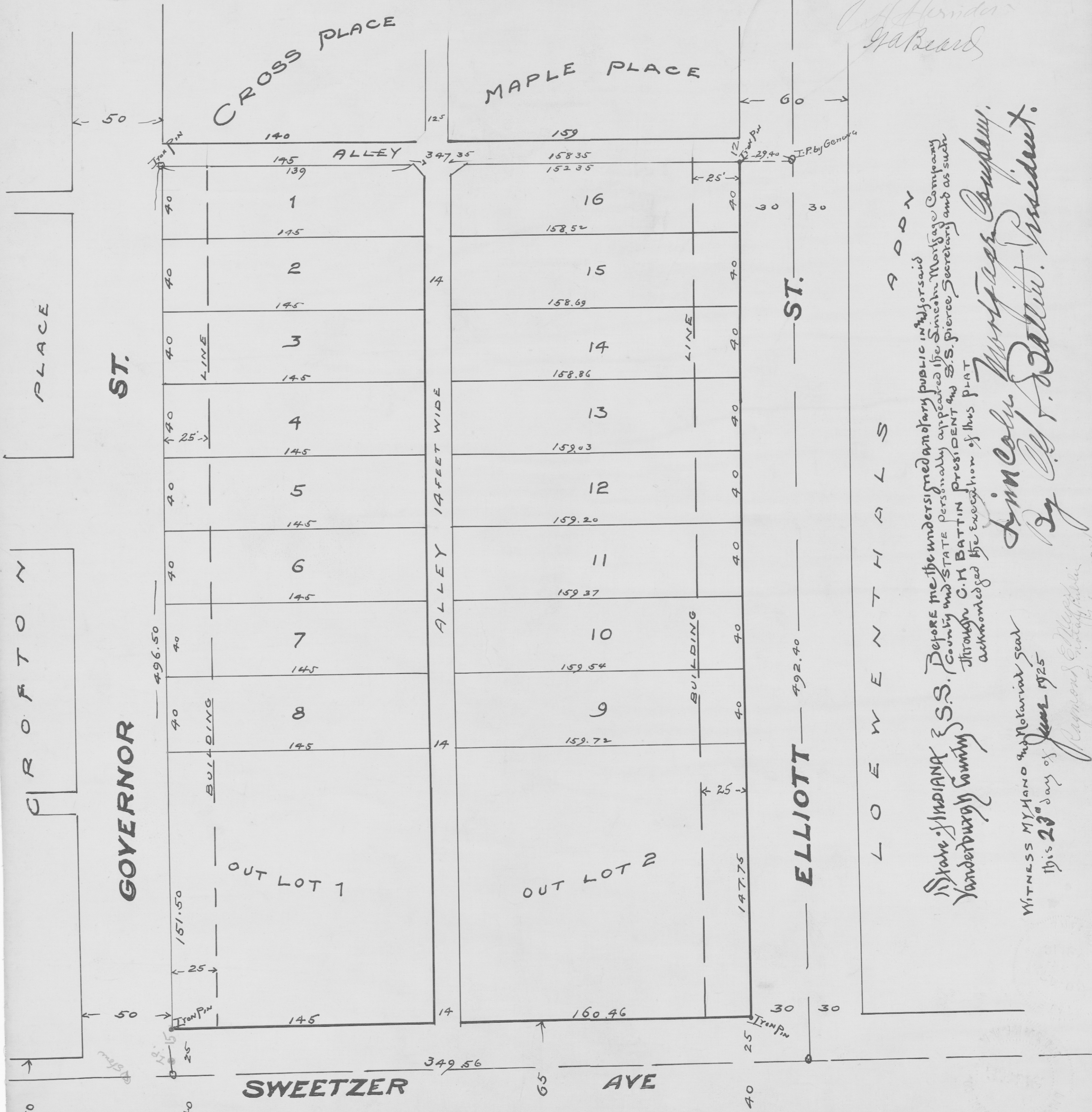
AN ADDITION TO THE CITY OF EVANSVILLE INDIANA AS LAID OUT BY
