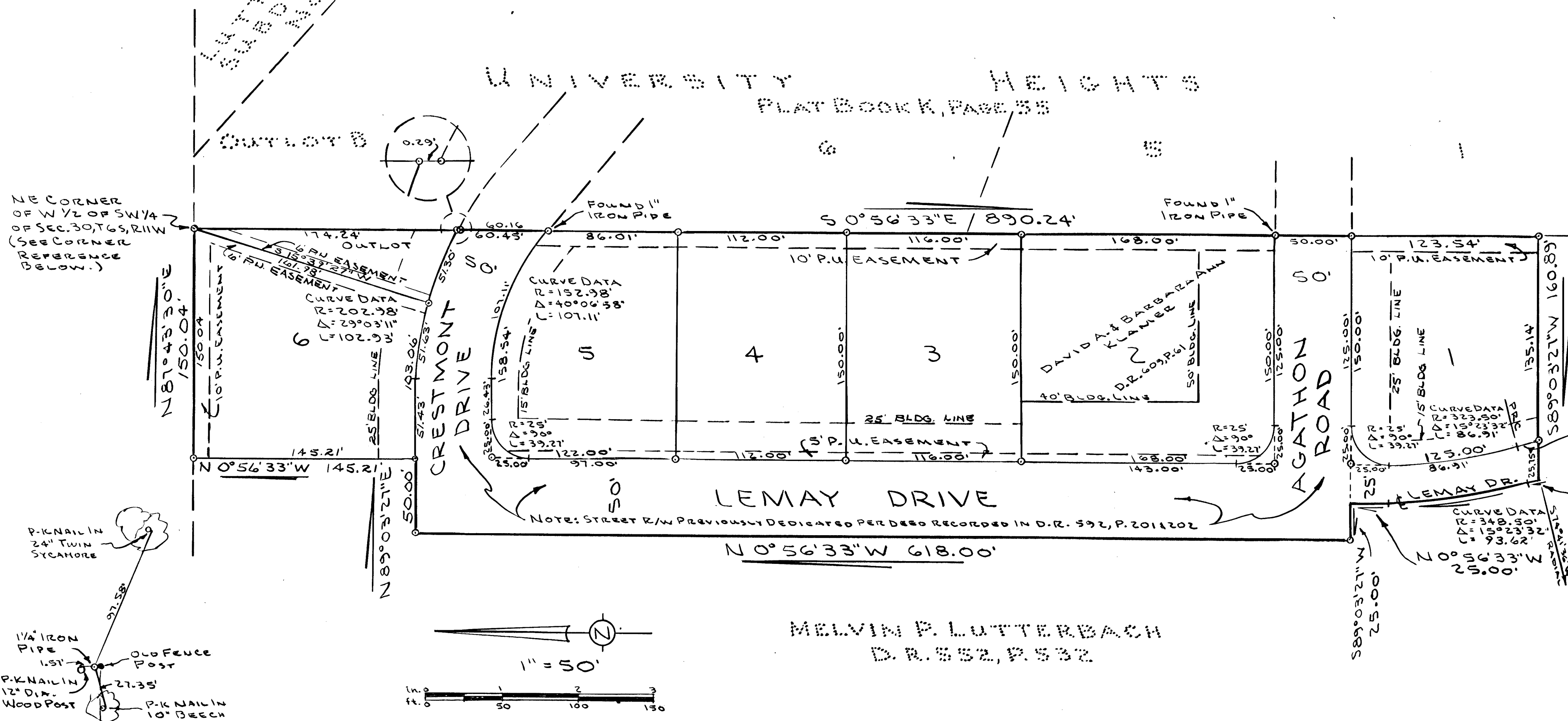
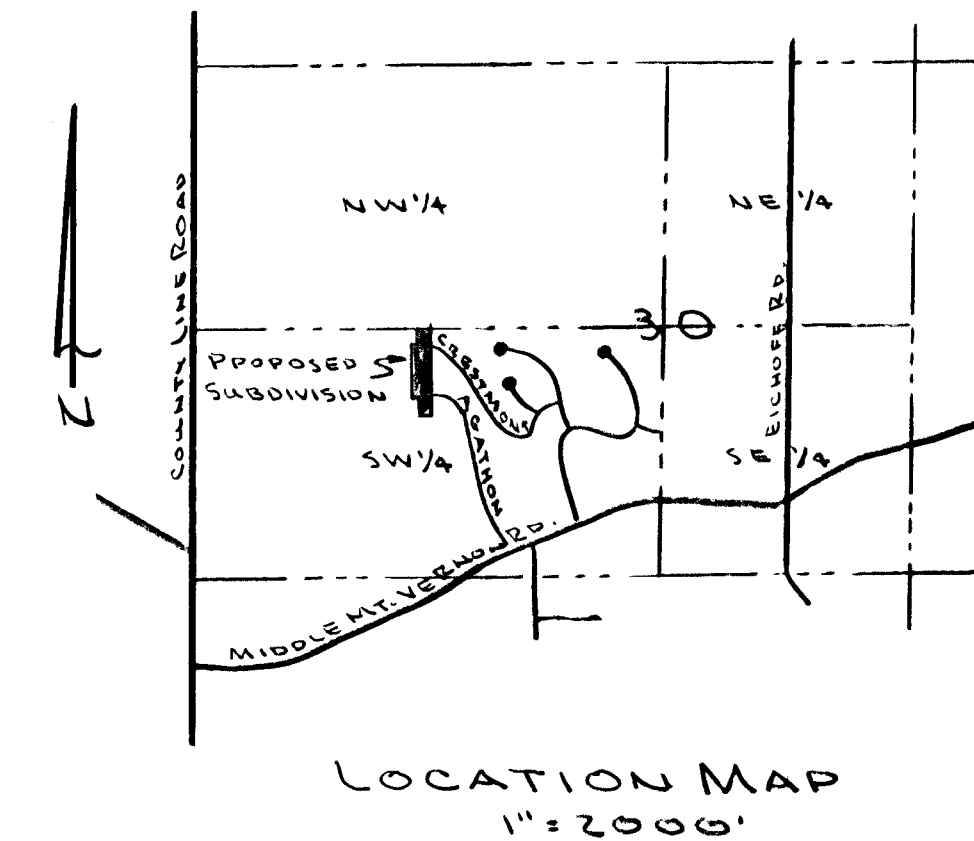

OWNERS' CERTIFICATE
We, the undersigned owners of the real estate shown and described herein, do hereby certify that we have laid off, platted and subdivided, and do hereby lay off, plat and subdivide the said real estate in accordance with the within plat.
All streets and alleys shown and not heretofore dedicated, are hereby dedicated to the public. Front and side yard building setback lines are hereby established as shown on this plat, between which lines and the property lines of the street, there shall be erected or maintained no buildings or structures. Strips of ground of the width as shown on this plat and marked "easement" are hereby reserved for the use of public utilities for the installation of water, sewer mains, surface water drainage, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easement herein reserved. No structures are to be erected or maintained upon said strips of land but owners in this subdivision shall take their titles subject to the rights of the public utilities.

LEGAL DESCRIPTION
Part of the West 1/2 of the Southwest 1/4 of Section 30, Township 6 South, Range 11 West in Vanderburgh County, Indiana, described as follows:
Beginning at the Northeast corner of said 1/2, 1/4 section, said point also being the Northwest corner of UNIVERSITY HEIGHTS, Subdivision as per plat recorded in plat book K, page 55, in the Office of the Recorder of Vanderburgh County, Indiana; thence, along the East line of said 1/2, 1/4 section and the West line of said UNIVERSITY HEIGHTS, Subdivision,
1st: S 0° 56' 33" E 890.24'; thence,
2nd: S 89° 03' 27" W 160.89' to a point on a 348.50' radius curve, concave to the West, said curve having a radial at said point bearing S 74° 41' 36" W; Thence, along said curve, through a central angle of 1° 01' 41",
3rd: Northerly 6.25' to the beginning of a tangent curve concave to the East, having a radius of 348.50 feet; thence, along said curve, through a central angle of 15° 23' 32",
4th: Northerly 93.62'; thence, parallel to said East line,
5th: N 0° 56' 33" W 25.00' to a point in the South right-of-way line of Agathon Road, 50' wide; thence, along said South right-of-way line,
6th: S 89° 03' 27" W 25.00' to its intersection with the West right-of-way line of Lemay Drive, 50' wide; thence, along said West right-of-way line and parallel with said West line,
7th: N 0° 56' 33" W 618.00' to its intersection with the North right-of-way line of Crestmont Drive; thence, along said North right-of-way line,
