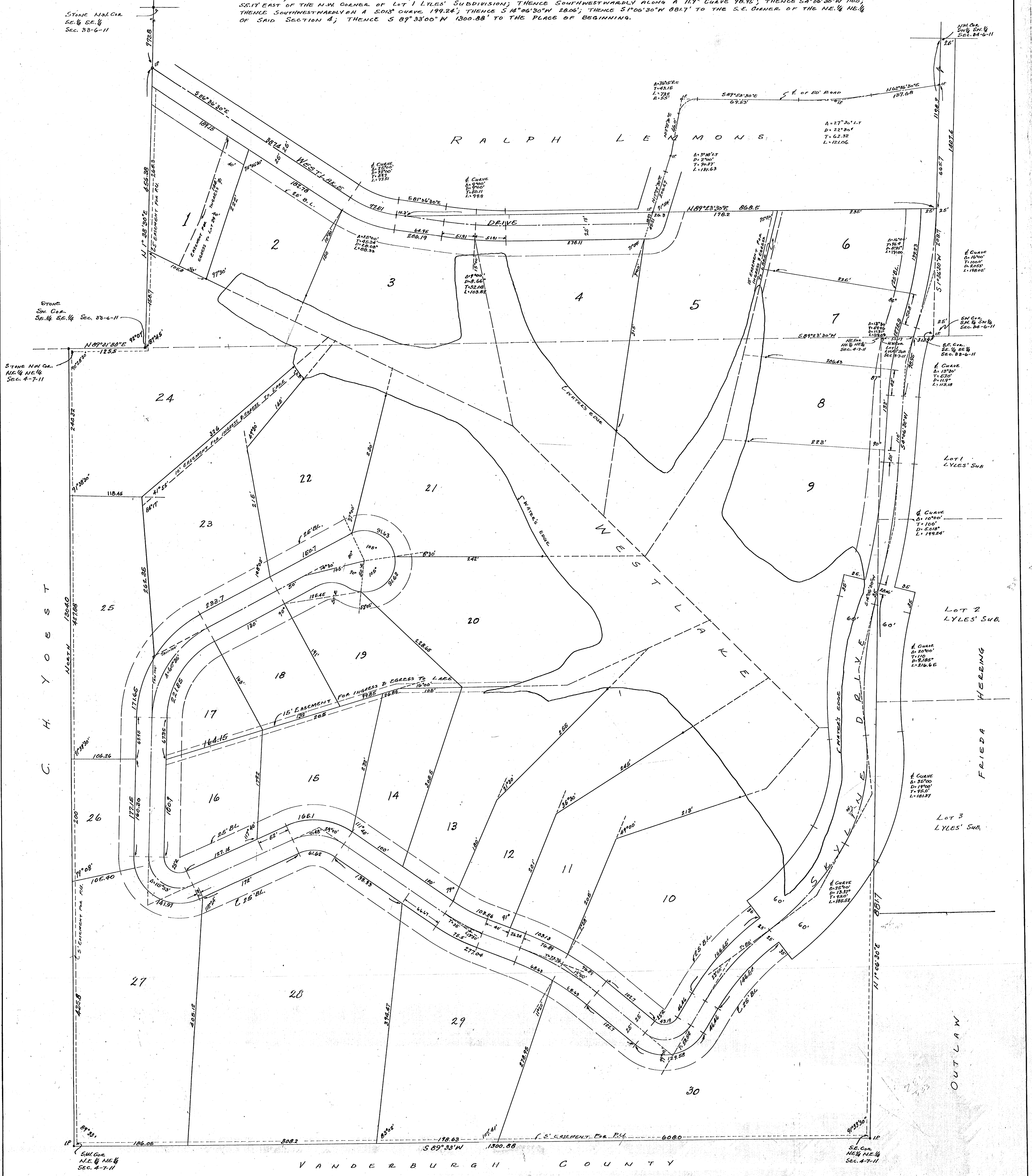

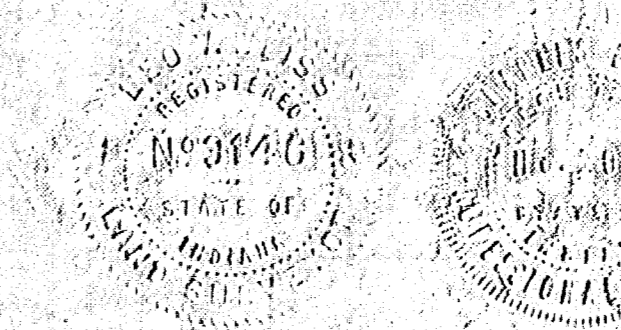
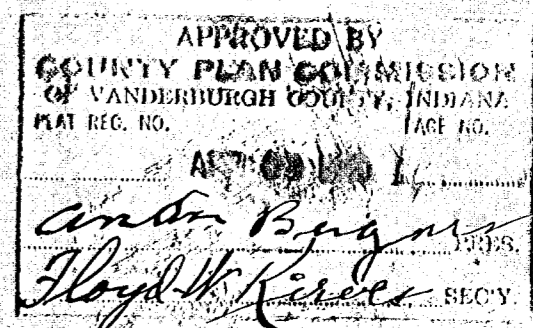

CORNER OF THE SE 1/4 SE 1/4 OF SECTION 33-6-11; THENCE N 1°36'30"E 156.30'; THENCE S 56°36'30"E 337.4' TO A 32' CURVE TO THE LEFT; THENCE SOUTHWESTWARDLY ALONG SAID CURVE 77.51'; THENCE S 81°36'30"E 15.3'; THENCE N 81°23'30"E 86.85' TO A POINT 100.7' N 1°36'30"E OF THE S.E. CORNER THEREOF; THENCE N 1°36'30"E 117.87' TO THE N.W. CORNER OF THE SW 1/4 SE 1/4 OF SECTION 34-6-11; THENCE EAST 25.0'; THENCE S 1°36'30"W 140.26'; THENCE WEST 25.0' TO THE S.W. CORNER OF SAID SECTION 34; THENCE S 81°23'30"W 31.27' TO A POINT 55.17' EAST OF THE N.W. CORNER OF LOT 1 LYLES' SUBDIVISION; THENCE SOUTHWESTWARDLY ALONG A 11.9' CURVE 78.15'; THENCE S 4°06'30"W 100.0'; THENCE SOUTHWESTWARDLY ON A 50.13' CURVE 199.24'; THENCE S 4°06'30"W 28.66'; THENCE S 1°06'30"W 88.17' TO THE S.E.
