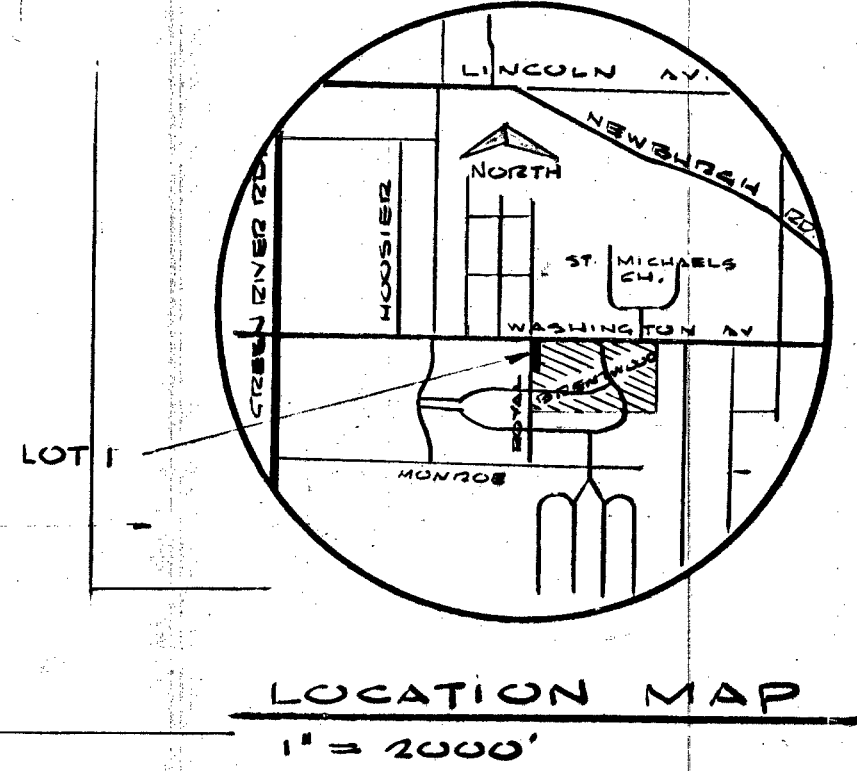
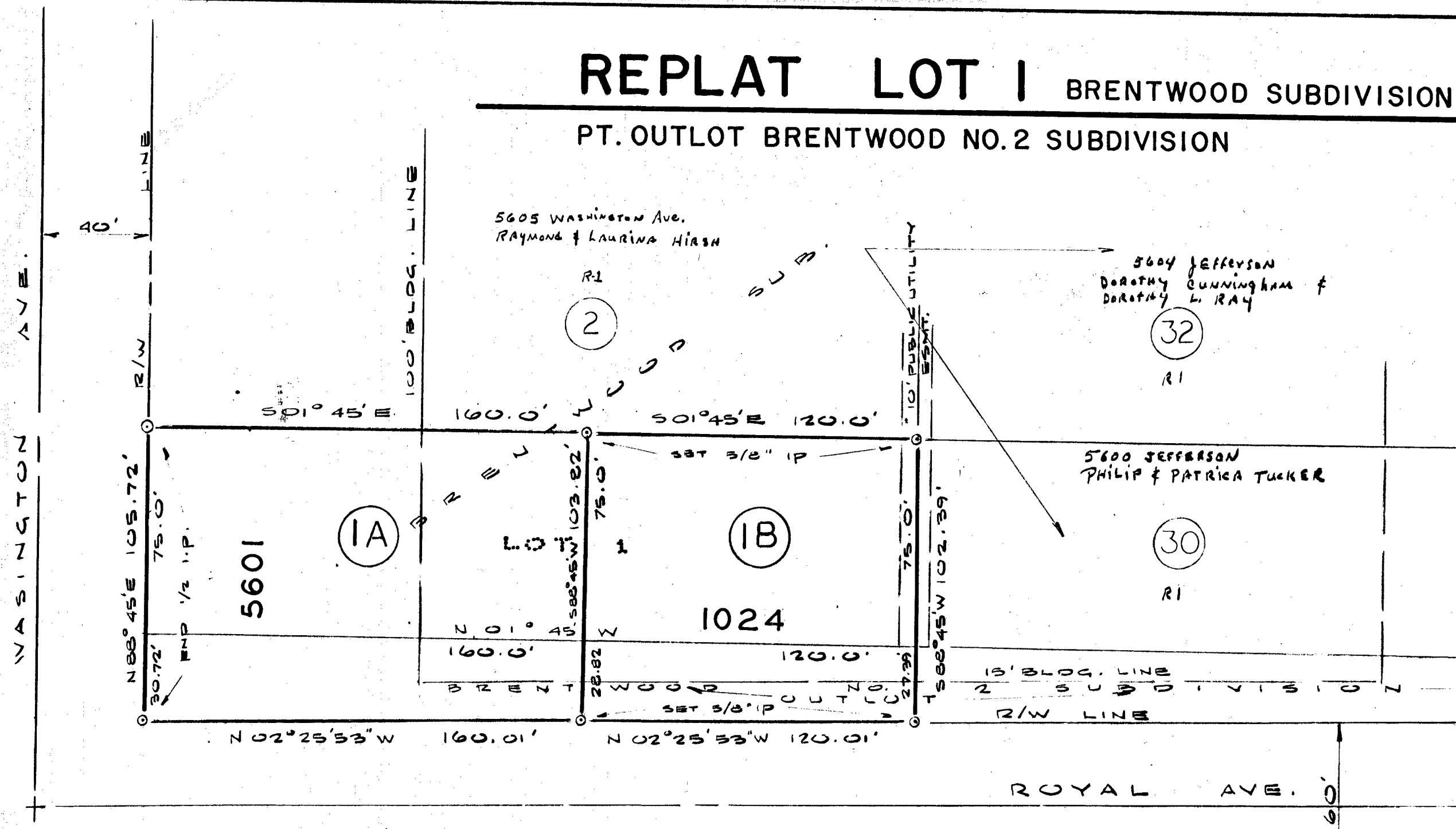
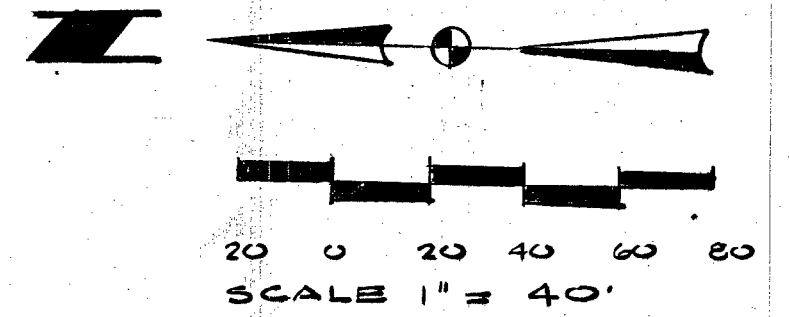

BOUNDARY DESCRIPTION**

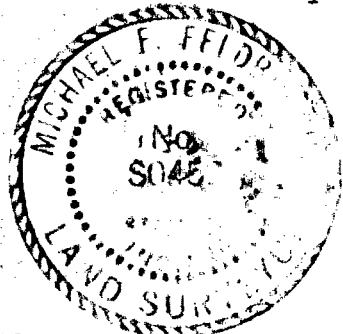
A part of the Northeast Quarter of Section 36, Township 6 South, Range 10 West in Vanderburgh County, Indiana and more particularly described as follows.

Beginning at the Northeast corner of Lot 1 in Brentwood Subdivision the City of Evansville, Vanderburgh County, Indiana according to the recorded plat thereof, at a half inch iron pin as found this survey; thence South 01°45' East a distance of 280.0 feet along the East line of said Lot 1 to a 5/8 inch iron pin as set this survey; thence South 88°45' West along the South line of said Lot 1 distance of 102.39 feet at a 5/8 inch iron pin as set this survey to a point on the East right of way line of Royal Avenue; thence North 02°25'53" West along the West line of the outlot of Brentwood No. 2 Subdivision and the East right of way line of Royal Avenue a distance of 280.02 feet to a half inch iron pin as found this survey located on the North line of said outlot and the South right of way line of Washington Avenue; thence North 88°45' East along the North line of said Lot 1 and the South right of way line of Washington Avenue a distance of 105.72 feet to the place of beginning, containing 0.67 acres more or less.

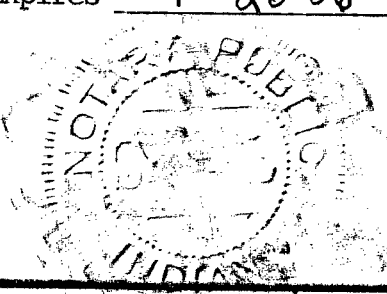
