LEGAL DESCRIPTION

A SUBDIVISION OF PART OF THE NORTHWEST QUARTER OF SECTION 6, TOWNSHIP 6 SOUTH, RANGE 10 WEST IN THE CITY OF EVANSVILLE, VANDERBURGH COUNTY, INDIANA, DESCRIBED AS BEGINNING AT A POINT ON THE NORTH LINE OF SAID QUARTER SECTION 673.42 FEET EAST OF THE NORTHWEST CORNER OF SAID QUARTER SECTION; FROM SAID PLACE OF BEGINNING THENCE SOUTH 00 DEGREES, 39 MINUTES, AND 38 SECONDS EAST FOR 750.16 FEET TO A POINT ON THE NORTH LINE OF THE AMENDED PLAT OF CARRIAGE HILL, SECTION 'B' AS PER PLAT THEREOF RECORDED IN PLAT BOOK 'K', PAGE 97 IN THE OFFICE OF THE RECORDER OF VANDERBURGH COUNTY, INDIANA (SAID POINT LYING 673.42 FEET EAST OF THE WEST LINE OF SAID QUARTER SECTION); THENCE SOUTH 89 DEGREES, 45 MINUTES, 30 SECONDS EAST ALONG THE NORTH LINE OF THE SAID AMENDED PLAT OF CARRIAGE HILL AND THE EXTENSION THEREOF FOR 445.29 FEET TO A POINT WHICH LIES NORTH 89 DEGREES, 45 MINUTES, 30 SECONDS WEST 931.60 FEET FROM THE EAST LINE OF SAID QUARTER SECTION; THENCE NORTH 00 DEGREES, 47 MINUTES, 32 SECONDS WEST FOR 125.43 FEET; THENCE IN A NORTHEASTERLY DIRECTION FOR 83.47 FEET ALONG THE ARC OF A CURVE TO THE LEFT SCRIBED BY A RADIUS OF 79.00 FEET (THE CHORD OF WHICH RUNS NORTH 35 DEGREES, 24 MINUTES, 40 SECONDS EAST FOR 77.43 FEET); THENCE SOUTH 89 DEGREES, 45 MINUTES, 30 SECONDS EAST FOR 118.17 FEET; THENCE NORTH 00 DEGREES, 47 MINUTES, 32 SECONDS WEST FOR 566.77 FEET TO A POINT ON THE NORTH LINE OF SAID QUARTER SECTION WHICH LIES NORTH 89 DEGREES, 45 MINUTES, 30 SECONDS WEST 766.60 FEET FROM THE NORTHEAST CORNER OF SAID QUARTER SECTION; THENCE NORTH 89 DEGREES, 45 MINUTES, 30 SECONDS WEST 257.89 FEET TO A POINT; THENCE SOUTH 89 DEGREES, 45 MINUTES, 30 SECONDS WEST ALONG THE SAID NORTH LINE FOR 350.55 FEET TO THE PLACE OF BEGINNING.

NO STRUCTURES ARE TO BE ERASED OR MAINTAINED ON SAID STRIPS AND OWNERS OF LOTS SHALL TAKE TITLE SUBJECT TO THE RIGHTS OF THE VARIOUS UTILITIES IN SAID STRIPS.

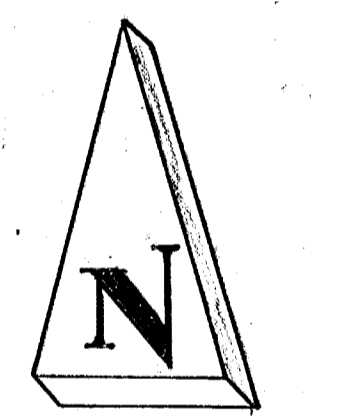
