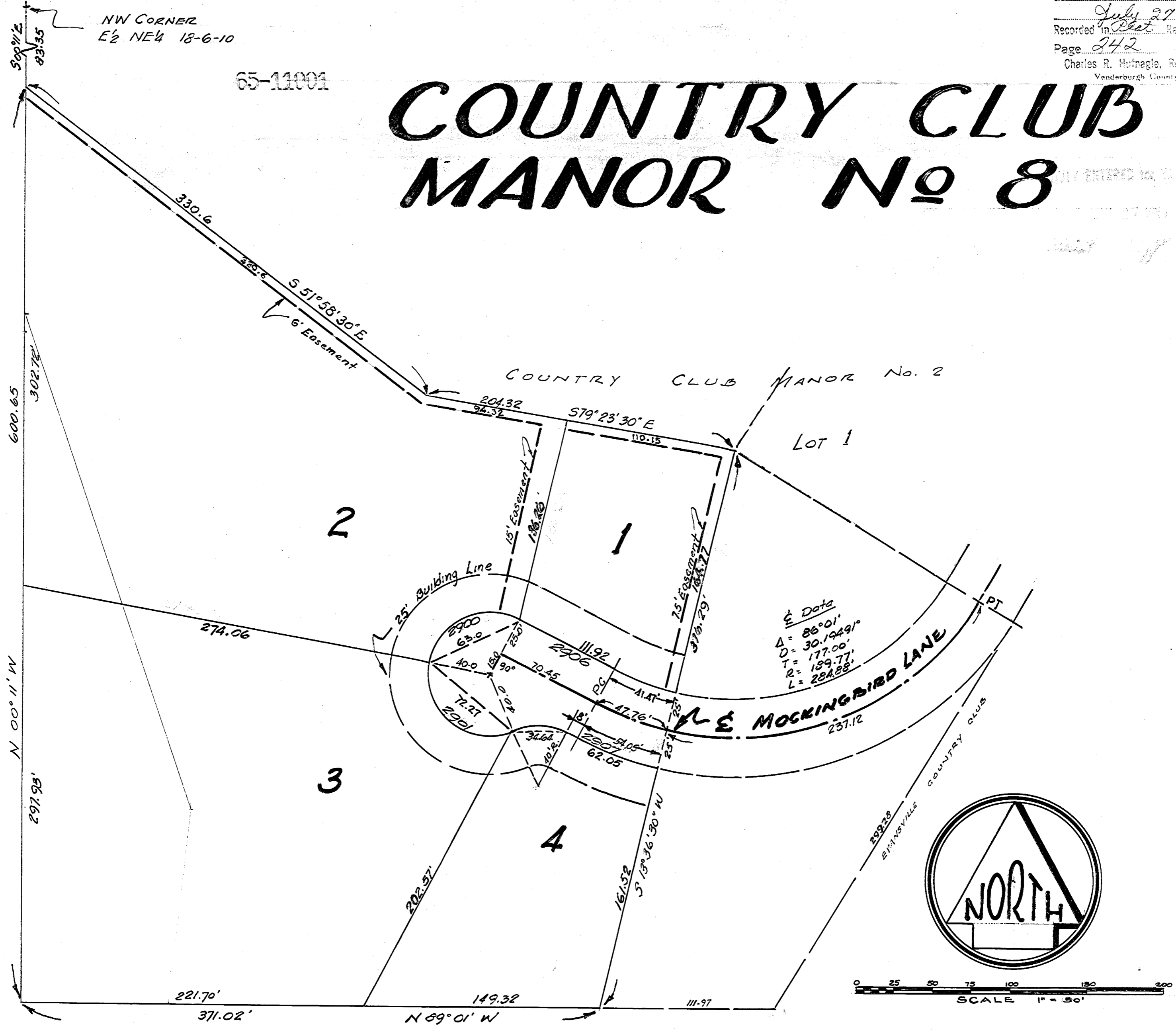

LEGAL DESCRIPTION

Part of the East half of the Northeast quarter of Section 18, Township 6 South, Range 10 West of the Second Principal Meridian and lying in Vanderburgh County, Indiana, and described as follows, to wit:
 Beginning at a point on the West line of said half quarter Section 900'' E a distance of 83.35 feet from the Northwest corner thereof, thence S 51° 58' 30'' E a distance of 330.60 feet, thence S 79° 23' 30'' E a distance of 204.32 feet to the most Westerly corner of Lot 1, Country Club Manor No. 2, thence S 13° 36' 30'' W a distance of 376.29 feet, thence N 89° 01' W a distance of 371.02 feet to a point on the said West line, thence N 00° 11' W along said West line a distance of 660.65 feet to the place of beginning.

OWNER'S CERTIFICATE
