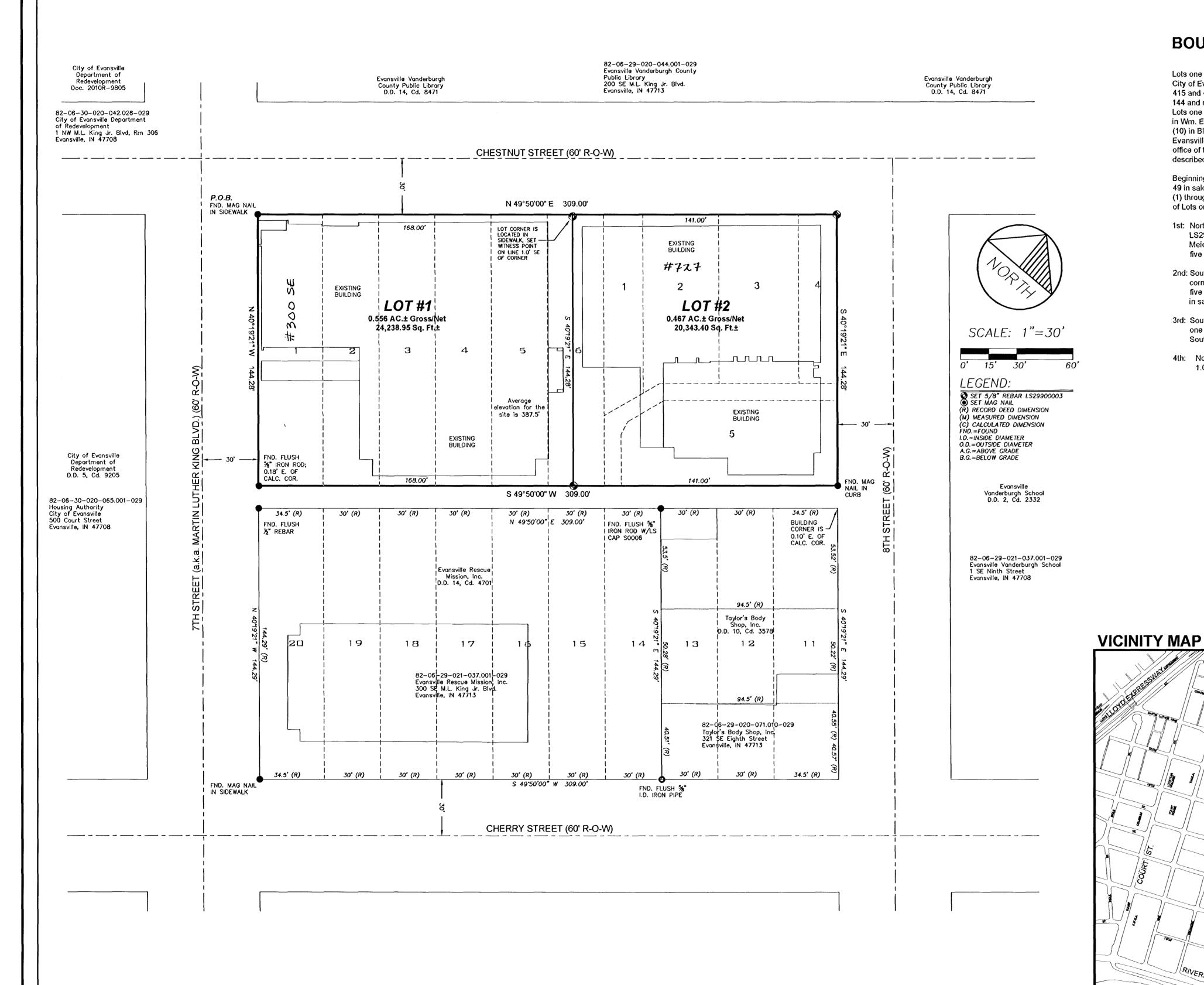

BOUNDARY DESCRIPTION

Lots one (1) through six (6) in Block 49 in the Eastern Enlargement of the City of Evansville, as per plat thereof, recorded in Deed Record "E", pages 415 and 416 and transcribed of record in Plat Book "A", pages 142, 143 and 144 and re-transcribed of record in Plat Book "E", pages 16, 17 and 18; also Lots one (1) through five (5) and all that part of the nine (9) foot private alley in Wm. E. Meier's Subdivision of Lots seven (7), eight (8), nine (9) and ten (10) in Block Forty-nine (49) in the Eastern Enlargement of the City of Evansville, as per plat thereof recorded in Plat Book "F", page 198 in the office of the Recorder of Vanderburgh County, Indiana and being further described as follows: Piacon TWP.

Beginning at a mag nail at the most Westerly corner of Lot one (1) in Block 49 in said Eastern Enlargement; thence along the Northwest line of Lots one (1) through six (6) in Block 49 in said Eastern Enlargement and the North line of Lots one (1) through four (4) in said Wm. E. Meier's Subdivision

- 1st: North 49°50'00" East 309.00 feet to a 5/8 rebar (Donald Gries LS29900003) at the most Northerly corner of Lot four (4) in said Wm. E. Meier's Subdivision; thence along the Northeast line of Lots four (4) and five (5) in said Wm. E. Meier's Subdivision;
- 2nd: South 40°19'21" East 144.28 feet to a mag nail at the most Easterly corner of said Lot five (5); thence along the Southeast line of said Lot five (5) and the Southeast line of Lots one (1) through six (6) in Block 49 in said Eastern Enlargement
- 3rd: South 49°50'00" West 309.00 feet to the most Southerly corner of Lot one (1) in Block 49 in said Eastern Enlargement; thence along the Southwest line of said Lot one (1)
- 4th: North 40°19'21" West 144.28 feet to the point of beginning, containing 1.023 acres more or less.

- 3. FLOOD PLAIN DATA: No portion of this property lies within the Special Flood Hazard Area Zone "A" as plotted by scale on the Flood Insurance Rate Map (FIRM) 18163 C 0177 D, Community Panel 180257 dated

4. TEMPORARY EROSION CONTROL (during construction): Slopes 0% to 6% shall be mulched and seeded, i.e. rye, red top, or wheat, within 45 days of disturbance of soil, which must remain in place until final grading and shaping. Slopes of more than 6% shall be mulched and seeded and shall have silt fence, straw bales and/or erosion blankets in place within 5 days of disturbance of soil which must remain in place until final grading and seeding. Developer is responsible for submitting an erosion control plan with the necessary state and local agencies if more than one acre of ground is to be disturbed during construction.

5. SITE CONDITIONS: No obstructions shall be placed within the natural watercourse on this site.

6. Retracement Survey: The subject property was survey by this firm in 2006 and is recorded as Document Number 2006R-10353 in the office of the Recorder of Vanderburgh County.
