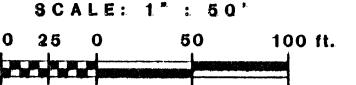

GENERAL NOTES

Zoning: The subject property and all abutting property is currently zoned agricultural (Ag.).

Flood Plain Data: Per F.I.R.M. Vanderburgh County, Indiana, Panel No. 180256 0075 B dated March 19, 1982, none of the proposed subdivision is within the designated 100 year flood zone.

Utilities: Water and sanitary sewer services are available at the site.

Road Grades: Maximum road grade will not exceed 10%.

Minimum First Floor Elevation: First floor grades shall be a minimum of 1'-4" above the top of the curb if the lawn drains across the curb, or 1'-2" above the high point of a drainage swale around the house.

Temporary Erosion Control: (during construction)

R/W German Pines Drive

Slopes of 0%-6% shall be mulched and seeded with a cover crop, i.e., $\Delta = 35d13'28''$ rye, red top, or wheat, within 45 days of disturbance of soil and must remain in place until final grading and shaping.

•Slopes of more than 6% shall be mulched and seeded and shall have straw bales and/or erosion blankets in place within 45 days of disturbance of soil and must remain in place until final grading and

Erosion Control for Ditches:

•Slopes of 0%-2% shall be mulched and seeded within 45 days of

•Slopes of 2%-8% shall be sodded or stabilized with an erosion control mat at completion of ditch grading.

•Slopes over 8% require riprap or other approved stabilization at completion of ditch grading if the total ditch length at that point is greater than 100 feet.

Part of the Northwest Quarter of the Southeast Quarter of Section 13, Township 5 South, Range 11 West, in Vanderburgh County, Indiana, more particularly described as follows:

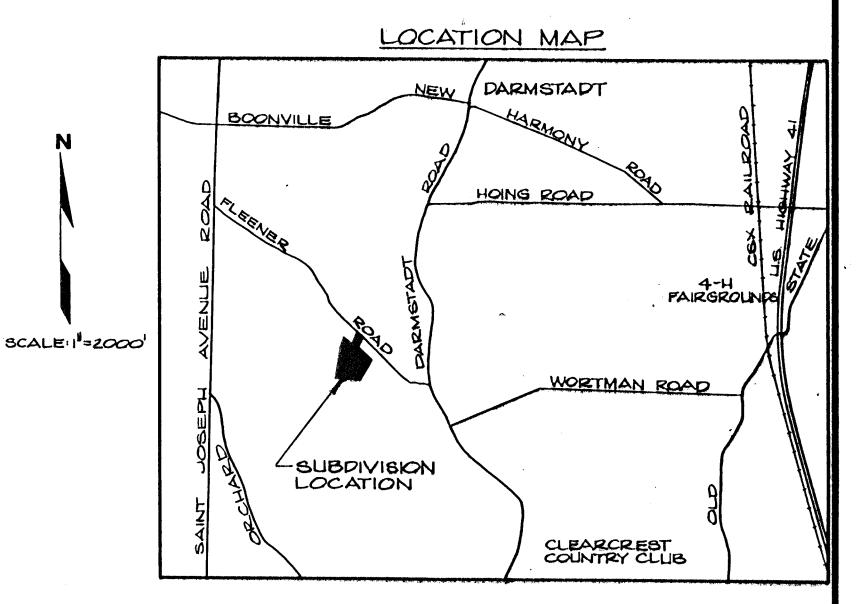
Beginning at the southwest corner of said quarter quarter section; thence north 00 degrees 01 minutes 01 seconds east (assumed bearing) along the west line of said quarter quarter section a distance of 527.81 feet; thence north 19 degrees 39 minutes 24 seconds east a distance of 332.75 feet; thence south 51 degrees 58 minutes 04 seconds east a distance of 241.57 feet; thence north 19 degrees 39 minutes 24 seconds east a distance of 367.75 feet to a point in the centerline of Fleener Road; thence south 51 degrees 58 minutes 17 seconds east along said centerline a distance of 125.46 feet; thence south 45 degrees 33 minutes 10 seconds east along said centerline a distance of 81.02 feet; thence south 33 degrees 11 minutes 16 seconds west a distance of 300.00 feet; thence south 45 degrees 52 minutes 32 seconds east a distance of 150.00 feet; thence south 46 degrees 42 minutes 37 seconds east a distance of 175.00 feet; thence south 43 degrees 48 minutes 45 seconds east a distance of 100.00 feet; thence south 33 degrees 10 minutes 29 seconds west a distance of 422.45 feet to a point on the south line of said quarter quarter section; thence south 89 degrees 36 minutes 22 seconds west a distance of 491.65 feet to the true point of beginning, containing 10.70 acres.
