LEGAL DESCRIPTION

A subdivision in part of the Southwest Quarter of section five (5), Township six (6) South, Range ten (10) West in the city of Elmsville, Vanderburgh County, Indiana more particularly described as follows:
Beginning at a point in Christ Road which point is located by commencing at the southwest corner of said quarter section and measuring East along the south line thereof for 31.53 chains (2080.38 feet); thence North 00 degrees, 24 minutes, and 55 seconds West for 24.11 chains (1501.26 feet) to the center of Christ Road; thence West along the center of Christ Road for 386.0 feet to the place of beginning; from said place of beginning thence South 00 degrees, 24 minutes, and 55 seconds East for 318.21 feet to point which lies North 00 degrees, 24 minutes, and 55 seconds West a distance of 52.69 feet from the center of a Southern Indiana Gas and Electric Company transmission line; thence North 72 degrees, 01 minutes, and 55 seconds West parallel to and 50 feet (measured at right angles) from the center of said transmission line for 313.68 feet; thence South 83 degrees, 24 minutes, and 55 seconds West parallel to and 50.00 feet (measured at right angles) from the center of said transmission line for 325.59 feet to a point which lies 330.00 feet East of the East right-of-way line of Stringtown Road; thence North 00 degrees, 14 minutes, and 45 seconds East, parallel to Stringtown Road for 234.77 feet to a point in the center of Christ Road; thence East along the center of Christ Road for 620.57 feet to the place of beginning.

Owner's Certificate

The undersigned owner of the real estate shown and described above does hereby, as shown, plat and subdivide said real estate and designates the same as "GREENHILL" streets within the plat are dedicated to the public. Building setback lines are established as shown on the plat. Between which lines and the property lines of the street there shall not be erected or maintained any buildings or structures. Strips of ground of the widths as shown on the plat and marked "P.U. EASEMENTS" are reserved for the use of public utilities for the installation of water, sewer, or gas mains, poles, ducts, lines, and wires and subject at all times to the proper authorities and to the easements hereon reserved. No structures are to be erected or maintained on said strips and owners of lots shall take title subject to the rights of the various utilities in said strips.

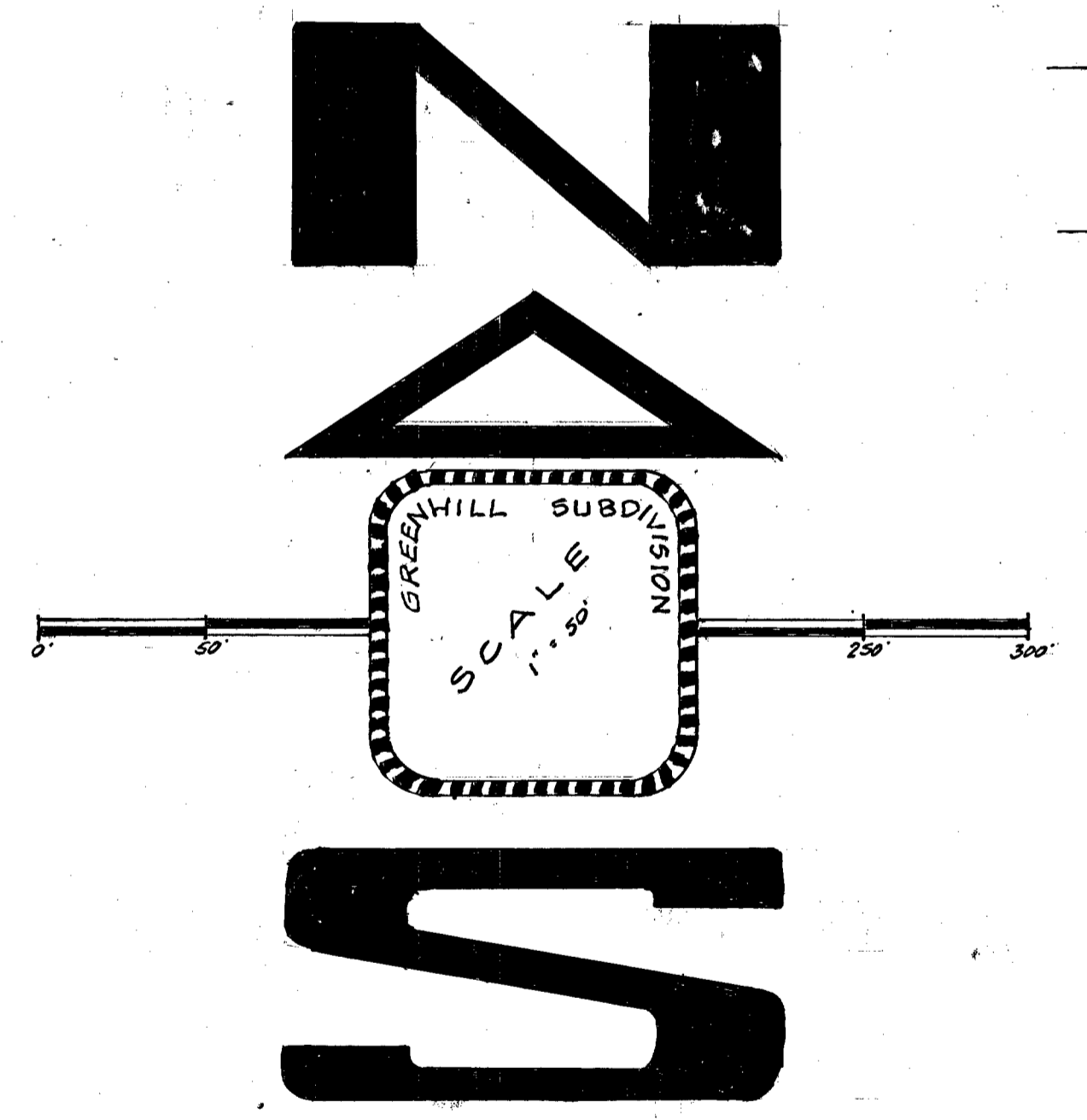
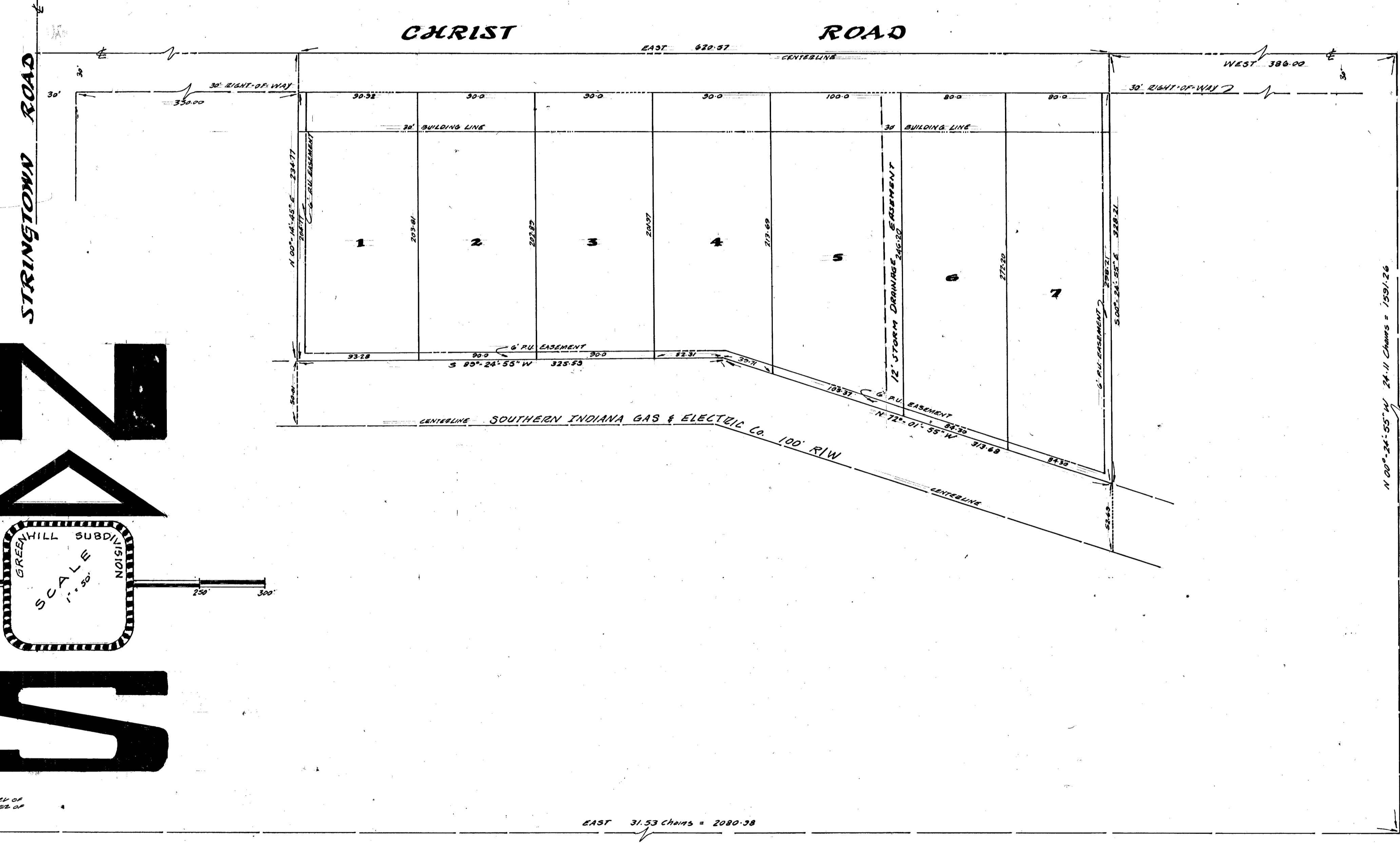

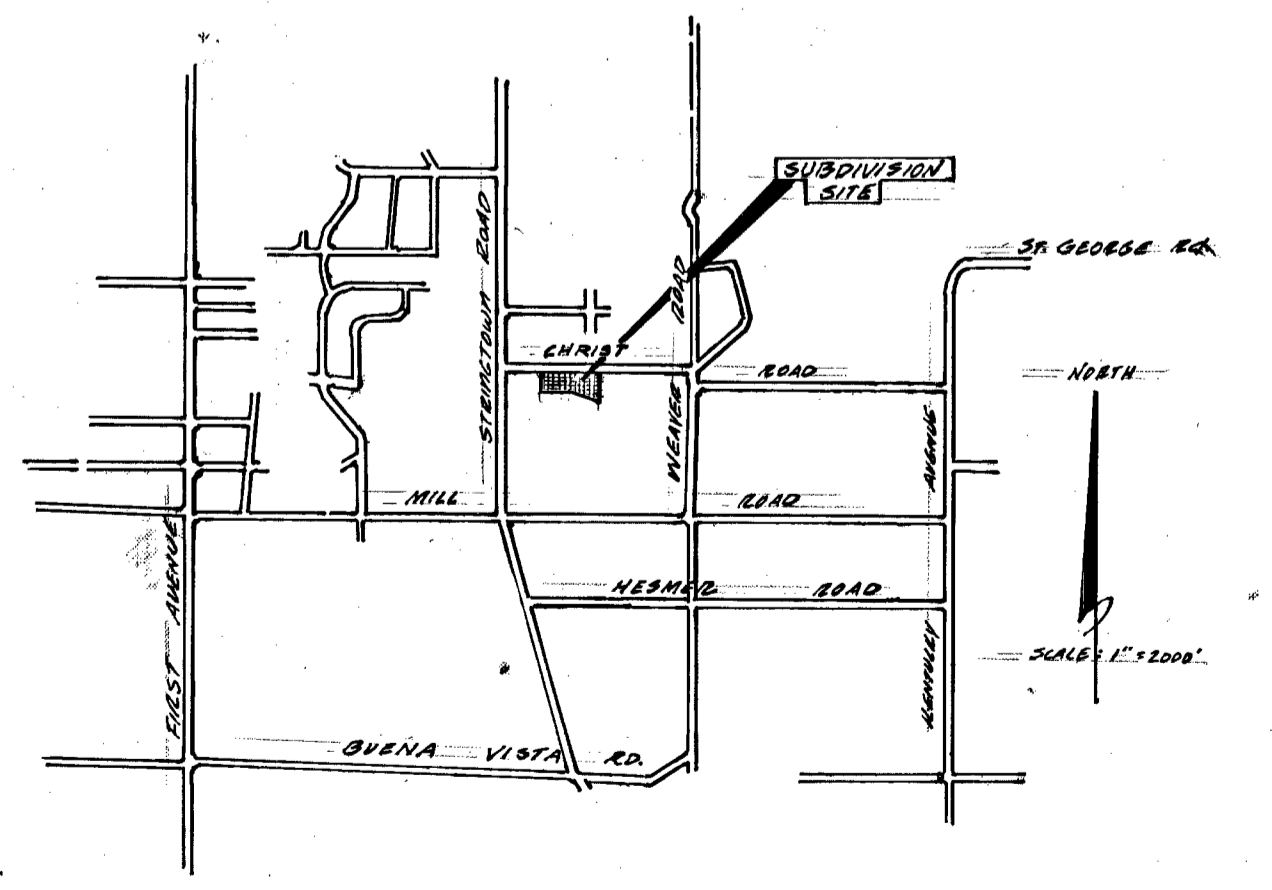
