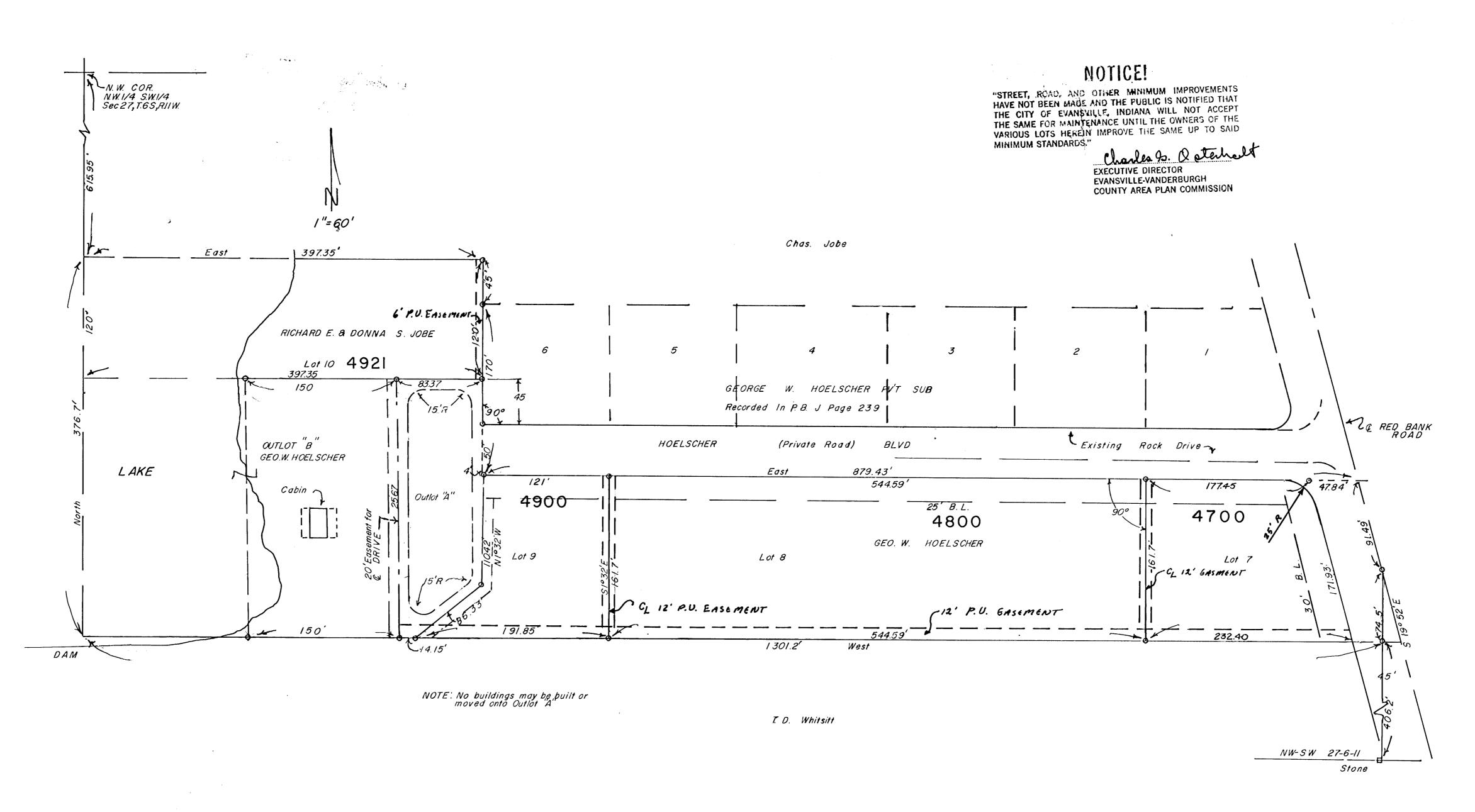

## GEORGE W. HOELSCHER PRIVATE SUBDIVISION NO. 2

Part of the Northwest Quarter of the Southwest Quarter of Section 27, Township 6 South, Range II West, Vanderburgh County, Indiana, described as follows: Beginning at a point on the West line of said Quarter Section 615.95 feet South of the Northwest corner thereof; thence East a distance of 397.35 feet to the West line of Lot 6 in George W. Hoelschers private subdivision as recorded in Plat Record & page 239 in the Office of the Recorder of Vanderburgh County; thence South along the West line of Lot 6 to a point 50 feet South of the Southwest corner thereof; thence East along the South line of Hoelscher Blvd. 879.43 feet to the center of Red Bank Road; thence South 19 degrees 52 minutes East along said centerline 91.49 feet to the East line of the Northwest Quarter, Southwest Quarter of said Section 27, thence South 74.5 feet to a point 406.2 feet North of the Southeast corner thereof; thence West a distance of 1301.2 feet to the West line thereof; thence North along said West line 376.7 feet to the place of beginning



We the undersigned, owners of the real estate shown and described here on do hereby as shown plat and subdivide said real estate and designate same as George W. Hoelscher Private Subdivision No. 2 All streets within the plat are dedicated to the public. Building setback lines are established as shown on the plat between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plat and marked "P.U" Easement" are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easements hereon reserved. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities in said strips of ground.
