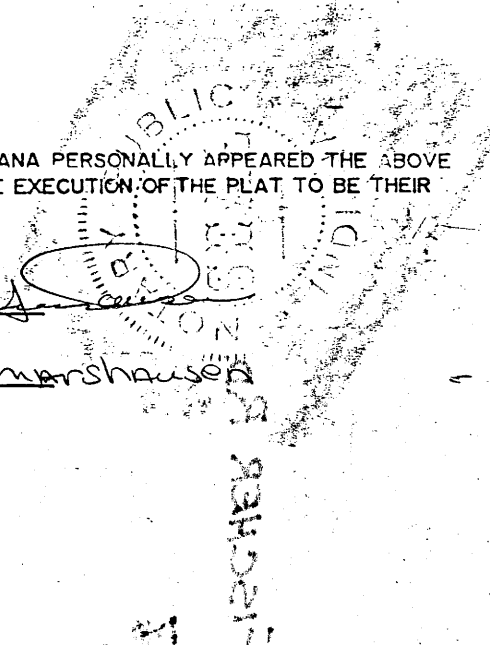

**RE: Zirkelbach/Orchard Road Address Issue**

Dear Sirs/Madam:

I would like to take the opportunity to thank each of you for speaking with me about the address problem for the Zirkelbach families on Orchard Road. As we mentioned, for some unknown reason, their mail recently got re-routed to a "Fischer Road" address to which they objected. I wanted to take this opportunity to send a letter documenting our efforts to correct this problem and to confirm that we are all on the same page with respect to the Zirkelbach addresses.

According to the Zirkelbachs, in particular Mark Zirkelbach of 3441 Orchard Road, his address is and should remain 3441 Orchard Road. We contacted each of your offices to determine how or why it seemed there was an attempt for his and his relatives addresses to be changed since he began receiving mail at a Fischer Road address. We were never able to

uncover the source of any address change attempt and it appears all government agencies are now in agreement that his address is 3441 Orchard Road and not an address on Fischer Road.


Further, the post office cannot identify any source for an address change having occurred and their official records will now indicate Mr. Zirkelbach's address as 3441 Orchard Road and his neighboring Zirkelbach relatives also on Orchard Road and not Fischer Road. This will confirm that the following offices or agencies are in agreement and/or the official records of such offices show the Orchard Road address for the Zirkelbachs:

1. GIS Map Service;
2. Area Plan Commission;
3. Central Dispatch;
4. Telephone company;
5. Assessor's Office; and
6. Post Office.

Thank you all again for your assistance with this matter. Please contact us if there are any further problems or if any indications are made to your offices that there is an attempt to change the Orchard Road address so that we may address the problem. Thank you in advance.
