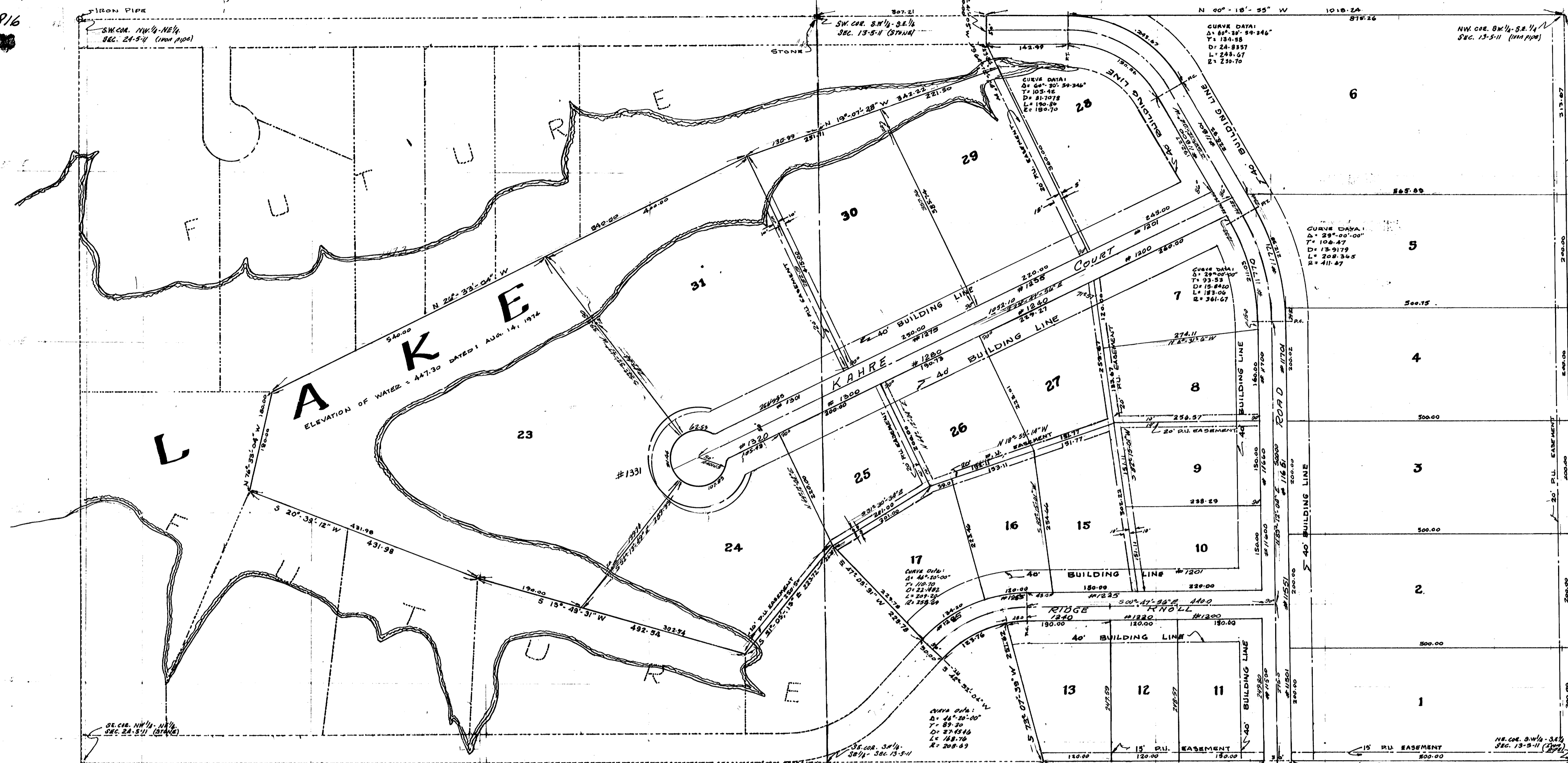

# AMENDED PLAT KAHRE LAKE SUBDIVISION

## LEGAL DESCRIPTION

A SUBDIVISION OF PART OF THE SOUTHWEST QUARTER OF SECTION 13 TOWNSHIP 5 RANGE 11 WEST AND PART OF THE NORTHWEST QUARTER OF SECTION 24 TOWNSHIP 5 RANGE 11 WEST MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 13 TOWNSHIP 5 RANGE 11 WEST; FROM SAID PLACE OF BEGINNING; THENCE SOUTH 04 DEGREES 19 MINUTES 52 SECONDS EAST ALONG THE EAST LINE OF SAID QUARTER SECTION FOR 300.00 FEET; THENCE NORTH 89 DEGREES 12 MINUTES 04 SECONDS EAST FOR 416.87 FEET; THENCE NORTH 73 DEGREES 16 MINUTES 54 SECONDS EAST FOR 430.18 FEET TO A POINT IN THE CENTERLINE OF THE DARMSTADT ROAD; THENCE ALONG THE CENTER OF SAID ROAD SOUTH 27 DEGREES 31 MINUTES 04 SECONDS EAST FOR 30.9 FEET; THENCE SOUTH 73 DEGREES 16 MINUTES 54 SECONDS WEST FOR 46.72 FEET; THENCE SOUTH 89 DEGREES 12 MINUTES 04 SECONDS WEST FOR 416.87 FEET TO A POINT ON THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 13 TOWNSHIP 5 RANGE 11 WEST; THENCE SOUTH 00 DEGREES 19 MINUTES 52 SECONDS EAST FOR 390.00 FEET TO A POINT WHICH LAYS 10 DEGREES 19 MINUTES 52 SECONDS WEST FOR 392.54 FEET OF THE SOUTHWEST CORNER OF SOUTHWEST QUARTER OF SECTION 13 TOWNSHIP 5 RANGE 11 WEST; THENCE SOUTH 73 DEGREES 07 MINUTES 39 SECONDS FOR 251.62 FEET; THENCE ALONG THE ARC OF A 27.4546 DEGREE OF CURVE TO THE LEFT FOR 123.76 FEET; THENCE SOUTH 42 DEGREES 52 MINUTES 04 SECONDS WEST FOR 50.00 FEET; THENCE SOUTH 47 DEGREES 05 MINUTES 31 SECONDS WEST FOR 229.78 FEET; THENCE SOUTH 51 DEGREES 05 MINUTES 15 SECONDS EAST FOR 26.78 FEET TO A POINT ON THE LINE DIVIDING SAID SECTION; THENCE PROCEEDING INTO SAID SECTION 24 TOWNSHIP 5 RANGE 11 WEST SOUTH 51 DEGREES 05 MINUTES 15 SECONDS EAST FOR 223.72 FEET; THENCE SOUTH 15 DEGREES 49 MINUTES 31 SECONDS WEST FOR 492.54 FEET; THENCE SOUTH 20 DEGREES 39 MINUTES 12 SECONDS WEST FOR 431.98 FEET; THENCE NORTH 74 DEGREES 14 MINUTES 04 SECONDS WEST FOR 180.00 FEET; THENCE NORTH 24 DEGREES 33 MINUTES 04 SECONDS WEST FOR 940.00 FEET; THENCE NORTH 19 DEGREES 07 MINUTES 28 SECONDS WEST FOR 130.99 FEET TO A POINT ON THE LINE DIVIDING SAID SECTION; THENCE PROCEEDING BACK INTO SAID SECTION 13 NORTH 19 DEGREES 07 MINUTES 28 SECONDS WEST FOR 342.22 FEET; THENCE SOUTH 64 DEGREES 12 MINUTES 04 SECONDS WEST FOR 48.84 FEET; THENCE SOUTH 89 DEGREES 11 MINUTES 45 SECONDS WEST FOR 50.00 FEET TO A POINT ON THE WEST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 13 WHICH LAYS 10 DEGREES 19 MINUTES 52 SECONDS WEST A DISTANCE OF 307.21 FEET FROM SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 13; THENCE NORTH 00 DEGREES 18 MINUTES 52 SECONDS WEST ALONG THE WEST LINE OF SAID QUARTER SECTION FOR 320.00 FEET; THENCE SOUTH 12 DEGREES 04 SECONDS EAST ALONG THE NORTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 13 TOWNSHIP 5 RANGE 11 WEST FOR 1012.87 FEET TO THE NORTHEAST CORNER THEREOF BEING THE PLACE OF BEGINNING.

## OWNER'S CERTIFICATE

NO STRUCTURES SHALL BE EXERCISED OR MAINTAINED ON SAID STRIPS OF LAND AND OWNERS SHALL TAKE TITLE SUBJECT TO THE RIGHTS OF THE PUBLIC UTILITIES IN THOSE STRIPS OF LAND.
