

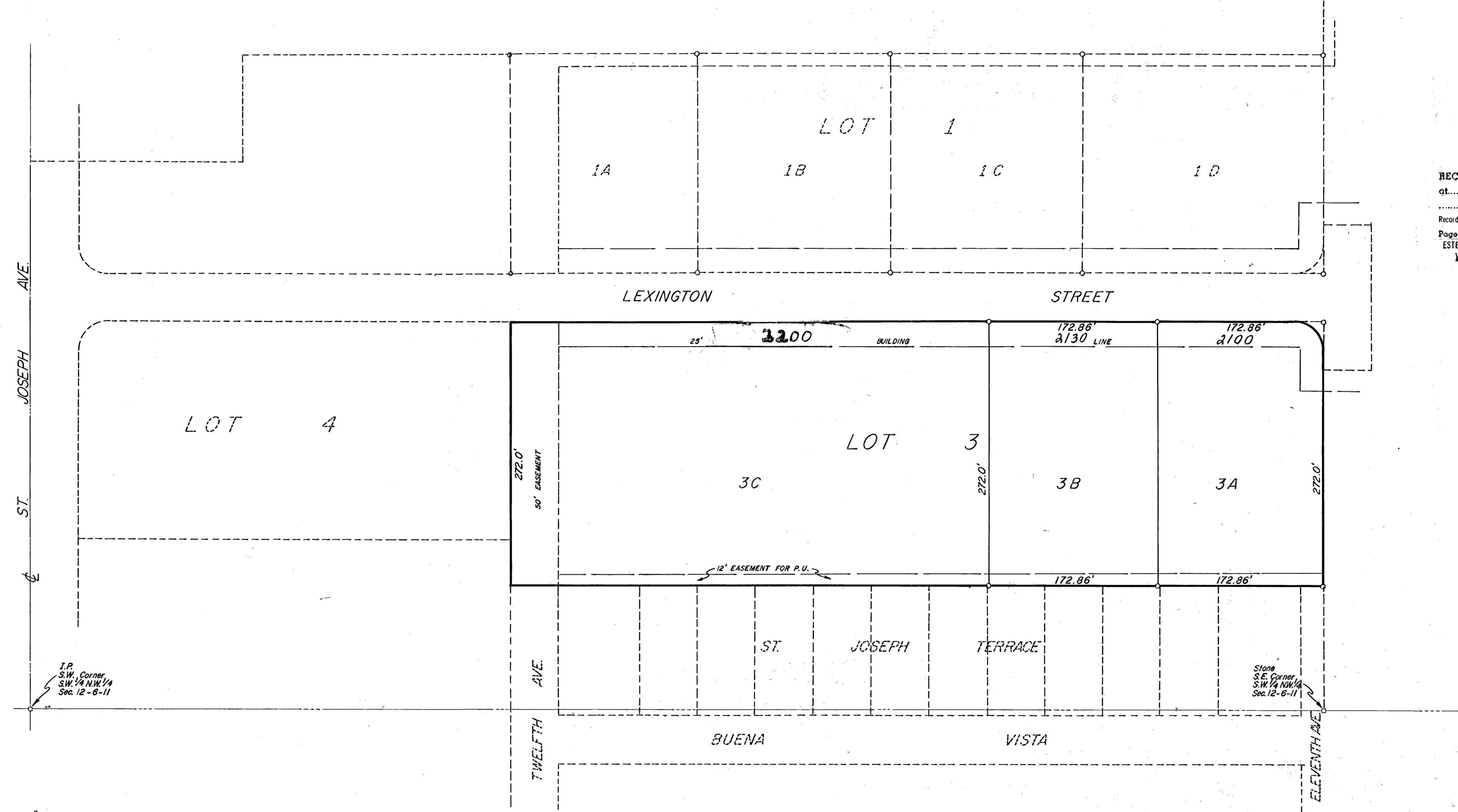
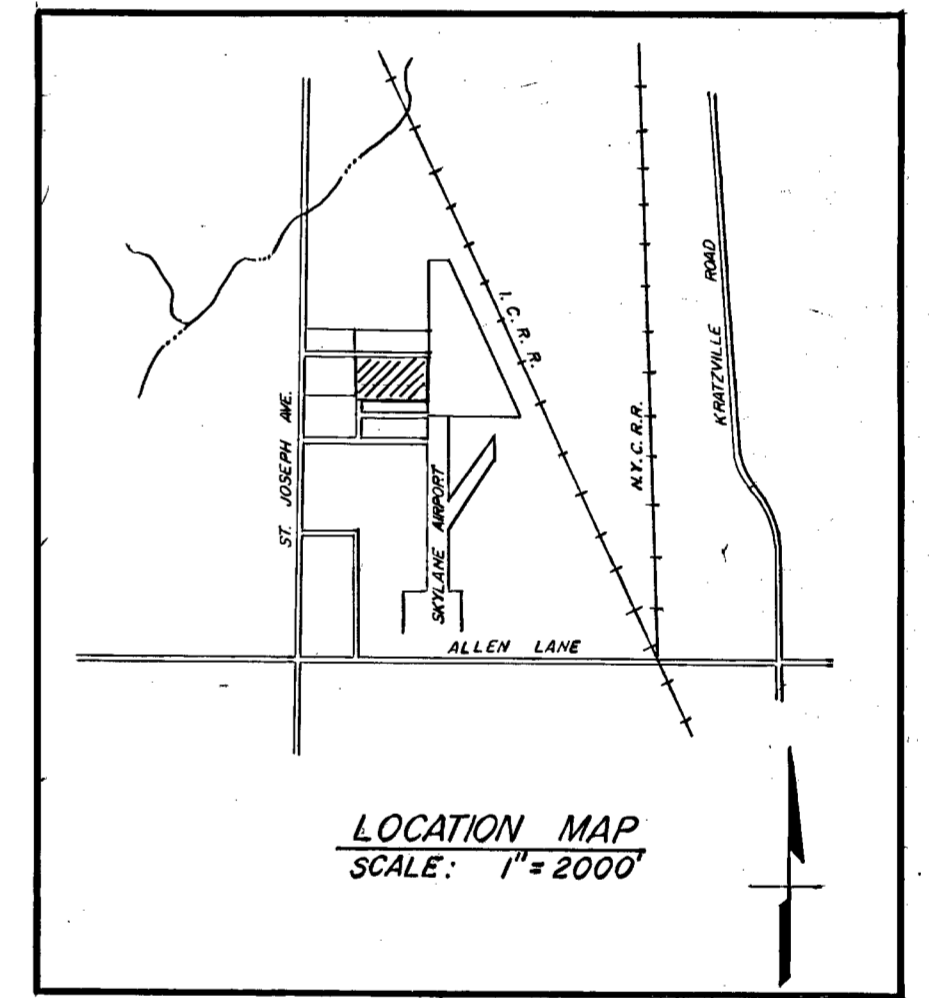
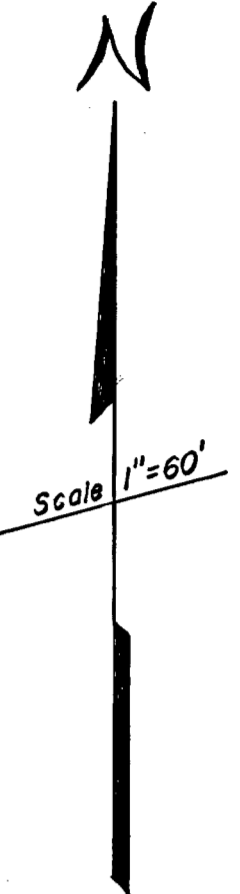

We the undersigned, owner of the real estate shown and described here on do hereby as shown plat and subdivide said real estate and designate same as REPLAT OF LOT 3, KAUAI INDUSTRIAL PARK.
