

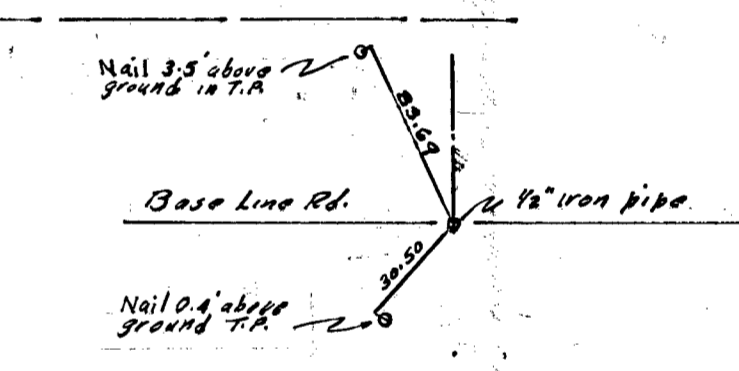
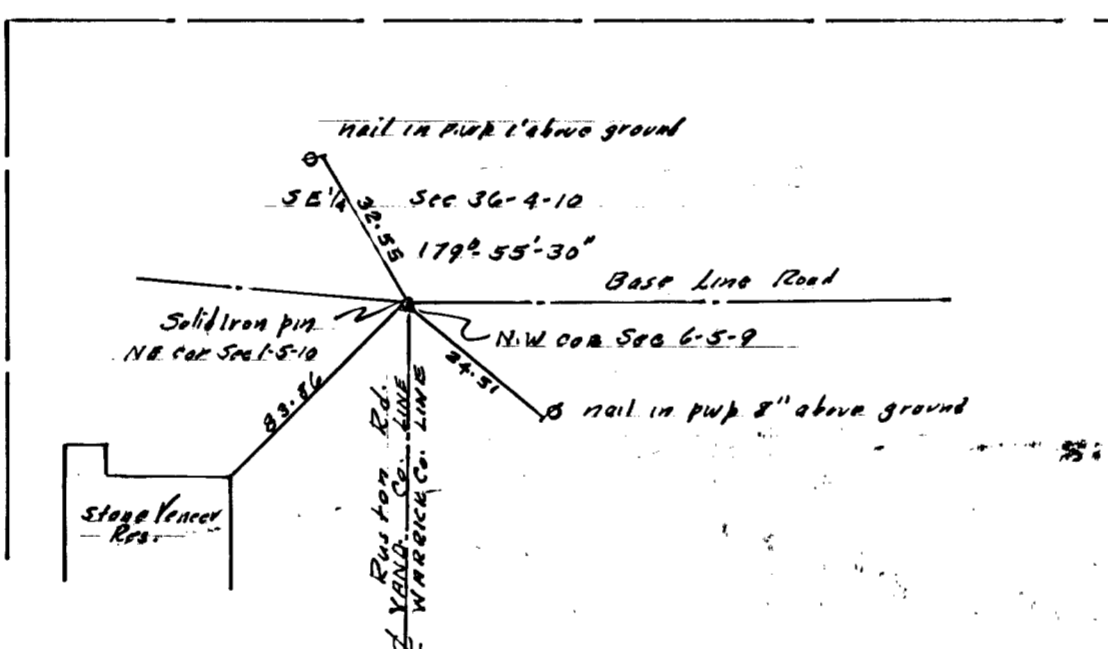
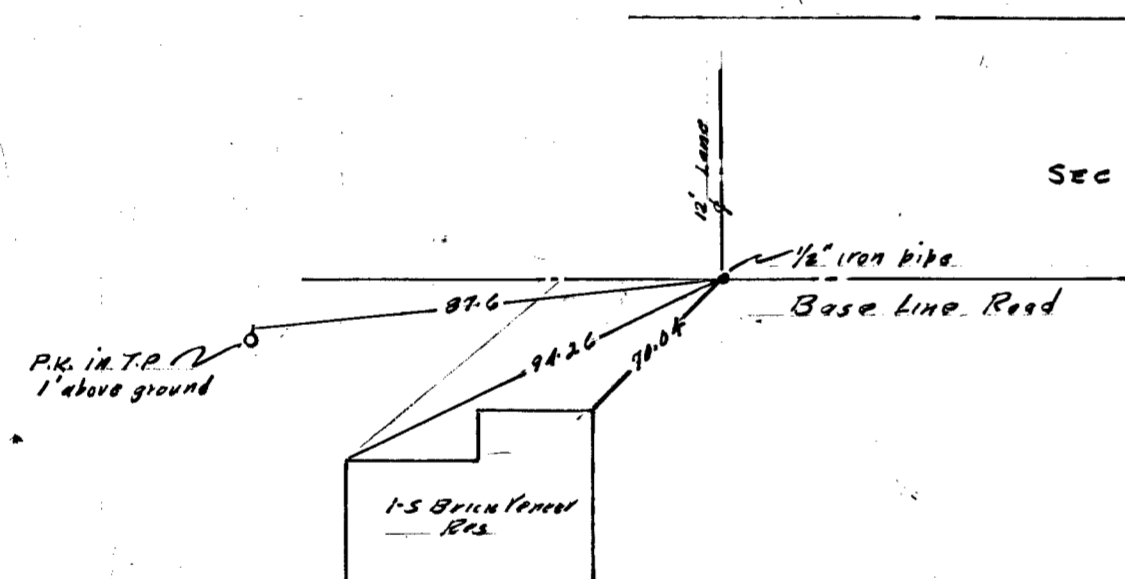
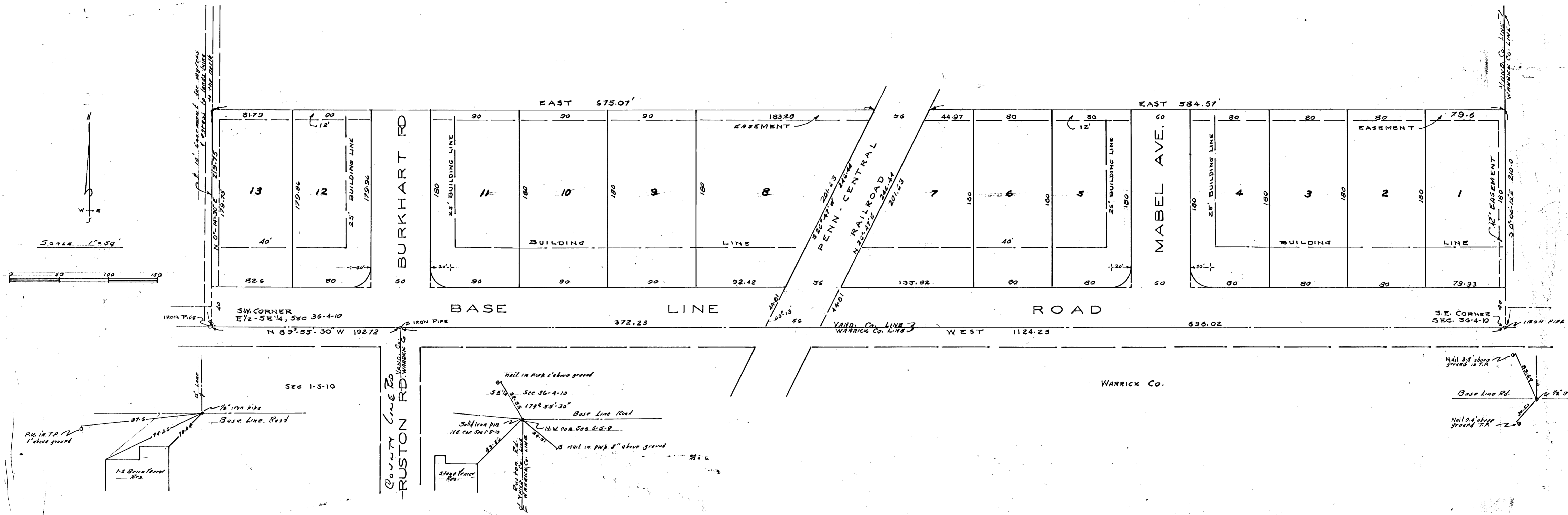
MABEL - PLACE

A Subdivision of part of the East half of the Southeast Quarter of Section 36, Township 4 South, Range 10 West in Vanderburgh County, Indiana, described as follows: Beginning at the Southeast corner of said half quarter section thence West along the South line thereof for 1124.25 feet to the Northeast corner of Section 1, Township 3 South, Range 10 West; thence N 89° 55' 30" W along the south line of said half quarter section for 192.72 feet to the Southwest corner of said half quarter section; thence N 0° 14' 30" E along the west line of said half quarter section for 219.75 feet; thence East for 675.07 feet to a point on the westerly right-of-way line of the Penn-Central Railroad (formerly the Evansville and Indianapolis Railroad); thence S 26° 47' W along the said right-of-way line for 246.44 feet to a point on the south line of said half quarter section; thence East along the said south line for 56 feet to a point on the easterly right-of-way line of the Penn-Central Railroad; thence N 26° 47' E along said right-of-way line for 246.44 feet; thence East for 584.37 feet to a point on the East line of said half quarter section; thence S 0° 05' 12" E along the said east line for 220.0 feet to the place of beginning.

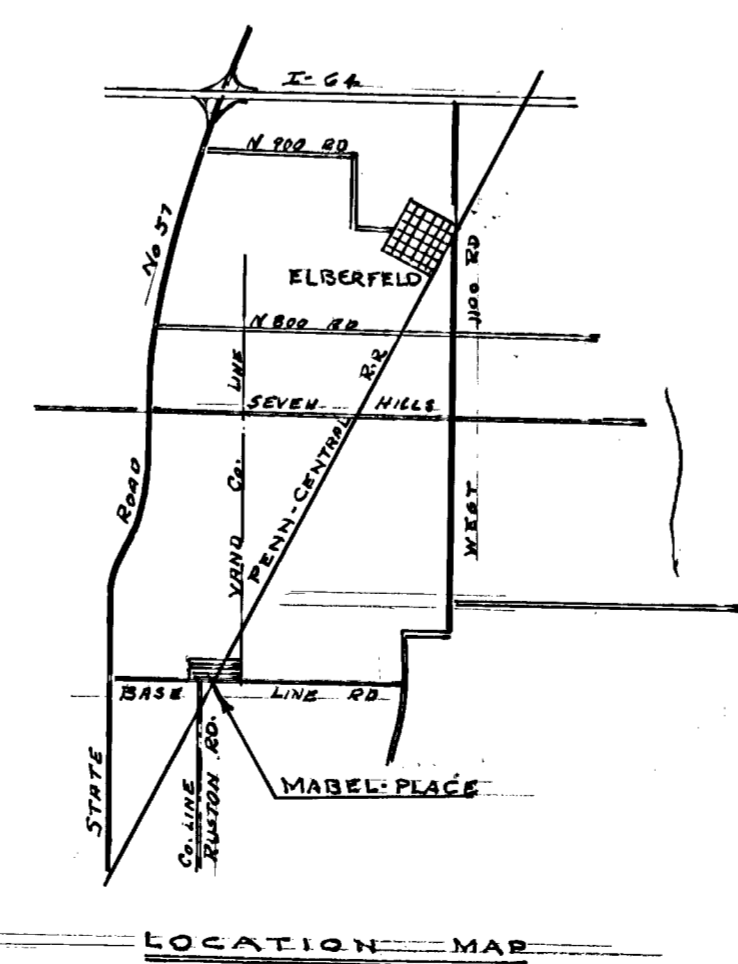
