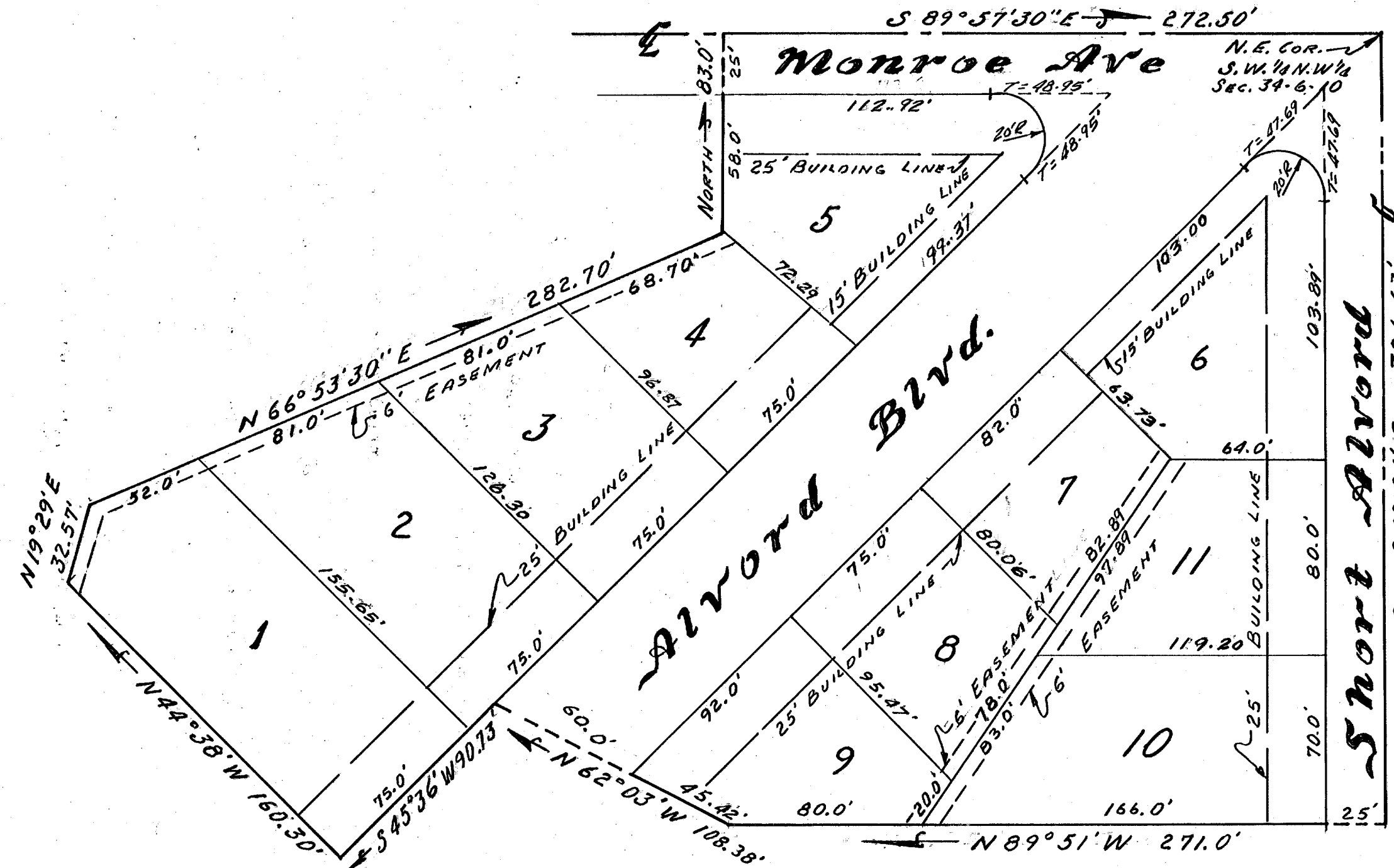

A SUBDIVISION OF PART OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION THIRTY FOUR (34), TOWNSHIP SIX (6) SOUTH, RANGE TEN (10) WEST IN VANDERBURGH COUNTY, INDIANA AND MORE PARTICULAR DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION; THENCE SOUTH ZERO (0) DEGREES SIX (06) MINUTES EAST ALONG THE EAST LINE THEREOF A DISTANCE OF THREE HUNDRED TWENTY SIX AND SIXTY THREE HUNDREDS (326.63) FEET; THENCE NORTH EIGHTY NINE (89) DEGREES FIFTY ONE (51) MINUTES WEST A DISTANCE OF TWO HUNDRED SEVENTY ONE (271.0) FEET; THENCE NORTH SIXTY TWO (62) DEGREES THREE (03) MINUTES WEST A DISTANCE OF ONE HUNDRED EIGHT AND THIRTY EIGHT HUNDREDS (108.38) FEET; THENCE SOUTH FORTY FIVE (45) DEGREES THIRTY SIX (36) MINUTES WEST A DISTANCE OF NINETY AND SEVENTY THREE HUNDREDS (90.73) FEET; THENCE NORTH FORTY FOUR (44) DEGREES THIRTY EIGHT (38) MINUTES WEST A DISTANCE OF ONE HUNDRED SIXTY AND THIRTY HUNDREDS (160.30) FEET; THENCE NORTH NINETEEN (19) DEGREES TWENTY NINE (29) MINUTES EAST A DISTANCE OF THIRTY TWO AND FIFTY SEVEN HUNDREDS (32.57) FEET; THENCE NORTH SIXTY SIX (66) DEGREES FIFTY THREE (53) MINUTES THIRTY (30) SECONDS EAST A DISTANCE OF TWO HUNDRED EIGHTY TWO AND SEVENTY HUNDREDS (282.70) FEET; THENCE NORTH EIGHTY THREE (83) FEET TO A POINT ON THE NORTH LINE THEREOF; THENCE SOUTH EIGHTY NINE (89) DEGREES FIFTY SEVEN (57) MINUTES THIRTY (30) SECONDS EAST A DISTANCE OF TWO HUNDRED SEVENTY TWO AND FIFTY HUNDREDS (272.50) FEET TO THE PLACE OF BEGINNING AND CONTAINING 3.09 ACRES MORE OR LESS.
