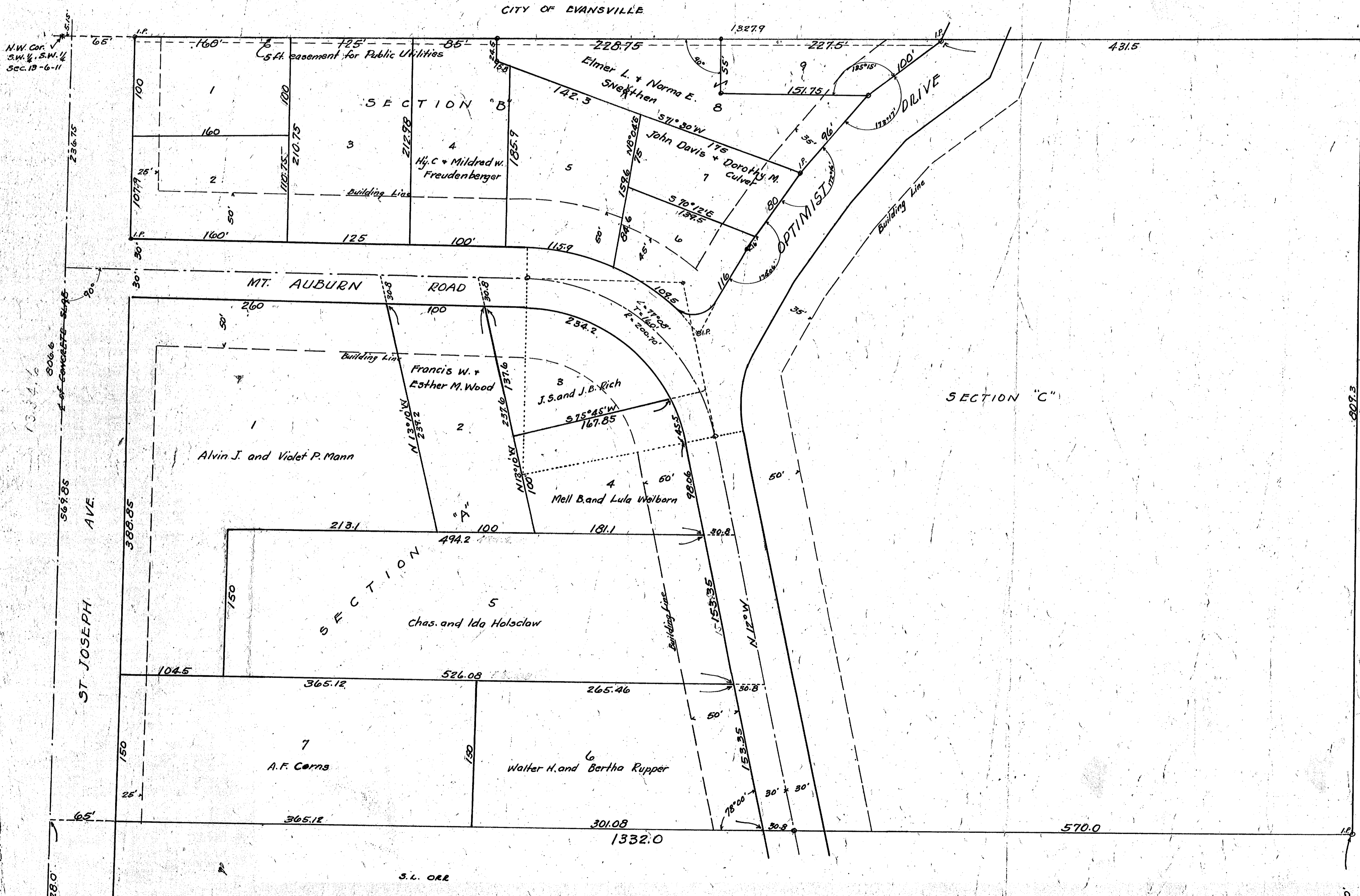
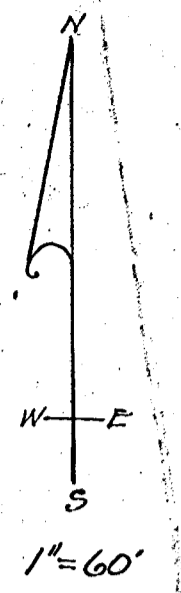
A Subdivision of Part of the S.W. 1/4, S.W. 1/4 of Sec. 13-T65-R11W
