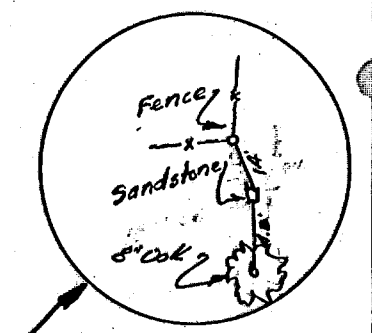


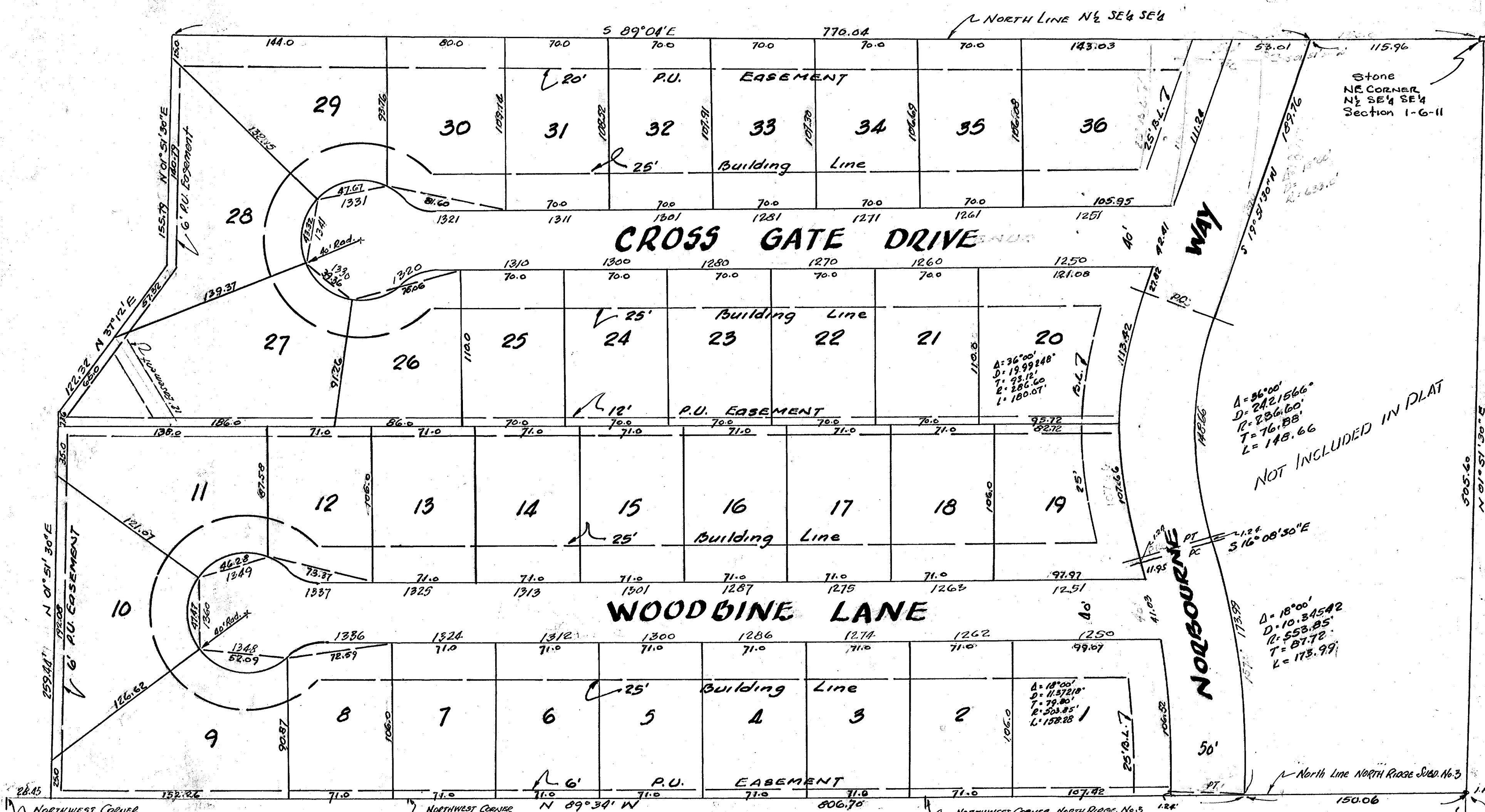

LEGAL DESCRIPTION

Part of the North half of the Southeast quarter of the Southeast quarter of Section 1, Township 6 South, Range 11 West of the Second Principal Meridian lying in Vanderburgh County, Indiana, described as follows, to wit:

Beginning at a point on the North line of said half quarter North, 89° 04' East 118.96 feet from the Northeast corner thereof, thence S 19° 51' 30" W 189.76 feet to the P.C. of an 242.1566 degree curve to the left, thence along the arc of said curve 124.16 feet to the P.T. of said curve to the left, thence S 16° 08' 30" E a distance of 124.16 feet to the P.C. of a 101.24542 degree curve to the right, thence along the arc of said curve 173.99 feet to the P.T. of said curve, thence N 89° 04' W 806.70 feet, thence N 01° 51' 30" E 259.44 feet, thence N 37° 12' E 122.32 feet, thence N 01° 51' 30" E 155.79 feet to a point on the said North line, thence S 89° 04' E along said North line 779.24 feet to the place of beginning.

OWNER'S CERTIFICATE

The undersigned, owner of the real estate shown and described hereon, does hereby, as shown, plat and subdivide said real estate and designate same as NORTH RIDGE SUBDIVISION No. 5. All streets within the plat are dedicated to the public. Building setback lines are established as shown on the plat, between which lines and the property lines of the streets there shall not be erected or maintained any buildings or structures. Strips of ground of the widths shown on the plat and marked "P.U. Easements" are reserved for the use of public utilities for the installation of water, sewer, or gas mains, poles, ducts, lines, and wires and subject at all times to the proper authorities and to the easements herein reserved. No structures are to be erected or maintained on said strips and owners of lots shall take title subject to the rights of the various utilities in said strips.
