

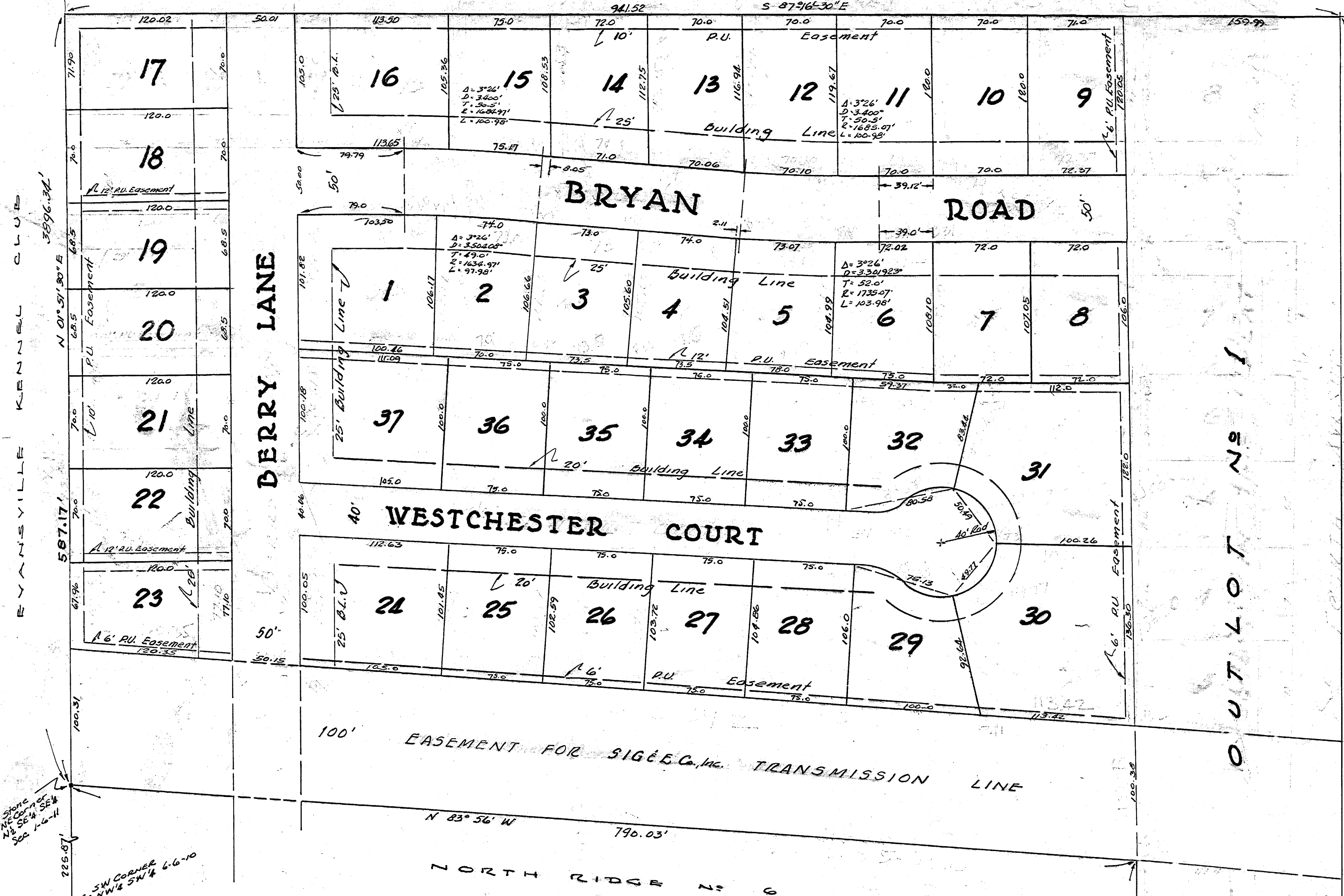

LEGAL DESCRIPTION

PART OF THE NW 1/4 OF THE SW 1/4 OF SECTION 6, T 6 S, R 10 W OF THE SECOND PRINCIPAL MERIDIAN AND LYING IN VANDERBURGH COUNTY, INDIANA, DESCRIBED AS FOLLOWS, TO WIT: BEGINNING AT A POINT ON THE WEST LINE OF SAID QUARTER QUARTER, N 01° 30' E, 225.87 FEET FROM THE SOUTHWEST CORNER THENCE (Said Point) BEING THE NE CORNER OF THE NE 1/4 SEC 14 (Sec. 14-11) THENCE CONTINUE N 01° 30' E ALONG SAID WEST LINE 507.17 FEET THENCE S 87° 16' 30" E, 741.52 FEET THENCE S 01° 49' 30" W, 84.77 FEET TO A POINT ON THE SOUTH LINE OF SAID QUARTER QUARTER, THENCE ALONG SAID SOUTH LINE, N 87° 12' 30" W, 153.12 FEET, THENCE ALONG S 87° 12' 30" W, 173.0 FEET, THENCE N 87° 55' W, 790.83 FEET, TO THE PLACE OF BEGINNING SAID PLACE OF BEGINNING BEING 3396.34 FEET FROM THE NW CORNER OF THE NW 1/4 OF SEC. 6-6-10.

NO STRUCTURES ARE TO BE ERRECTED OR MAINTAINED ON SAID STRIPS AND OWNERS OF LOTS SHALL TAKE TITLE SUBJECT TO THE RIGHTS OF THE VARIOUS UTILITIES IN SAID STRIP.

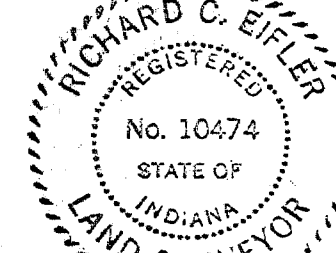
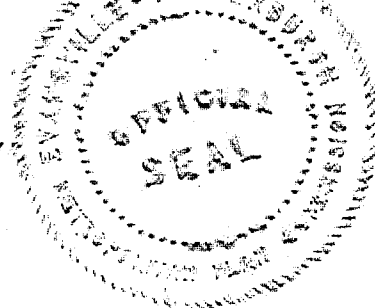

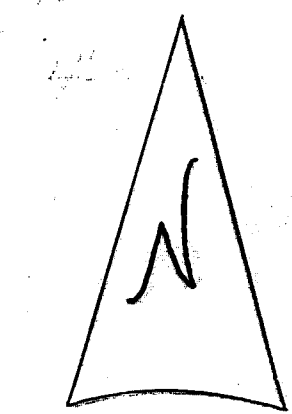
SURVEYOR'S CERTIFICATE
