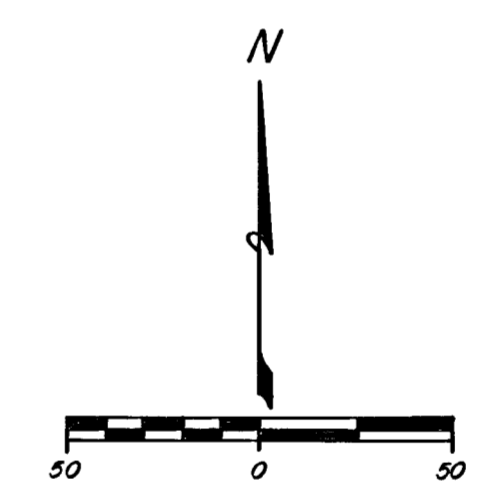
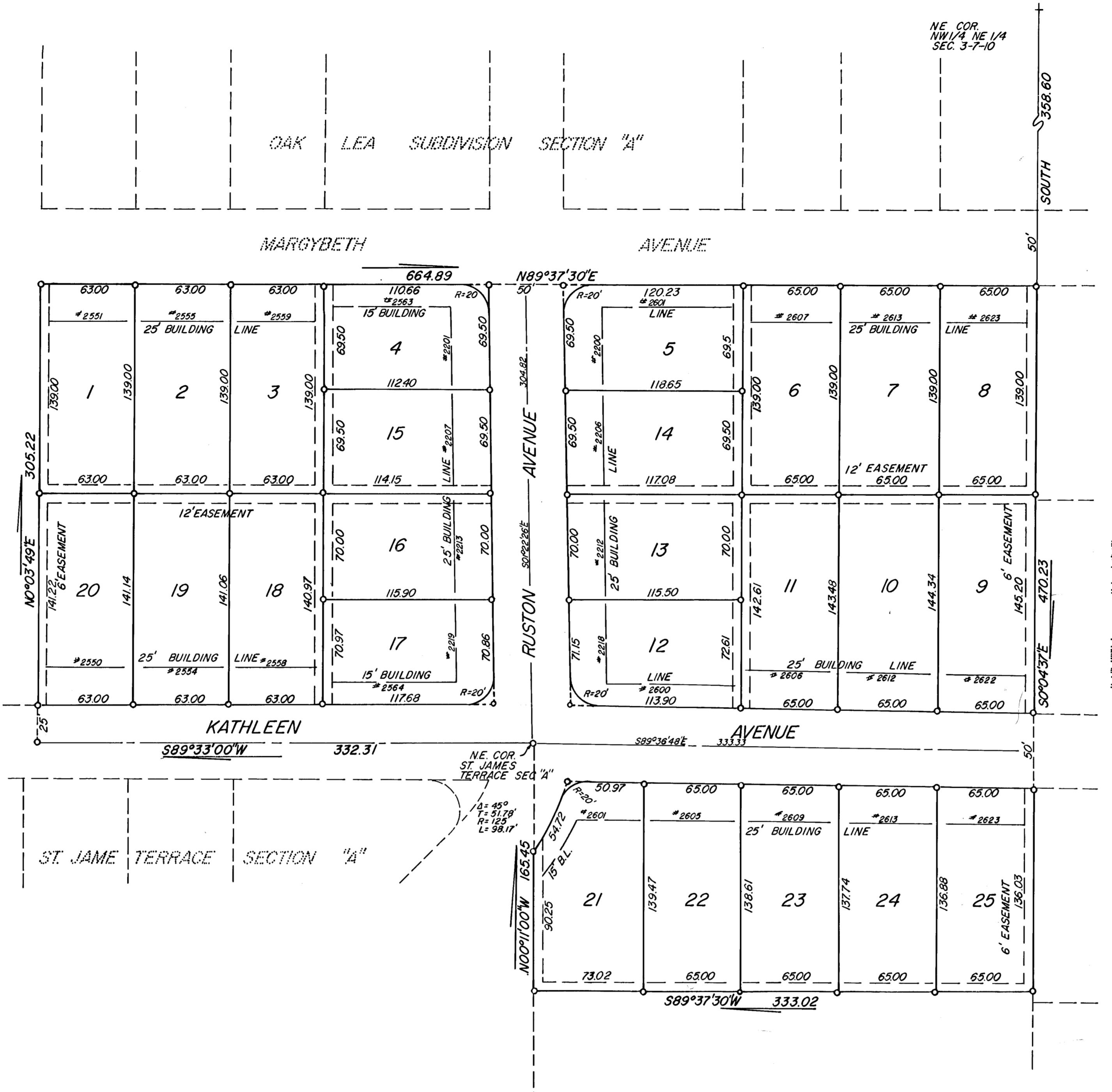


OAK LEA SUBDIVISION SECTION "B"
