



OAK GROVE



A SUBDIVISION OF PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 34, TWP 6 SOUTH, RANGE 10 WEST OF THE SECOND PRINCIPLE MERIDIAN, VANDERBURGH COUNTY, INDIANA, DESCRIBED AND BOUNDED AS FOLLOWS:

Beginning at the southeast corner of the northeast quarter of the south west quarter of section 34, township 6 south, Range 10 west, thence west along the south line of said quarter section a distance of 666.71 feet to the South west corner of the Southeast quarter-Northeast quarter-Southwest quarter of said section, said southwest corner being also the Southeast corner Southwest quarter-Northeast quarter-Southwest quarter of said section 34, thence a distance of 301.4 feet to point which lies 365.0 feet East of the Southwest corner thereof, thence north a distance of 63.22 feet to a point which lies 15.46 feet South of the north line and 356.31 feet East of the west line of said quarter-quarter section, thence East a distance of 309.42 feet to a point on the East line of said quarter-quarter section a distance of 14.98 feet South of the Northeast corner thereof, said north east corner being also the Northwest corner of the southeast quarter-northeast quarter-southwest quarter said section 34, thence north along said East line 14.98 feet to said northeast corner thence East along the north line of said Southeast quarter-Northeast quarter-Southwest quarter a distance of 668.92 feet to the Northeast corner thereof, thence South along the east line of said quarter-quarter section a distance of 666.77 feet to the place of beginning.



The undersigned owners and subdividers of the land included within the above and foregoing plat hereof do hereby execute the same and acknowledge the execution thereof, with the intent that when recorded said plat shall be fully effectual for all purposes provided by law including the dedication to the public of easements for public Streets, shown and designated thereon.
