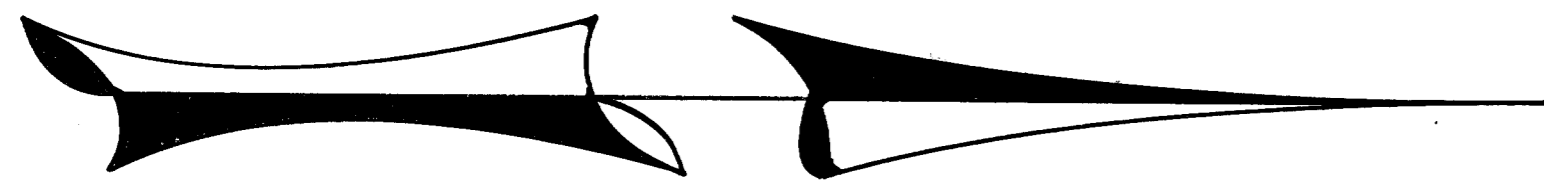
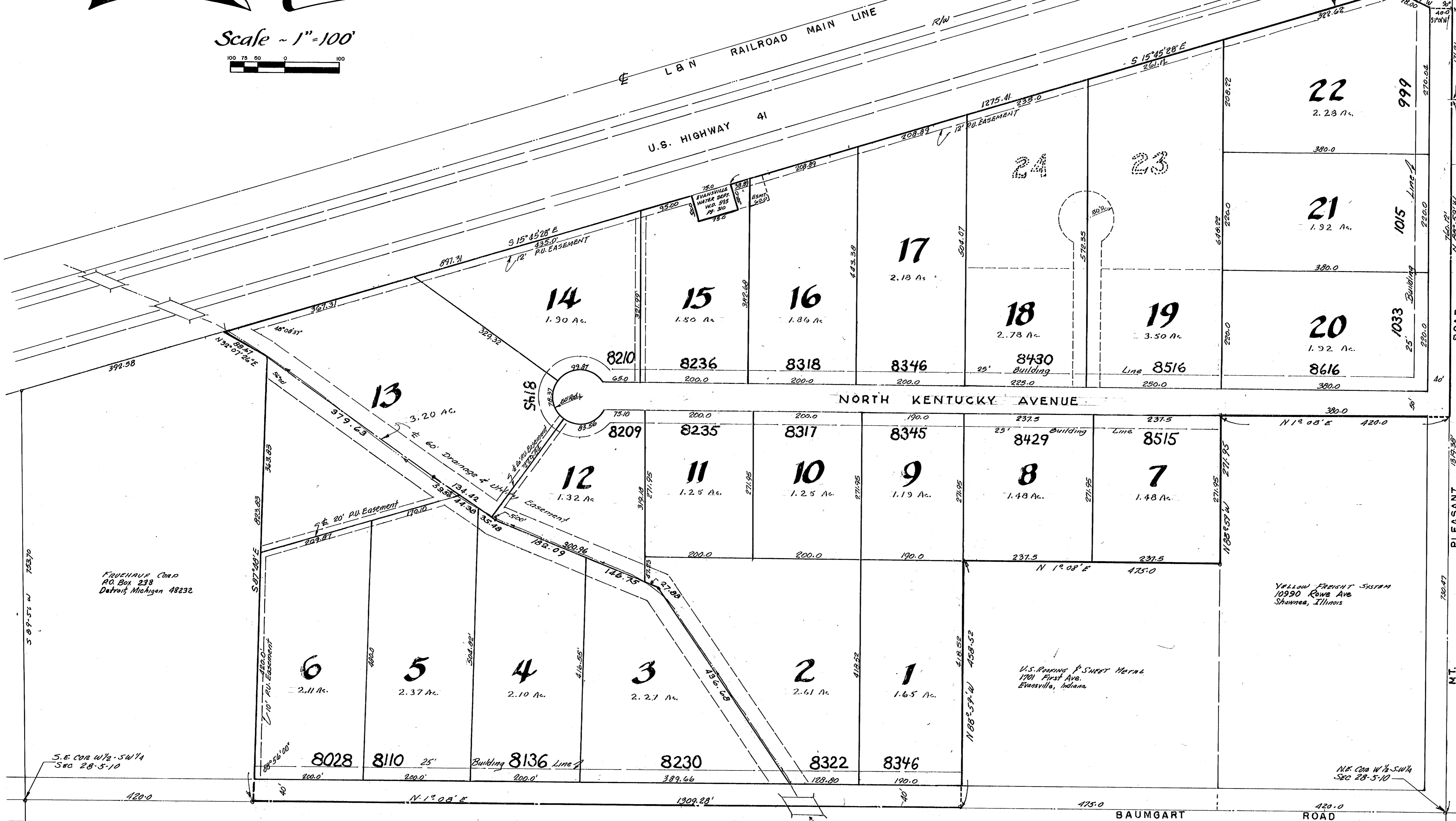
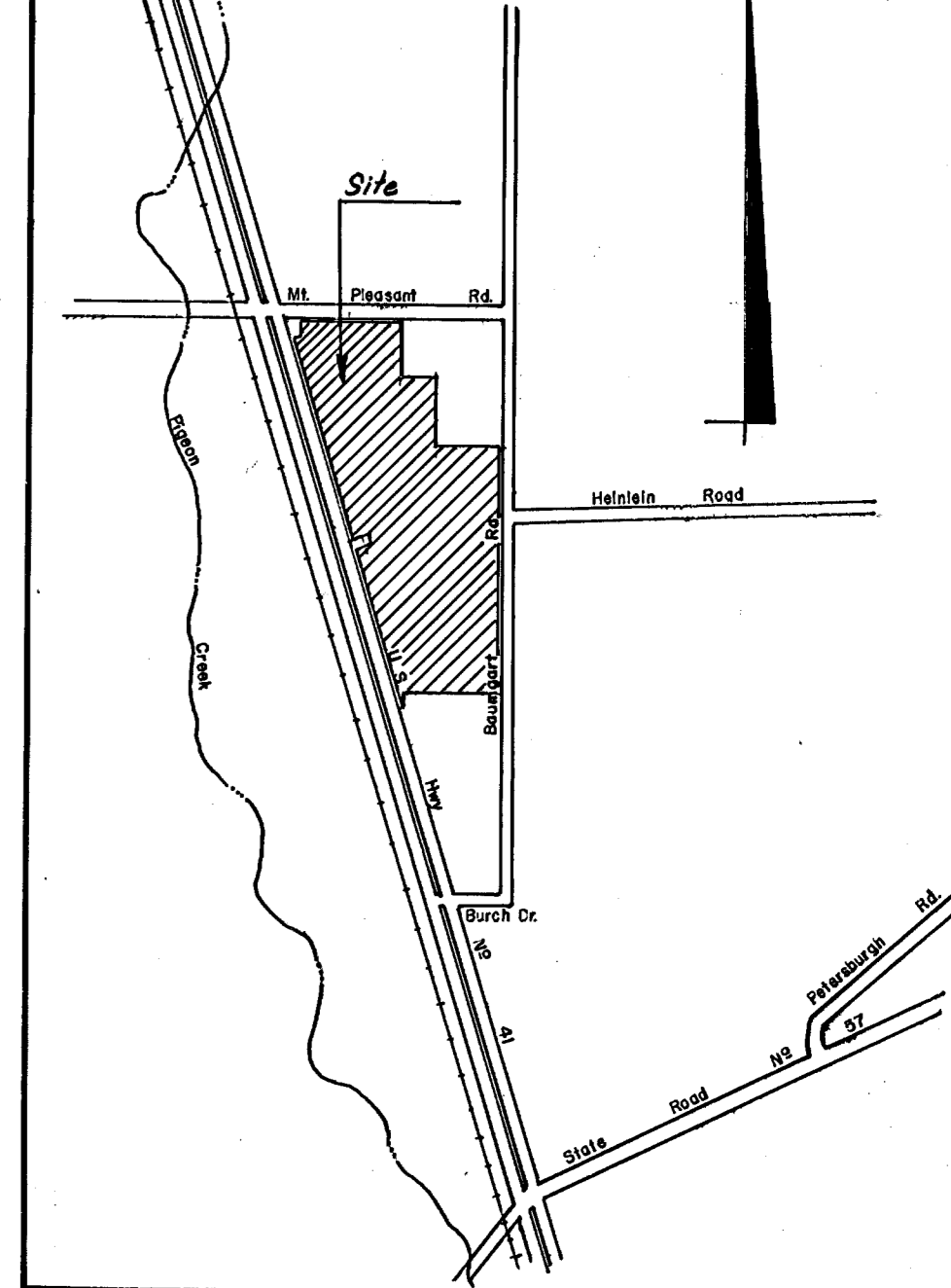


Omicron Industrial Park

LEGAL DESCRIPTION

A subdivision of part of the West half of the Southwest quarter of Section 28, Township 5 South, Range 10 West in Vanderburgh County, Indiana, and more particularly described as follows:
