

SECTION "D" PARK PLAZA

SUBDIVISION OF PART OF THE SOUTHWEST QUARTER (SW 1/4) OF FRACTIONAL SECTION 30, TOWNSHIP SIX (6) SOUTH, RANGE NINE (9) WEST IN VANDERBURGH COUNTY, INDIANA, MORE PARTICULARLY DESCRIBED AS FOLLOWS: Beginning at a point in the center of Martin Lane, said point being at the Northeast corner of Section "C" Park Plaza as per plat thereof and said point being located by commencing at the Southeast corner of the Southwest quarter of said section and measuring thence South eighty-nine (89) degrees, zero (0) minutes West along the South line thereof, a distance of 960.1 feet to a point in the center of Martin Lane, thence North along the center of Martin Lane for a distance of 770.0 feet to the said place of beginning.

From said place of beginning thence West along the Northernly line of Lots 15 through 7 inclusive of Section "C" Park Plaza for a distance of 710.0 ft., thence North for a distance of 180.0 feet to a point on the Northernly line of Section "C" Park Plaza, thence West along the Northernly line of Section "C" Park Plaza for a distance of 110.0 feet to a point on the arc of a circle having a radius of 20.0 ft., thence in a Westerly and Northernly direction along the arc of said circle for a distance of 31.42 ft., thence West along the Northernly line of Section "C" Park Plaza for a distance of 20.0 feet; thence South for a distance of 10.0 feet; thence West along the Northernly line of Section "C" Park Plaza for a distance of 126.44 feet to the Northwest corner of Section "C" Park Plaza, said point being also on the East line of the unrecorded plat of Plaza Estates, thence North zero (0) degrees, twenty (20) minutes East along the East line of the unrecorded plat of Plaza Estates for a distance of 744.64 feet to the Southwest corner of the Knight School Building Corporation property, said point being 908.24 feet South of the North line of said quarter section; thence North eighty-eight (88) degrees, forty-eight (48) minutes, thirty (30) seconds East along the South line of Knight School Building Corporation property and parallel to the North line of said quarter section for a distance of 1012.1 feet to a point in the center of Martin Lane; thence South along the center of Martin Lane for a distance of 995.48 feet to the place of beginning.

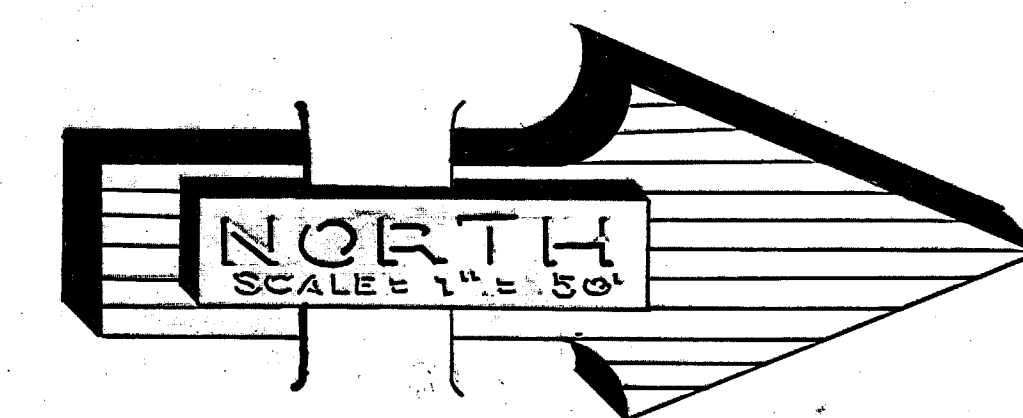
