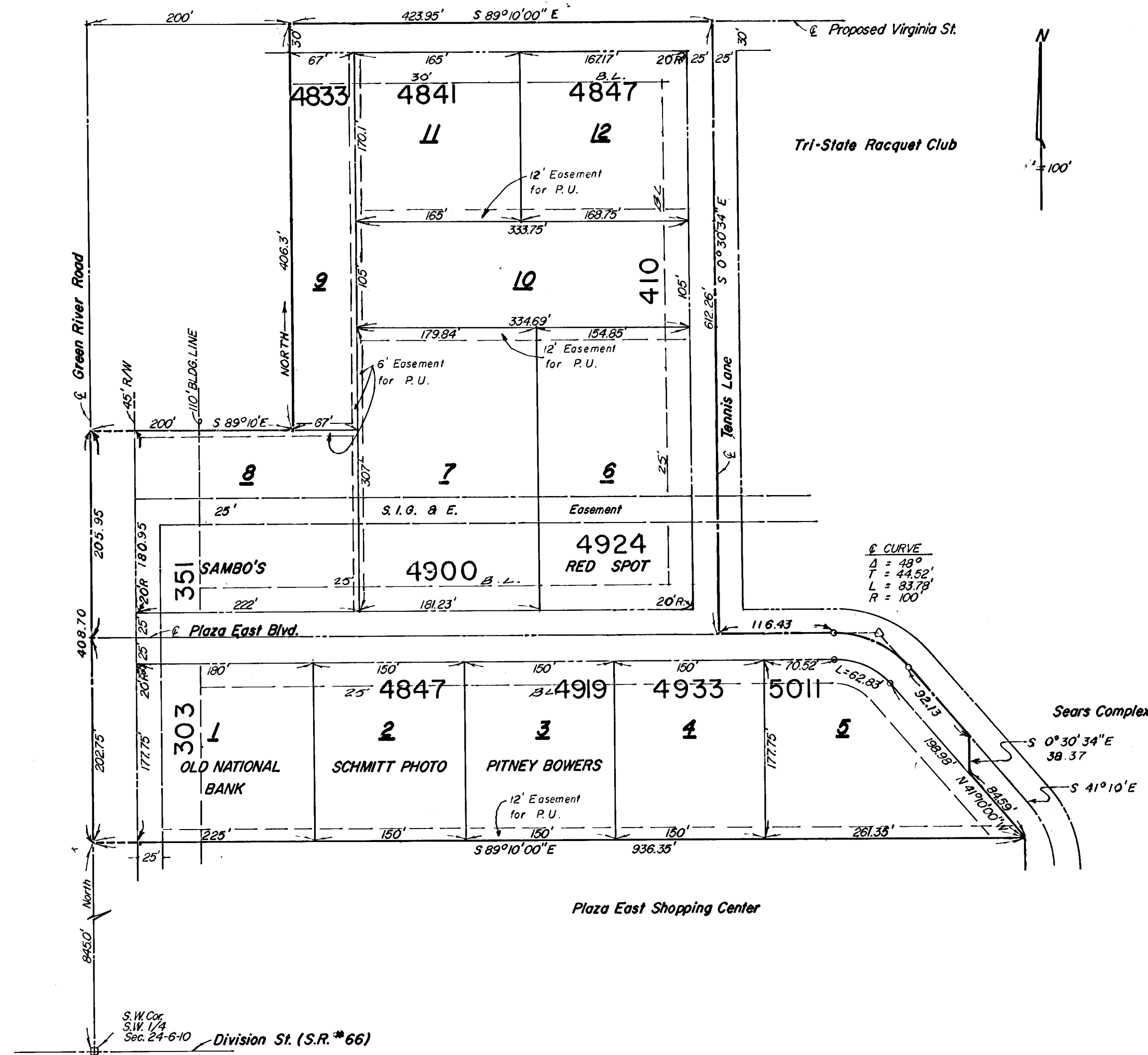


# PLAZA EAST SUBDIVISION

PLAZA EAST SUBDIVISION

A subdivision of part of the Southwest Quarter of Section 24, Township 6 South, Range 10 West, Vanderburgh County, Indiana described as follows:

Beginning at a point on the west line of the Southwest Quarter of said Section 24 a distance of 845.0 feet North of the Southwest corner thereof; thence North along said west line a distance of 408.7 feet; thence South 89 degrees 10 minutes East a distance of 200.0 feet; thence North a distance of 406.3 feet to the center of East Virginia Street; thence South 89 degrees 10 minutes East along said centerline a distance of 423.95 feet to the center of Tennis Lane; thence South 0 degrees 30 minutes 34 seconds East along said centerline a distance of 612.26 feet to the center of Plaza East Blvd.; thence South 89 degrees 10 minutes East along said centerline a distance of 116.43 feet to the beginning of a curve having a radius of 100 feet; thence southeasterly along said curve to the right a distance of 83.78 feet to the end of said curve; thence South 41 degrees 10 minutes 34 seconds East along said centerline a distance of 92.13 feet; thence South 0 degrees 30 minutes 34 seconds East a distance of 38.37 feet to the south right-of-way line of Plaza East Blvd.; thence South 41 degrees 10 minutes East along said right-of-way line a distance of 84.59 feet; thence North 89 degrees 10 minutes West a distance of 936.35 feet to the place of beginning.

We the undersigned, owners of the real estate shown and described here on do hereby as shown plat and subdivide said real estate and designate same as PLAZA EAST SUBDIVISION. All streets within the plat are dedicated to the public. Building setback lines are established as shown on the plat between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plat and marked "P.U." Easement" are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject to all times to the proper authorities and to the easements hereon reserved. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities in said strips of ground.
