
3-7-10-(5+6) ST. JAMES TERRACE - SECTION

> Part of the Northwest Quarter of the Northeast Quarter of Section 3, Township 7 South, Range 10 West, lying in Vanderburgh County, Indiana, and more particularly described as follows:

Beginning at a point, which is located by commencing at the southwest corner of said quarter-quarter section, and measuring thence North 89 degrees 42 minutes East along the South line of said quarter—quarter section for a distance of 332.31 feet; thence North O degrees 17 minutes West for a distance of 686.45 feet to the aforementioned place of beginning; thence from said place of beginning continue North 89 degrees 31 minutes East and parallel with the North line of said quarter—quarter section for a distance of 44.91 feet to the P.C. of a 2.323 degree curve to the left; thence along the arc of said curve for a distance of 98.90 feet to the P.T. of said curve; thence North 87 degrees 13 minutes East for a distance of 51.19 feet to the P.C. of a 2.309 degree curve to the right; thence along the arc of said curve for a distance of 100.99 feet to the P.T. of said curve; thence North 89 degrees 33 minutes East for a distance of 39.20 feet; thence North O degrees 21 minutes East for a distance of 151.67 feet; thence South 89 degrees 42 minutes West and parallel to the said South line of the quarter—quarter section for a distance of 336.12 feet; thence South O degrees 17 minutes East for a distance of 158.76 feet to the place of beginning.
