

A subdivision of part of the Northwest Quarter of Section 8 township 6 South, Range 10 West, Vanderburgh County, Indiana described as follows:

Beginning at a point on the East line of said quarter Section which lies North 0°17' West a distance of 657.4 feet from the southeast corner thereof, thence South 89°16' West a distance of 195.4 feet, thence S 74°16' W a distance of 3600 ft, thence N 9°10' 30\"/>

Restrictions to this plat are recorded in Misc. Record Vol. #10, Page 266, Office of The Recorder of Vanderburgh Co., Ind.

We the undersigned, owners of the real estate shown and described here on do hereby as shown plat and subdivide said real estate and designate same as **STONEGATE HILL SUBDIVISION**. All streets within the plat are dedicated to the public. Building setback lines are established as shown on the plat between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plat and marked "PU" Easement are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easements hereon reserved. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities in said strips of ground.
