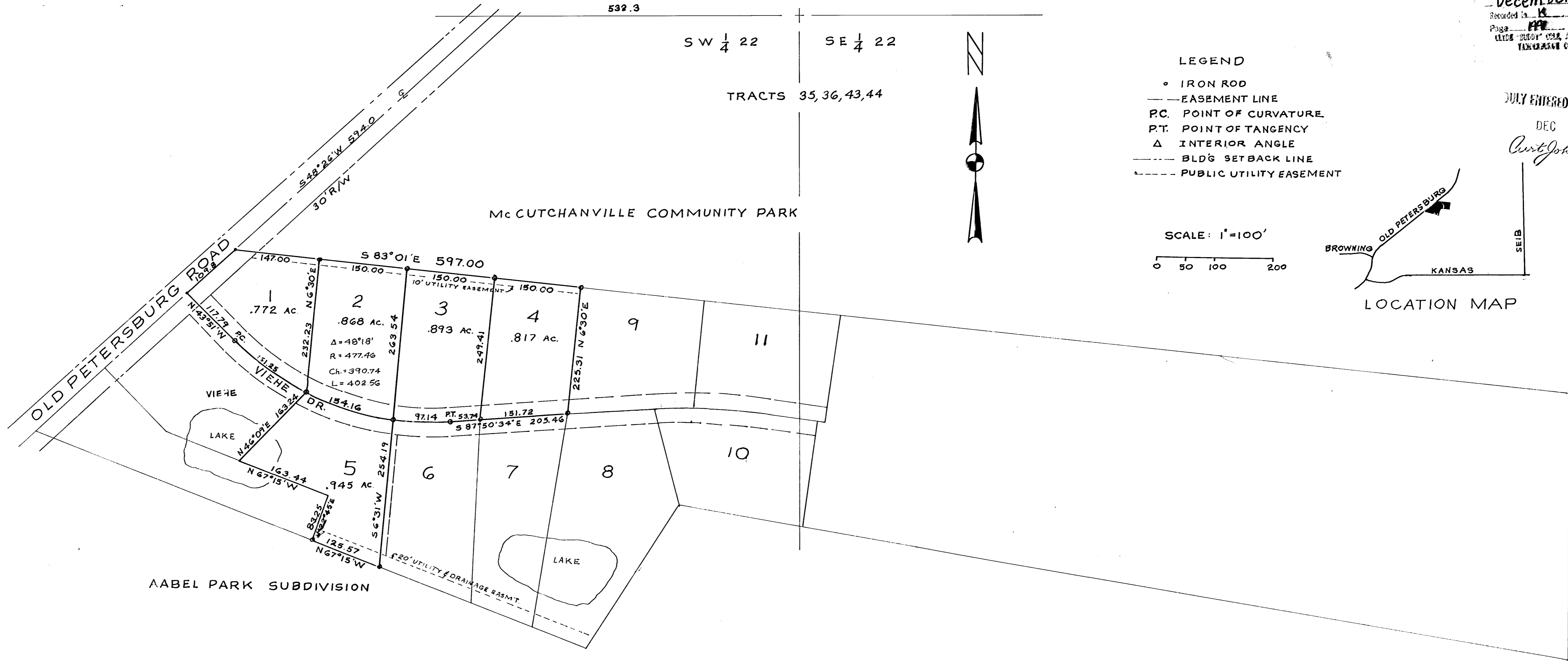

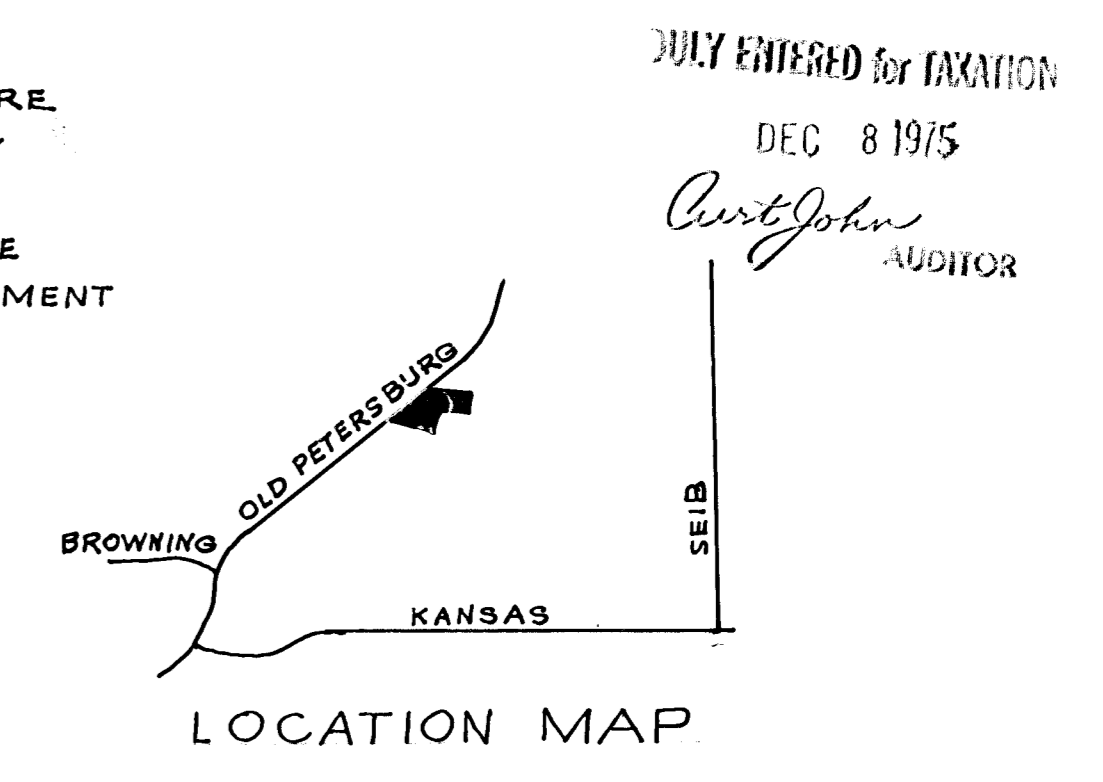

LEGAL DESCRIPTION

A subdivision of part of the south half of Section 22, Township 5 South, Range 10 West bounded and described as follows:

Commencing at the northeast corner of the southwest quarter of Section 22; thence west along the north line of said quarter section 532.3 feet to the centerline of Petersburg Road; thence south 48 degrees 25 minutes west along said centerline 594.0 feet to the true point of beginning; thence south 33 degrees 1 minute east along the south line of McCutchanville Community Park 597.00 feet; thence south 5 degrees 30 minutes west 225.31 feet; thence south 87 degrees 50 minutes 34 seconds west 205.45 feet to the point of tangency of a curve; thence westerly along a curve concave to the north having a radius of 477.46 feet a distance of 97.14 feet; thence south 6 degrees 31 minutes west 254.19 feet; thence north 67 degrees 15 minutes west along the line of Abel Park Subdivision 125.57 feet; thence north 22 degrees 45 minutes east 83.25 feet; thence north 67 degrees 15 minutes west 163.44 feet; thence north 46 degrees 09 minutes east 163.24 feet; thence westerly along a non tangent curve concave to the north having a radius of 477.46 feet a distance of 151.25 feet to the point of curvature; thence north 43 degrees 51 minutes west 117.79 feet; thence north 43 degrees 26 minutes east along the centerline of Petersburg Road 109.8 feet to the true point of beginning, containing 4.295 acres.

Also the right of ingress, egress and utility service over a 25 foot wide roadway and utility easement off the George O and Mabel A. Viehe Parcel adjoining the southwest side of Lot 1.
