

WESTERN TIE RACE NO. 2

A Subdivision of a part of the Southeast quarter of the Northwest quarter of Section 22, Township 6 South, Range 11 West, of the Second Principle Meridian, lying in Vanderburgh County, Indiana, more particularly described as follows:

Commencing at a point marked by an old stone on the East line of said quarter quarter section a distance of 177.95 feet South 0°-02' West of the Northeast corner thereof; thence North 89°-01'-30" West a distance of 264.66 feet; thence South 0°-05' East a distance of 917.40 feet to the center line of the Upper Mt. Vernon Road; thence South 61°-43'-East along the center line of said road a distance of 155.66 feet; thence South 65°-26' East along the center of said road a distance of 5.66 feet; thence North 0°-58'-30" East a distance of 231.54 feet; thence South 89°-03'-30" East a distance of 66.91 feet; thence North 0°-02' East a distance of 160.99 feet; thence North 89°-09' East a distance of 50 feet to a point on the East line of said quarter quarter section; thence N 0°-02' East along said East line a distance of 596.72 feet to the place of beginning



We the undersigned, owners of the real estate shown and described hereon do hereby as shown plat and subdivide said real estate and designate same as **WESTERN TERRACE NO.2**.
All streets within the plot are dedicated to the public. Building setback lines are established as shown on the plat between which lines and the property of the street there shall not be erected or maintained any building or structure. Strips of ground of the width shown on the plat and marked "P.U." Easement" are reserved for the use of Public Utilities for the installation of water and sewer mains, poles, ducts, lines and wires, subject at all times to the proper authorities and to the easements herein reserved. No structures are to be erected or maintained on said strips, and owners of lots shall take title subject to the rights of the public utilities to said strips of ground.
