**Description :-**

A Subdivision of a part of the S. W.  $\frac{1}{4}$ , S. W.  $\frac{1}{4}$  of Section 22, Township 6, South, Range 10 West, and described as follows:-

Beginning at a point on the west line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section at a distance of 825 ft. north of the S. W. corner thereof; thence east and parallel with the south line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section to the east line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section; thence north along said east line for a distance of 412.5 ft.; thence west 230.4 ft; thence north 67.6 ft.; thence west 116.90 ft to the S. E. corner of a subdivision known as MAY PLACE; thence along the south line of MAY PLACE for a distance of 197.60 ft., thence south 143.80 ft. to the north line of Franklin St., thence west along the north line of Franklin St. 150 ft; thence South 5 ft. to the north line of Franklin St. as laid out in a subdivision known as Eastlawn; thence East 30 ft. to the northeast corner of Eastlawn; thence south 201 ft. to the S. E. corner of Eastlawn; thence west along the south line of Eastlawn; to the west line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section; thence south along the west line of said  $\frac{1}{4}$ ,  $\frac{1}{4}$  section 130 ft. to the place of beginning.
