

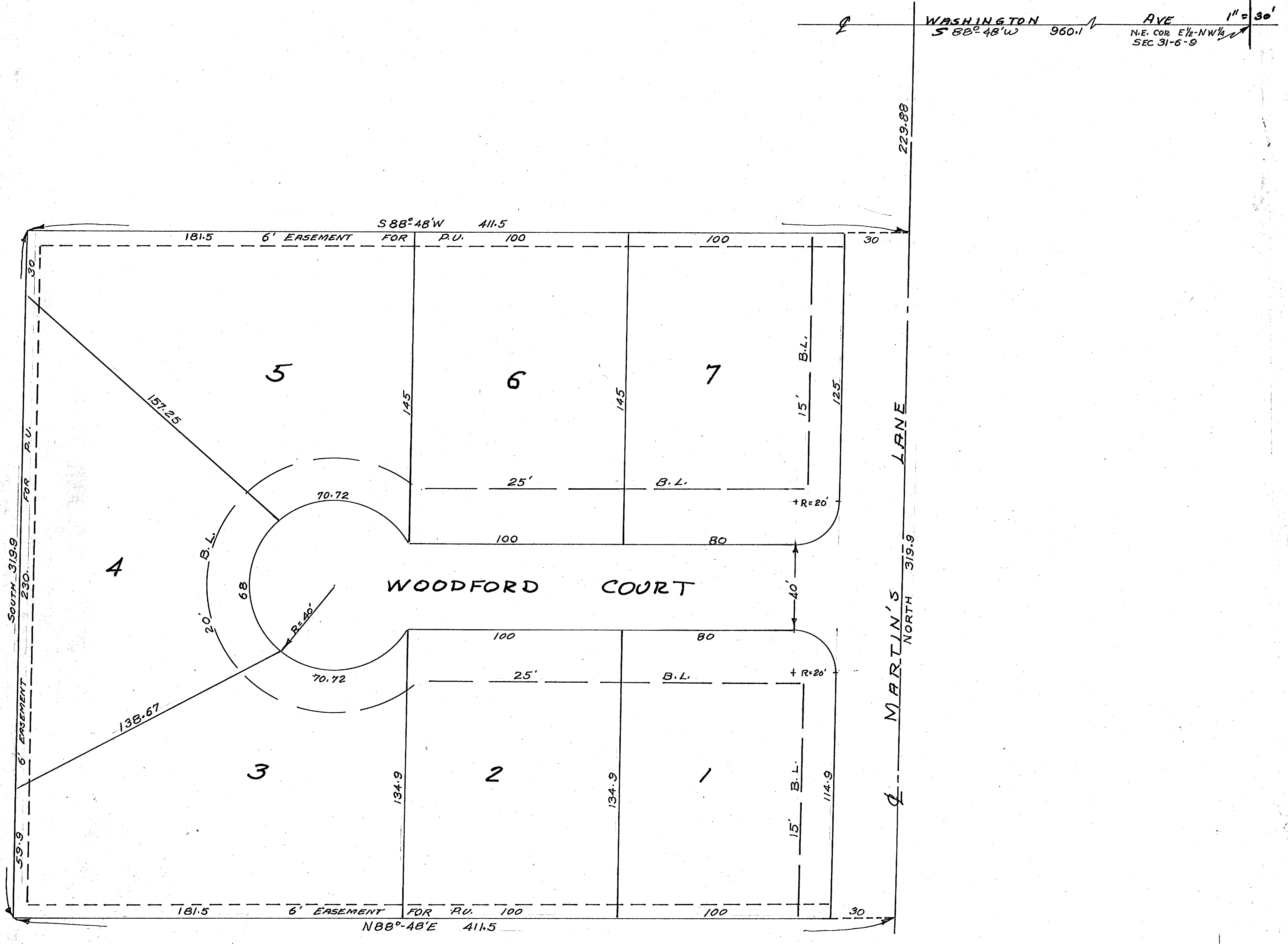

A SUBDIVISION OF PART OF THE EAST 1/2 OF THE NORTHWEST 1/4 OF SEC. 31 TWP 6 SOUTH RANGE 9 WEST IN VANDERBURGH COUNTY, INDIANA, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE CENTER OF MARTIN'S LANE, SAID POINT BEING LOCATED BY COMMENCING AT THE N.E. CORNER OF SAID HALF-QUARTER SECTION AND MEASURING THENCE S 88° 48' W ALONG THE NORTH LINE THEREOF FOR 960.1 FEET TO THE CENTER OF MARTIN'S LANE; THENCE SOUTH ALONG THE CENTER OF MARTIN'S LANE FOR 229.88 FEET TO THE PLACE OF BEGINNING. FROM SAID PLACE OF BEGINNING S 88° 48' W AND PARALLEL TO THE NORTH LINE OF SAID HALF-QUARTER SECTION FOR 411.5 FEET; THENCE SOUTH AND PARALLEL TO THE CENTER OF MARTIN'S LANE FOR 319.9 FEET; THENCE N 88° 48' E FOR 411.5 FEET TO A POINT IN THE CENTER OF MARTIN'S LANE; THENCE NORTH ALONG THE CENTER OF MARTIN'S LANE FOR 319.9 FEET TO THE PLACE OF BEGINNING.

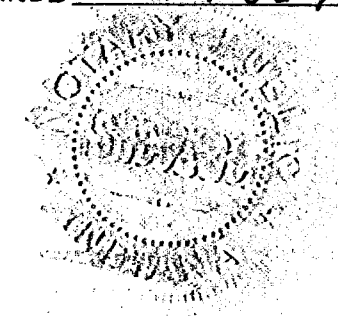
